Sterling from Thomas SHIRLEY and wife America for \$5,000 CSA money c.1864 ; Tinker sold the lot to Joshua MORSE, but Gabriella never gave up her dower right. S.E. GAINES got judgement against Morse and land was sold by Sheriff sometime 1869-1870 James W. BRUISTER had the land, then sold it to John & Mary FOSTER
