That the said party of the first part, for and in consideration of the sum of One (\$1.00) and other valuable consideration, Dollars, in hand paid by said party of the second part, the receipt whereof is hereby acknowledged, grant, bargain and sell unto the said party of the second part, and to his heirs and assigns Forever, all the following described lot piece, or parcel of land, situated in the County of Baldwin and State of Alabama and known and described as follows, to wit.

Lot thirteen (13) and fourteen (14) block twenty one (21) in the north east quarter of north east quarter (NE.1/4 of NE.1/4) section ten (10) township six (6) south range three (3) east, town of Silverhill.

AND the said C.A. Vallentin, party of the first part, for his heirs, executors and administrators, does covenant, promise and agree, to and with the said party of the second part, his heirs and assigns, that he has not done, or suffered to be done, anything whereby the said premises hereby granted are, or may be, in any manner encumbered or charged, and that the said premises, against all persons lawfully claiming, or to claim the same, by, through or under him, will Warrant and Forever Defend.

AND the said party of the first part hereby expressly waive and release any and all right, benefit, privilege and advantage, and exemption, under or by virtue of any and all Statutes of the State of Alabama providing for the exemption of homesteads from sale on execution or otherwise.
