CHEYNE, Alexander

Marischal Coll., Aberdeen, 1700-04. Schoolmaster, Dunbennan & Kinnoir; deposed from this post, 16 May 1716, for having, as Reader in Dunbennan Church, prayed for King James during the 1715 Rising. Asst. Huntly, 1720-24. He set up a school at the Raws of Huntly, for which he was summoned to appear before the Presbytery in 1720; he refused to do so, but the Presbytery, however, forbade him to teach any school within the parish. The following year, the Presbytery alleged that his marriage was scandalous and illegal (Rev. Lewis Gordon had been the officiating priest); this affair led to Cheyne giving up his school. Inc. Huntly, 1724-27. In 1727 he was staying in Fochabers and preaching in Aberlour, Keith and Fochabers, Presbyter at Fochabers, 1727-32, and Chap. Gordon Castle [Fochabers], 1729 -Whitsun 1732 (left Gordon Castle because the young Duke of Gordon adopted prayers for King George). Inc. Botriphnie, 1732-37. Inc. Stonehaven, 1737-41. Inc. Laurencekirk, 1741-745. One of Brechin Diocesan clergy who met, 15 June 1742, to elect new Bishop of Brechin. Dean of Brechin, 1744-?45. Signed the Protestation in support of Primus Keith, 1744/45. Appears to have left Laurencekirk before

He was also one of 10 who on 16 July 1708 appeared before the Magistrates and acknowledged that notwithstanding the judgement of 13 Mar., they had exercised their ministry; they were ordained to appear "the Morrow against 10 of the Clock forenoon" when five were present and were sentenced to imprisonment but Cheyne did not appear. He was Collector for Fund of Charity for the Indigent Episcopal Clergy and their Widows, 1711-21. His meeting-house in 1716 was at back of Bell's Wynd, Edinburgh. He was prosecuted with other Edinburgh clergy in 1716 by order of the Commission of the Justiciary for not praying for King George; he was prohibited from the ministry and fined.
