MEET THE MEMBER: JODIE BILES

Where were you born?

I was born in Cleveland, OH.

Have you lived in other places? Where?

I moved to Worcester, MA in 1977, but moved back home in 1978 after my mother's death. I joined the Army in 1982 and have lived in many different states and two other countries.

What is your background (Where did you work, what did you do, etc?)

I was in the Army for over 8 years. I went in as an aviation sheet metal mechanic, but after 2 ½ years I became a Counterintelligence Agent. In the civilian world I have held many positions. I am a skilled seamstress and ran a business out of my home overseas. My last 9-5 job was as the Deputy Director of Bob Hope Village in Shalimar, FL.

When did you start doing genealogy?

I have been interested in my Ancestry for as long as I can remember. I didn't start doing serious research and documentation, until 2016.

What geographic areas have you researched?

Most of my research has been concentrated in Henry County, VA and independent Martinsville, VA on my father's side and the counties of Rockingham, Forsyth, Davidson and Guilford counties in North Carolina.

Have you attended any conferences?

Not yet.

Do you belong to any other genealogy related societies?

Yes, I belong to African-American Historical and Genealogical Society (AAHGS), National Genealogical Society (NGS) and Museum & Archives of Rockingham County (MARC).

Tell us about one of your brick walls.

I have many, many brick walls, but one that I have been working on is the origins of my Great Grandmother Margaret "Maggie" Walser.

Have you DNA tested? (What have you learned from DNA testing? Were there any surprise results?)

Yes, I have tested with 23andMe and Ancestry. I also uploaded to GEDmatch, My Heritage, Family Tree and DNA.LAND. I have had no real surprises. Ethnically, I am basically 1/3 European and 2/3 African. I did have one close cousin show up that no-one in the family knew about. Her grandfather was adopted and didn't know who his real parents were.

Does one of your ancestors have an unusual name?

I have come across several unusual first names in my research. I have a cousin whose middle name is Crumpton. I had cousins with these one of a kind names: Chalmers, Virgus, Mann and Surry. My uncle has a family name that I want to do more research on, Maceo Antonio.

Do you have an ancestor you would consider famous?

My 2xGreat Grandmother Keziah was impregnated by the plantation owner's son who was the overseer. His line goes back to Patrick Henry and Alexander Spotswood (Lieutenant Governor of Virginia, appointed in 1710)

If you ask one ancestor a question, who would you ask and what would the question be?

From what I have learned of my mother's family, the mother of my Great Grandmother Maggie, was born in Africa. I would ask her where in Africa she was from or what tribe she belonged to.

DESCENDANCY RESEARCH: ANOTHER PATHWAY TO GENEALOGY



A Webinar Presentation by MICHAEL L STRAUSS, AG

Breaking though the challenges of brick walls has never been more rewarding; genealogists are often taught that the only way to doing successful research is to search backwards through time; going back as far as you can. This lecture assumes a new focus on doing research by tracing all of the descendants of an ancestral couple to present; as we will examine the methodology to find living persons who may hold the key to your family history research. Focus is also given to provide an actual case study of doing this kind of research.

Michael L. Strauss, AG is a professional Accredited Genealogist® (ICAPGen), and a nationally recognized speaker. A native of Pennsylvania and a resident of Utah, he has been employed as a Forensic Investigator for more than 25 years. Strauss holds a BA in History and is a United States Coast Guard veteran. He is a qualified expert witness in the courts in New York, New Jersey, Pennsylvania, and Virginia. Michael is featured on Lisa Louise Cooke's Genealogy Gems with his regular segments of "Military Minutes." Strauss is a faculty member at SLIG, GRIP, and IGHR where he is the Military Course Coordinator.
