GENEALOGY SURVEY

Captain Anthony Fulgham Revisited

First pioneer, was born in England. Captain Anthony was married to Martha (??). He arrived in The Isle of Wight County, VA, prior to 1643. His first land grant was for 100 acres in 1643. In 1650 Captain Anthony patented 500 acres on the northside of the Rappahannock River. In 1665 Anthony patented 1600 acres "at the head of West Branch for the transportation of 20 persons." This was near the present-day Isle of Wight Courthouse. On the same day (July 12, 1665), Anthony's friend and neighbor, "John Marshall received a grant of 700 acres next to Captain Fulgham's grant and six of his Headrights (servants) were assigned to him by Wm. Boddie, who also on that day was granted 3350 acres lying next to the Fulgham and Marshall grants."

Anthony was intelligent, cultured, obviously wealthy, and was a highly respected leader in his community for many years, and was an active participant in the Bacon Rebellion. Captain Anthony was a Justice in the County Court of the Isle of Wight, and a Captain in the County Militia; thus, his title of Captain. Anthony and Martha had four sons: 1) John, 2) Anthony, 3) Michael, and 4) Nicholas. Captain Anthony died in 1669 and is buried at the Isle of Wight, most probably on his own plantation. It was the custom in those days to be buried at one's home.

Administrative request for the settlement of Anthony's estate was made by Martha on May 2, 1670 and is recorded in will book 2 - page 25. It is also of record that the descendants of John are the Georgia Fulghams and the descendants of Michael are the North Carolina Fulghums.


THE ANCESTRAL HOMEPLACE

In June 1776 our kinsman, Charles Fulgham, served as a delegate to the Revolutionary Virginia State Convention. That convention voted unanimously to adopt the Declaration of Independence and, accordingly, Charles played an active role in the auspicious beginnings of this great nation. It is one of the great ironies of our family history that the male Fulgham descendants of Nicholas Fulgham, son of Cpatain Anthony, failed with Charles, and the original ancestral home built by Captain Anthony in Isle of Wight County, Virginia, and passed by inheritance through three generations to Charles, was disposed of through probate. Because Nicholas' male Fulgham descendants failed with Charles, little attention has been paid to this branch of the Fulgham family whose history reveals great deal about the location of the ancestral home.

In 1669 with the death of Captain Anthony, John Fulgham, by primogeniture, inherited all of Captain Anthony's real property. In response to a deathbed bequest by Captain Anthony, John quitclaim deaded Captain Anthony's Pagan River plantation, including the old homeplace, over to his younger brother, Anthony, Jr. Brother Anthony died soon after Bacon's Rebellion, in 1687, and willed most of his property to another brother, Nicholas, including the old home place. Subsequent wills in Nicholas' line of descent identify this property as being on Red Point, the original holdings of Captain John Moone (Mahone). Captain Moone's property is important in that he named the "King of All Places."

The Red point property passed through Nicholas' line of descent to Charles based on the following genealogy:

CAPTAIN ANTHONY FULGHAM died 1669



About 1765, Charles III returned to Virginia from Plymouth, Massachusetts to take over the Red Point estate of his cousin, Charles II. The 18th century records for that period make mention of a "Fulgham's Landing" and "Fulgham's Warehouse" as an official tobacco inspection station for tobacco export from Isle of Wight County. The "landing" would indicate that the "King of All Places" mentioned in the Moone documents had been integrated into the Fulgham holdings since that was the only deepwater port on the lower Pagan River mentioned in the records. We know that young Charles Fulgham, aged 19 when he first returned to Virginia, fose rapidly in the Isle of Wight colonial hierarchy, being styled Charles Fulgham, Esquire and Gentleman and appointed Captain of Militia and delegate to the revolutionary convention of 1776. Charles definitely had a connection with the sea as he provided two naval swivel guns to the fledgeling Virginia State Navy in 1776.

Although we may never know exactly where the ancestral home was located, logic points to a location near the King of All Places on the Pagan River.

EDITOR's note: Captain Anthony's first patent of land was probably near Red Point south of that of Captain John Moone. Boddie describes Captain Anthony's first land patent as being 100 acres on Pagan Point; however, a map in "SEVENTEENTH CENTURY ISLE OF WIGHT COUNTY VIRGINIA" by John Bennett Boddie locates Pagan Point at the mouth of Pagan River on the south shore. Much of what we know needs careful researching, documentation and referencing to legal documents, to published material or to other public or church records. There are conflicts in statements between Boddie's writings and the county records in Isle of Wight County, VA. The land grant to Silvester Thacker and Anthony Fuljiambe (Anthony's first land grant) is described elsewhere (early deeds in Isle of Wight Courthouse) as "100 acres Oct. 22, 1643. Lying on Pagen Point Bay, E. upon land of Thomas Davis and S. upon John Mahoon, for trans. 2 persons."

"THE KING OF ALL PLACES" was described by R. S. Thomas (in V.M. 6: p 33.) as the first landing on Cypress Creek, a tributary of the Pagan River. Although these places were known to local people as late as 1890, it may be difficult to locate them today. U.S. Geological Survey Maps help; however, the course of the Pagan River channel, as well as that of the Cypress Creek, may have changed over the years and it is difficult to determine from what is found in written documentation and current geological survey maps to locate "The King of All Places." "Red Point" appears on the current geological survey maps and "The King of All Places" would be anywhere from 3/4ths to 1 1/2 miles away depending on where the "first landing on Cypress Creek" was. There are several bluffs rising from Cypress Creek any one of which may have been the "King of All Places."

Cypress Creek, for those who attended the 1989 reunion, is the creek located between Smithfield proper and the more eastern portion of the town. The bridge across Cypress Creek was billed as "Fulgham's Bridge" by some (although the Fulghum's Bridge on the current geologic map is several miles to the east of the bridge across Cypress Creek. The Fulghum's Bridge on the geologic map crosses Jones Creek which runs from the St. Lukes Church to the Pagan River and was, in times past, navigable to small boats up to the church).





Figure 1. Map of the area between the Pagan River (and Red Point) and the old Brick Church (St. Luke's). Shown is Cypress Creek, Fulgham's Bridge over Jones Creek, and the eastern portion of the town of Smithfield. Downtown Smithfield is to the west across Cypress Creek.

SOME NEW LEADS TO CAPTAIN ANTHONY'S ORIGINS?

Colin Foljambe furnishes us with possible new leads to the origin of Captain Anthony Fulgham. He has located a James Fuliam and a James Fulgam of the late 16th century in Middlesex, England. Colin offers us the following:



The above in Middlesex or its close vicinity. Either one of the above Anthonys might be the Anthony in Virginia, America in 1645 or there abouts.

Other members of this particular family were residing there at Holborn and Stepney as late as 1700. One of these was:

Foljambe, Peter, Mariner of Stepney, Middlesex, of H.M.S. Pendennis, and died in H.M.S. St. Michael. Probate Act Book 197 for 1697, folio 198. Sarah is widow of Peter of St. Andrews, Holborn, Middlesex. Her will, Probate Act Book 227 for 1699, folio 189 (or 187). For the above two, P.C.C. will now held in the Public Records Office, London.

EDITOR's Note: The reference Colin makes to this Peter is very interesting since John Fulgham (Foljambe), the oldest son of Captain Anthony, returned to England at some point in his life (after he married and raised a family in Virginia?), joined the Roayal Navy and rose to become Captain of the H.M.S. Pendennis. Was this a coincidence? Or did these people know each other or were they closely related? Could the Peter Foljambe mentioned above be an uncle of John? Captain Anthony may have been from Middlesex since he brought immigrants from Middlesex, England to Virginia. Also, it is known Captain Anthony had some connection with a family of Smiths and that an "Anthony Smith" left England for Virginia—perhaps his wife, Martha, was a Smith (Smyth) as a Robert Smyth lived close to Captain Anthony early on in Virginia. My father, James Hooks Fulghum, thought Captain Anthony might have been a Quaker or Quaker sympathizer and therefore it is possible he left England under an alias (his wife's maiden name?). These are leads on which it is interesting to speculate. Hopefully they can be followed to provide the correct data, possibly leading us to our Captain Anthony's roots in England.

THE EARLY RAIFORD (RAYFORD) FULGHUMS

There have been many Raiford (Rayford) Fulghums since 1743—even to this day. Some of the early North Carolina Raiford Fulghums are discussed below.

The first Raiford Fulghum was the first born of Anthony Fulghum and his wife, Nancy Raiford, daughter of Mathew Raiford, Jr. and Ann Wall. Raiford was born in 1743 in Wayne County, North Carolina. He married Winnifred Pearce in 1764. Winnifred was the daughter of Arthur Pearce and Mary Everett Fitzjerald. Raiford's brothers were Michael, John (the line of Dr. Jim in Jacksonville FL), James and Mathew. The children of Raiford and Winnefred were Arthur, Mary, Elizabeth (Betsy), Theophilus, Richard, Apsilla, Asa, Benjamine, Franklin, and Raiford, Jr.

Raiford died in 1797 in Wayne County, NC. He was seen in the 1790 census of Wayne County.

The second Raiford was Raiford, Jr., son of Raiford and Winnefred Pierce. He was born about 1780 in Wayne County. He did not marry and died without issue, thus we know little about him.

The third Raiford, born 1805 in Wayne County, NC, was the son of Jacob Fulghum and Elizabeth Smith, the daughter of John Smith and Sarah Ann Taylor. This Raiford was the brother of John, Sarah (named after her mother), Jesse, Chelly, Anthony, Jacob Bardin (of the line of Dr. Jim), and Edwin. This Raiford was the grandson of John Fulghum and Sarah Bardin.

The fourth Raiford was the son of Theophilus Fulghum and Mary (Polly) Williamson. This Raiford D. Fulghum was born in 1817 in Franklin County, Tennessee.

The fifth Raiford was the son of William F. Fulghum. He was born about 1823. His mother was Marcella Elizabeth Seat and his Grandfather was James H. Fulghum.

The sixth Raiford was the son of Jesse (son of Jacob) and Temperance Williamson. Raiford was born in 1836 in Rock Ridge, N C. He married Rhoda Boyette and they had six children; Richard, Allison, William T., Jesse Carl, Doc A., and Sidney J. This Raiford died in 1909.

The seventh Raiford was Raiford Thomas Fulghum, born in 1881, the son of James N. Fulghum. He married Nina Darden. He was educated at the University of North Carolina as a Pharmacist and was a Kenly, N C druggist for many years. He was the representative of his district in the North Carolina Legislature. He died February 6, 1947 and is buried at Kenley, N C.

There are many other Raifords and Rayfords in North Carolina and elsewhere. The Historian would be pleased to receive genealogical data from them. Also, additional information regarding the seven listed above would be welcome. Please send what you know about them to: The Historian, Dr. James E. Fulghum, 4831 Avon Lane, Jacksonville, Florida 32210.

This is a typical genealogical example of how a name can be handed down from generation to generation for two hundred, fifty years. The Rayford family came to Virginia early. The first one in Isle of Wight County was Phillip Rayford who purchased land there first in 1674 and later made a number of other land acquisitions.

He was a teacher, a banker, a leader in his community and a licensed Methodist Minister, and a credit to the Fulgham name.

The reunion of the Association members at the Ponce de Leon Convention Center on June 15, 16, and 17th, with 157 cousins registered from all over the country, was a most successful one. DOCUMENTATION OF FULGHAM-FULGHUM HISTORY

As your outgoing editor, I wish to make a suggestion to all Fulgham-Fulghum history and genealogy researchers. The suggestion is to PLEASE reference all historical and genealogical material to their sources. Without this most critical aspect of scholarship, much of our history and genealogy becomes heresay, speculation, or a nice but unverified story.

In a way, historical and genealogical research is not too much different than scientific work—one sees information, or facts, or makes observations. Using these one then develops a theory. Then using additional information gathered (scientifically by laboratory research; historically by researching DOCU-MENTED writings, maps and by other methods; genealogically by studying government records, legal records, church records, personal records, tombestones, etc) one tests one's theory until it can be verified as truth. We never have all of the information—either in science or in history—therefore the search must go on and we must build on what is known already. We must write down every source of our information, including word-of-mouth information.

There are times when we have a story or isolated piece of information that is undocumented. We often must extrapolate from this via speculation to get our research going (or to stimulate other's research). However, it is essential that we very clearly point out what is known and documentable and what is speculation in order not to confuse or make the work of other researchers more difficult. My plea is to put our work on the Fulgham-Fulghum Family on an historically verifiable basis by proper documentation. Some of it is but much more could have been done.

As I review the writings of my father, James Hooks Fulghum, on the family, I see much valuable information was collected and much intellectual work done on it. I know there was a basis for everything my father wrote; however, little of it is referenced to its source. This means that it all has to be done over again. Granted, it will be easier the second time; however, how much more easy he could have made the job if he had cited references or gave the sources of his information.
