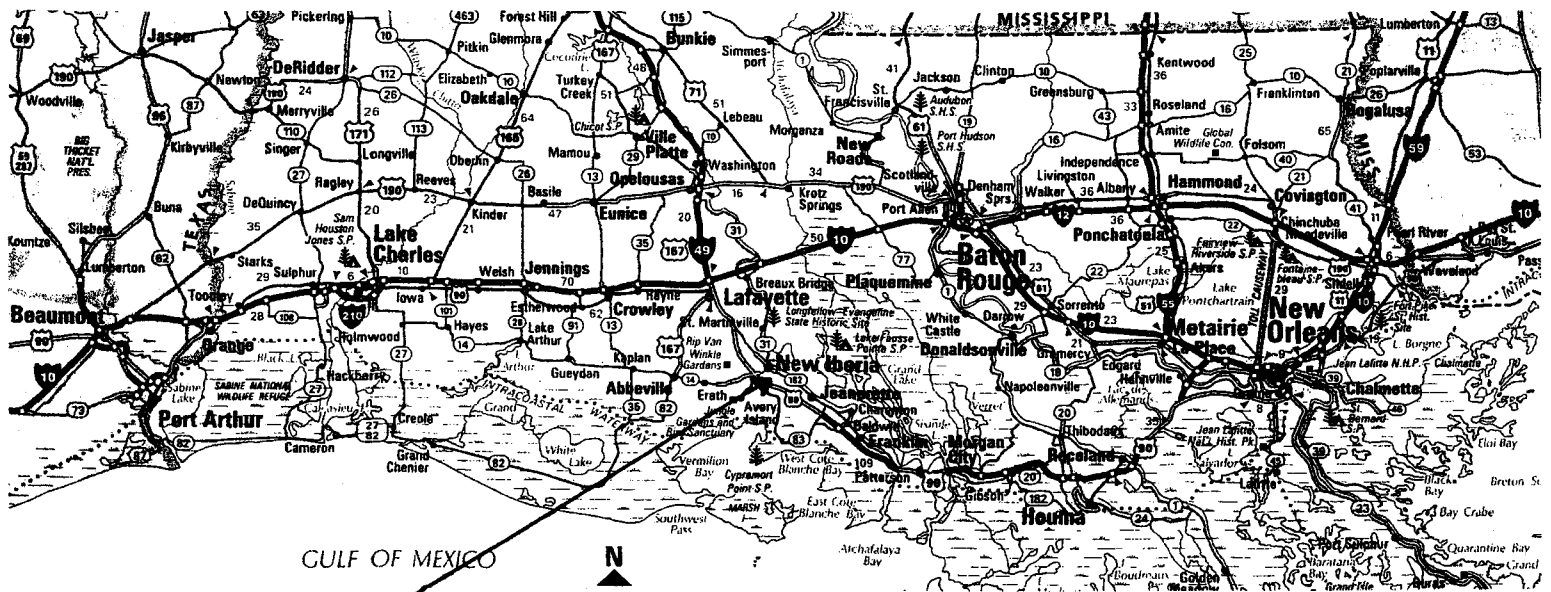

NEWS ITEMS from other publications

MARY SUSAN FULGHUM, M.D. and two other physicians have joined their practices in Raleigh, NC to form **HEATON, FULGHUM, & WILLIAMS, MD., PA.** for the practice of Gynecology and Infertility. In another article on a proposed lottery for North Carolina, **Dr. Mary Susan Fulghum** goes on record as opposing a lottery as she feels lotteries are addictive and would hurt children more than help them (one purpose of a lottery was to raise funds for education in NC).

North Carolina World War II Veterans who left High School to join the armed services were honored by the NC Department of Public Instruction in November 2001 with High School Diplomas. Anyone Know of James Lavoisier Fulghum?

Does anyone know of a James Lavoisier Fulghum, who was born on Wednesday, July 4, 1900, in Valdosta, Georgia? James also went by the nickname "Dot." He began his Major League baseball career on September 15, 1921, with the Philadelphia Athletics. He threw and batted right-handed, playing his first professional game September 15, 1921. The 21 year-old played for one season on one team and ended his big league playing career in 1921. "Dot" died November 11, 1967, in Miami, Florida.

John Fulgham, Pitcher

John Fulgham from St. Louis, MO, born 6/9/1956 drafted as pitcher for Oakland in 1979 at age 28. He was a tall man, 6' 2" who weighed 205 pounds. He pitched and batted right handed. His contract was for \$7,500,000 1979-1988. John earned his first career win on 4/7/1979. He pitched a no hitter against Cleveland on 5/9/1982. He was selected for the 1982 ALLSTAR game He was traded to San Francisco in 1983.

Earl of Liverpool and Governor of New Zealand

The Right Honorable Sir Arthur William deBrito Savile Foljambe was the second Earl of Liverpool. He was born in 1870 and died 1941. He was appointed Governor of New Zealand in 1912 and was the first Governor General from 1917-1920.

Not Always On the Straight and Narrow

Dan Fulghum of Conroe, TX reports the following old news item:

The Angola, LA Prison Death Row Population Included Roy Fulghum who was convicted of murdering four people - his wife, both of her parents and her brother. Later he was re-sentenced to "Life". In 1984 after serving 24 years, he was released on medical furlough, a release mechanism intended for terminally ill prisoners with six months or less to live. Roy Fulghum led a full, active, and non-criminal life as a free man for seven years after his release before he died.

Many Fulghams and Fulghums have volatile tempers. Anger therapy and instruction may be helpful to many.

New Thoughts on the Name, "FOLJAMBE"

What does the name mean? Like most things we encounter, and in Alice of Wonderland, the cat says, words mean what I choose them to mean. That will always be the predicament with the name Fulghum. We really do not know when people took names. Were they given like the Irish policeman on Ellis Island who named one of my Jewish friends "Keeler" when he said his name was "Kiele." There was a moment when I would have named myself "Johnson" if I were John's son. Nowadays we get named and a name is filed on birth certificate. The chances were that Captain Anthony could not write and when he told some writing clerk in colonial office his name was "Foljambe," the clerk dutifully wrote out "Fulgham." And the next clerk may have heard "Fulghum."

We enjoy speculating, but we can do no more than speculate. We have no facts. Nevertheless, The 20 volume Oxford English Dictionary (OED) is now available on a CD at relatively nominal cost, and I have had fun exploring the possibilities. Here are some of them.

1. **deFoleschamp** is Old French, predating 1066. If Foljambe is related to it, searching of the meaning of Foljambe need go no further. We have a good translation for deFoleschamp.

2. **Foljambe** is the oldest and most reliable predecessor for Fulghum. It has two syllables, and everyone seems to agree that it is an adjective and a noun: "Fol" the adjective and "Jambe" the noun.

3. **Fol** in the OED gets two entries, fool and full.

3a. Fool has been the accepted meaning for Fol by all the articles which have appeared in print. I first came across it in a very old genealogy text in The UNC library in 1947. It was printed as fact but without any referential citation. It simply said, "means fool legged." Nor does anyone else have more references than that for that translation. However, everyone who has written about "fool legged" has done so with apology. We are somewhat embarrassed by the pejorative. In fact, all the OED entries for "fool" are pejoratives. There are fool catchers, and fool's gold, fool-hardy and fool-proof, but there are no respectable entries for "fool" that would make us proud to be "fool legged."

3b. In 1000 AD, a written sentence said, "a fat (vat) ther stood fol of bath water." There are of course many other entries for full and combinations like fullsome, full-headed and full-mouthed. Alas, there is no "full-legged." We can imagine however that someone, man or woman, would have been pleased to be thought "full-legged."

4. **Jambe, the noun syllable**, is a very early entry in the OED. It means "leg," "support, and nothing else. In fact, the heraldic symbol is specifically mentioned as a favored arms device. The armor for the leg was a Jambe, a Gambe or in Celtic, a Camb, which also means "bent." (See below.)

4 a. Jambe is taken directly from the French and is still pronounced with the soft French "G." Mr. Michael Foljambe of Osberton, England told me he pronounced it "Full-zhjum" which Dr. James (Dr. James E. Fulghum, former family Historian) preferred. Jam is often used to denote a supporting structure or architectural device as in door-jam.

The arms device, the armed leg which Dr. James describes as the crest "coupled at the thigh, with spur," i.e. armed. Notably, the leg is bent. One recalls both the "bend" and the "crooked." The crest certainly confirms our translation of "jambe." Is there a clue in the bend of the leg. The OED provides a clue. An archer bends his bow with its bow string. Cross bowmen would have bent their bows as they prepared for battle. Later, flint lock rifles were bent or cocked ready for firing. A runner at ready has a bent leg, not kneeling piously but ready for action, to spring forward. The bent leg on the crest could easily and honorably be bent ready to spring into action. One thinks of the crouched football linesmen.

On the shield of the arms, there are 6 scallop shells, their hinges at the top, separated in threes below and above the bend or band. These shells are identical to the 3 scallop shells found on the shield of some St. James Churches. St. James' relics are believed to rest at Compostela, Spain, a famous pilgrimage shrine in the middle ages. People who made the pilgrimage seemed to merit the scallop shell as a badge to be worn or displayed. As it became associated with travel, some say it became a badge of the crusades, a claim not easily confirmed in the OED or Britannica Encyclopedia.

This etymology seems to give us the option of being "Full jambed" or "Fool jambed". I could be proud to support "Stout legged;" I could be excited by "Full legged" women. It seems worth considering.

MEET MY FAMILY GROUP, Part 3

The lineage of our family group, **James Hooks and Frances Schmidt Fulghum**, was reported incorrectly in the 2nd and 3rd issues of the newsletter. Judson Fulghum since straightened out this lineage before his death. The lineage is now thought to be as follows: Captain Anthony Fulgham → Michael → Anthony → Anthony → John → Matthew → James → Charles Mallory → James Hooks, Sr. → Robert Schmidt Fulghum. This makes me a 9th generation progeny of Captain Anthony. Part 3 picks up with Anthony Fulgham, Great Grandson of Capt. Anthony.

Anthony Fulgham, Ca 1720-1768.

Anthony Fulgham was born about 1720 in Isle of Wight County, Virginia. He died 3 March 1768 in old Dobbs County, NC (now Wayne County, NC). He was the son of **Anthony Fulgham** (~1675-1727) and **Sarah Raiford Fulgham** (~1678- ?). Anthony married his first cousin, **Nancy Raiford**, in ca 1740.

Anthony and Nancy moved with other Raiford relatives to North Carolina about 1742 and settled in old Dobbs County, now Wayne County, NC. This Anthony Fulgham is the ancestral father of most of the Fulghum's who spell their name with a "U".

Nancy and Anthony had five children of whom we know. They are listed below separately as their children migrated to the "west", beginning the spread of the Fulghums nationwide.

The first son was **Raiford Fulghum**, born 1743 and was the first Fulghum born in North Carolina. Raiford became a large landholder in Wayne County, NC. He married **Winnifred Pierce Fulgham** and settled on Nahunta Swamp to the west of Pikeville and Freemont, NC. Two of Raiford's sons, **Theophilus** and **Arthur**, joined the Williamsons and migrated to Tennessee where they established Williamson County, TN. Some years later, Arthur left Tennessee and moved to Texas where he established the Fulghums of Texas. **Robert Lee Fulghum**, noted American Author, is from the Arthur Fulghum lineage. Raiford's grandson, **William**, son of **Benjamin Franklin Fulghum** of Wayne County, NC, migrated first to Tennessee and then to Mississippi where he established the Fulghums in Mississippi.

The second son, **John Fulgham, Sr.** was born in 1747. He married **Sarah Bardin Fulghum** in about 1770. Sarah was born about 1750. They lived on Myrtle Spring Branch and Great Swamp northwest of Freemont and south of Black Creek, NC.

The third son, **James Fulghum**, was born about 1750 in Wayne County, NC.

The fourth son, **Michael Fulghum**, was born about 1755 in Wayne County, NC. He was a Wayne County landowner. After his death, his children migrated to Indiana (they were Quakers) and to Tennessee. Descendents of these children have now migrated to other states.

Another son, **Matthew Fulghum**, was born about 1755

John Fulghum, Sr., 1747-1825

John Fulghum, Sr. was the son of **Anthony Fulgham** (1720-1768) and **Nancy Raiford** (1724-1798). He was born ca 1747 in old Dobbs County, NC (later Wayne County) and died in 1825 in Wayne County, NC.

John married **Sarah Bardin** in ca 1770. Sarah was born ca 1750 and died in Wayne County, NC in 1828. Sarah was the daughter of **Jacob Bardin**. They settled on a state land grant on Myrtle Spring Branch where it enters Great Swamp which is now the dividing line between Wayne and Wilson Counties.

John and Sarah had the following children: **Anna Fulghum Clark**, born ca 1770; **Jacob Fulghum**, born 1773; **Benjamin Fulghum**, born ca 1774; **Matthew Fulghum**, born ca 1775; **Elizabeth Fulghum**, born ca 1777; **Patience Fulghum Jones**, born 1780; **Sarah Fulghum Pierce**, born ca 1782; **Zilpha Fulghum Davis**, born 1785; **Bethaney Fulghum Barnes**, born ca 1790; **John Fulghum, Jr.**, born ca 1795-1800; and possibly an unknown male born 1800-1819 and an unknown female born 1810-1820 who were listed in the household in the 1820 census (they could have been grandchildren living with the grandparents). Another source lists eight children, not mentioning Anna and Benjamin.

John's will is available in Wayne County, NC. He left personal articles to some of the female children. He left the whole of his land to wife, Sarah, during her natural life or widowhood. After her decease or remarriage, the land was left to Matthew (Jacob had acquired property in Wayne and Nash counties and had moved away whilst Matthew remained on his father's land and tended it). Jacob was executor. John, Jr. was witness as was Norfleet Newsom.

John died in 1825 in Wayne County, NC. Sarah died in about 1827 although some list her death as occurring in 1832.

FULGHUM HONORS AND SPEECHES

The Virginia General Assembly honored Thomas R. Fulghum for his long and exemplary service to Chesterfield County, Virginia Public Schools with House Joint Resolution No. 396, offered January 8, 1997:

WHEREAS, Thomas R. Fulghum, concluding 37 years of meritorious service to the Chesterfield County Public Schools, retired on June 30, 1996; and

WHEREAS, Thomas R. Fulghum began his career in Chesterfield shortly after he graduated from North Carolina State University, when he was hired as a science teacher at Thomas Dale High School in 1959; and

WHEREAS, over the past 37 years, Thomas R. Fulghum has held a variety of important positions within the school system, including supervisor of transportation, administrative assistant, and assistant superintendent; and

WHEREAS, witnessing the growth of Chesterfield's school population from 12,000 in 1959 to nearly 50,000 today, Thomas R. Fulghum has been involved in the construction or renovation of each of the county's 56 school buildings currently in use; and

WHEREAS, as superintendent for the past five years, Thomas R. Fulghum has rendered strong and innovative service to the citizens of Chesterfield, improving on an already excellent school system in a number of areas; and

WHEREAS, under Thomas Fulghum's stewardship, Chesterfield's public schools have maintained or enhanced their nationwide reputation for providing high-quality education to the youth of the county; and

WHEREAS, Thomas Fulghum established a budget advisory committee to increase the involvement of the community in the budgetary process; worked to update technology in the schools; and established the Superintendent's Safe Schools Initiative, including zero tolerance of weapons or drugs in the schools; and

WHEREAS, throughout his long and productive career, Thomas Fulghum has brought leadership, commitment and dedication to his service to the citizens of Chesterfield and the Commonwealth; now, therefore, be it

RESOLVED by the House of Delegates, the Senate concurring, That the General Assembly hereby commend Thomas R. Fulghum on the completion of a sterling career as a teacher, administrator, and singularly effective leader of the Chesterfield County public schools; and be it

RESOLVED FURTHER, That the Clerk of the House of Delegates prepare a copy of this resolution for presentation to Thomas R. Fulghum as an expression of the General Assembly's gratitude for his exemplary services and best wishes for a long, fulfilling, and well-earned retirement.
