REUNION NEWS –UPDATE

It is time to be making plans for attending the 2005 FFFNA Reunion in Annapolis, Maryland, July 8 – 10, 2005. Also, it is time to make reservations while rooms are still available. The hotel is the Maryland Historic Inns located at 58 State Circle in Annapolis. The Historic Inns are three charming hotels operating as one. Room rates will be \$115 + 7% lodging tax and 5% Maryland State tax (total about \$130 per night). Reservations should be made early as there is no back-up hotel with reasonable room rates. Telephone number for making reservations is **800-847-8882**. All guests register on arrival at the Governor Calvert House.

It is suggested that reservations be made no later than May 27th. Parking at the Hotel (valet parking) is \$ 18 per night. Parking at the city parking garage (about 2 blocks away) is \$8 per night while parking at the Navy Stadium is \$4 per night. Now doctors say a bystander can recognize stroke by asking three simple questions of possible stroke victims:

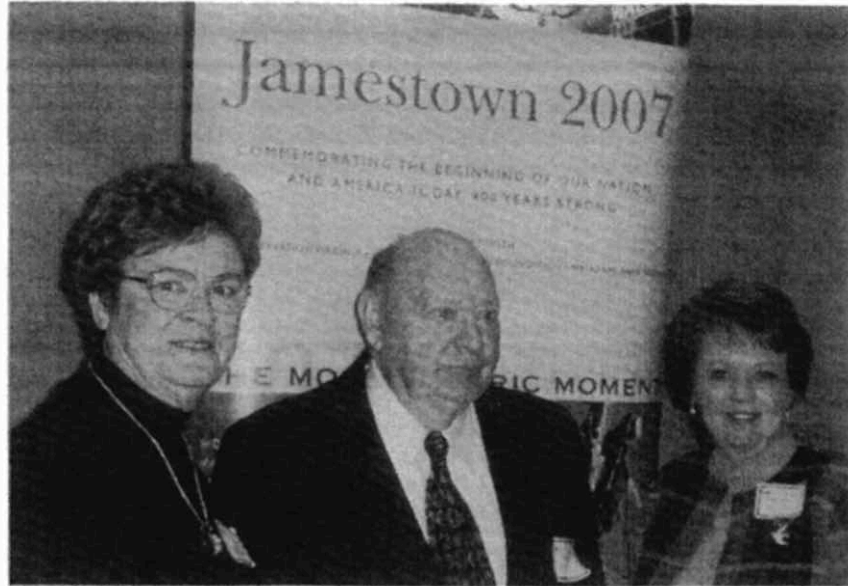
- **Ask the individual to smile**

It's Like Hair

"Family history can be a lot like hair – one doesn't think about it much until one starts to loose it" ⁽¹⁾.

Your newsletter editor was in the same boat. His father, James Hooks Fulghum of Roanoke, VA was a great Fulgh^m family genealogist. Jim developed the lineages of many branches of the Fulgh^m family. Your editor, however, was too busy to keep up with what his father was doing. Then he was away at college, in the U.S. Air Force, married, had children and a career. It was not until after his father suffered incapacitating strokes that he began to realize that a great source of family history beyond what his father had written down was now lost.

The moral to this story is for family groups NOT to wait until too late to begin to collect and compile family stories and history. Make it a part of family holiday gatherings to obtain and write down the genealogy of your family group. Add the newcomers and write down stories and family history information from the elderly family members. Compilations of such materials are not only of interest to the Family but also to historians researching the day-to-day activities of the various generations.

The Fulgham- Fulghum Family National Association urges you to create the family history of your family group. Periodically update it and submit it to our Historian and Archivist, J. Grant Fulgham, as it is developed over the years.

Carl W. Fulghum

Carl W. Fulghum served as Justice in the U.S. Occupation Court in Frankfurt, Germany. One case that came before him was a custody case involving a boy who was separated from his parents in Yugoslavia by the German Gestapo. His parents were sent to prison camps because of the father's underground Partisan work. The boy was taken to Germany and adopted by an SS Trooper and his wife, who were childless.

After the war, the birth Mother located her son and applied for custody before a U.S. Occupation Court. At first, denied custody, she reapplied. Justice Carl W. Fulghum argued that the boy should be returned to his birth mother. As he said, the earlier "ruling meant a former SS Trooper is considered more suitable [than she] who suffered so much at the hands of the Nazis." ⁽¹⁾ The three justices finally ruled that the boy should be in the custody of his birth mother.

TAX EXEMPT STATUS FOR THE FULGHAM-FULGHUM FAMILY ASSOCIATION

It was back in 1995 that the need for tax exemption status for the Fulgham/Fulghum Family National Association first surfaced. Since that time many efforts have been undertaken to gain access to tax exemption but none was successful.

It was during a Marketing Committee meeting at the 2003 reunion in New Iberia, Louisiana that **Eugene Fulgham** of Jacksonville, Florida, a member of the committee, spoke up and remarked that he had been involved in two or three organizations that had been successful in obtaining exemptions. Gene volunteered to join **Peggy Fulghum Wood**, the Association's Secretary/Treasurer, in working on an IRS application for exemption.

The first step undertaken by the pair was applying for a charter as a non-profit corporation in the State of Florida which is required by the IRS. Then, the long process of filling out an IRS application began. This phase was completed in a few months and the application was submitted to the IRS. Meanwhile, Peggy had struck up an acquaintance with the IRS agent on the telephone with whom they had been calling for assistance.

When the application was reviewed by the IRS staff, it was decided that the family association was **not** entitled to a 501 c-3 designation **but did qualify** for a 501 c-7 designation. The 501 c-3 gives a complete exemption for the organization as well as those who contribute to it while a 501 c-7 gives the tax exemption to the organization and not to those who contribute to it. But, Peggy was on the phone with the agent acquaintance and he suggested that the family might want to establish a foundation and then apply for exemption for the foundation.

The Fulgham-Fulghum Family National Foundation was soon established and the **IRS approved 501 c-3 status for the Foundation.**

What does this mean? It means that anyone making a contribution to the Fulgham-Fulghum Family National Foundation can claim exemption for the gift on his or her income tax return. **Gifts, for example, to the proposed family library/museum in Smithfield, Virginia, will be tax exempt.** This includes gifts in kind (such as items for the Museum, books, etc.) as well as gifts of money.

Gene Fulgham and Peggy Wood deserve appreciation from the Association and the Foundation for the hours they invested in accomplishing this much needed development.

LIBRARY / MUSEUM PLANS

Now that the Fulgham-Fulghum Family National Foundation has been formed and it has gained tax exemption from the Internal Revenue Service, things are beginning to fall together in the plan for development of a family library and museum in Isle of Wight County, Virginia.

The family got its start in America in Isle of Wight County when Captain Anthony (Foljambe) Fulgham settled his family in Virginia about 1640.

Here are the library/museum events as they are unfolding. Options are being studied for the best route for the Foundation to take in development of the facilities. Currently, there are three options: (a) the Foundation can build a free-standing facility in or near Smithfield, Virginia in Isle of Wight County; (b) the Foundation can locate its facility within a new county work training facility to be constructed by providing the County the \$500,000.00 it proposes to raise with the entire facility being named the Fulghum Center; or (c) the Foundation can include its facility within the neighboring community college's possible new library facility which it may build as a part of a proposed new satellite campus in Isle of Wight County.

Option (c) appears to be the best of the three with the hope that this new community college library will ultimately develop into a significant Southside Virginia historical genealogy library. Discussions are underway to reach final decisions by the Foundation and the Community College.

Meanwhile, the fund raising effort is underway by the Foundation. James E. Fulghum of Wilson, North Carolina, the fund raising campaign Coordinator, reports that promises, pledges and received donations thus far indicate that almost \$100,000.00 of the \$500,000.00 goal is at hand. Jim is working by telephone to obtain pledges of up to three years from family members.

Conq'ring hosts in freedoms name.

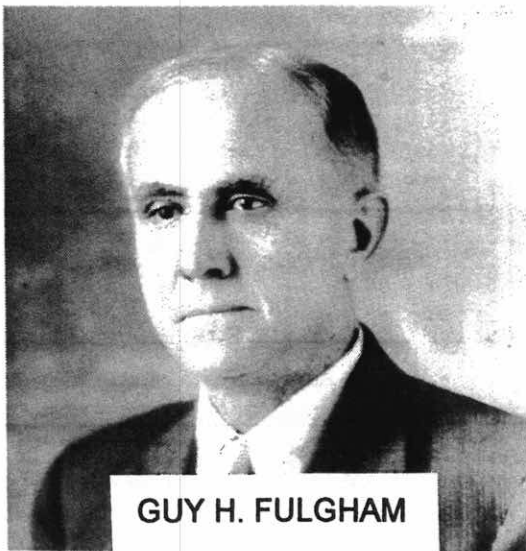
Emblazon'd on her standard high,

Editor's Note: These poems were found in a file of old letters to James H. Fulghum presumably written and dated in circa 1945. I think the poems were written just after World War II and it is this war to which the poem, **GEORGIA**, refers. Guy H. Fulgham added greatly to JHF's understanding of the genealogy of the Fulgh'm family through his letters to JHF.

SURLY STRANGER by Mike Cox

Whoever he was, he got a nice funeral.

Texas Ranger J.W. Fulgham and a Reeves County sheriff's deputy, identified in the press only by his last name of Lackey, left Pecos, Texas for a ride down the Pecos River, looking for cattle thieves or fugitives in early September 1893.

Back then, the Pecos was a good place to find either variety of criminal.

After an easy-paced 13 mile scout, the two lawmen camped for the night near Emigrant's Crossing, one of the river's two principle fords. The next morning, after coffee and breakfast, they continued their trek southward along the snake-like river.

Not long after swinging into their saddles, the two lawmen noticed that they were being followed at some distance by a solitary cowboy leading a packhorse. Wanting a closer look at the man, the officers slowed their horses, assuming the rider would overtake them. But when they slowed, the cowboy behind them seemed to slow down, too.

Since the two officers didn't look much different from cowboys themselves, they were beginning to get slightly suspicious at the man's apparent disdain for company. Reining their horses, the ranger and the deputy dismounted and waited for him to catch up. When he did, he rode right by with not even so much as a howdy or even a tug on his hat brim.

At that, the two officers got back on their horses and quickly caught up to him, one officer on each side. Observing that he wore a pistol, Lackey identified himself and asked the man if he was an officer. "I have been," he said, not elaborating.

Lackey shot a few more questions in his direction. "He answered all questions as to his name and destination in an abrupt and surly manner," the Pecos News reported a few days later. "His actions were those of a fugitive from justice."

The Reeves County deputy studied on the matter for a moment. "Jim," he told the ranger, "we will go to Pecos and take this man with us." Hearing that, the stranger dropped the reins to his packhorse and went for his pistol. At that, the two officers yelled for the rider to throw up his hands. Instead, the cowboy raised his pistol.

The Ranger must have had his eyes fixed on the cowboy's Colt, because his first bullet went through the non-communicative rider's gun hand. The smoke from that round blew into Fulgham's eyes. Aiming by instinct, he pulled the trigger again, sending a slug into the stranger's chest and knocking him off his horse.

"By God boys," the cowboy said, raising up on one arm. Then he slumped down, dead. The officers left the body where it lay and rode to Pecos to summon Reeves County Sheriff G.A. Frazier.

The sheriff and Ranger Lon Oden accompanied the other two officers back to the scene, where Oden picked the dead cowboy's gun up and found it had been half cocked. Then they loaded the dead cowboy on a horse and brought him back to Pecos.

About all the cowboy had to his name was the Colt revolver, which had one black grip, one white, a memorandum book and a letter with the signature torn off. "Started to work for the flying E. Cow Co.," one entry in his notebook said. One line in the letter gave credence to the officers' belief that the cowboy was wanted by the law somewhere: "I would like to be back on the old creek, but you know I can't come."

The officers figured the man to be about 23 years old. The doctor who examined the body measured him at 5 feet, 10 inches, guessed his weight at about 160 pounds and noted that he had grey eyes.

"Messrs. Fulgham and Lakey regret the occurrence very much," the newspaper account continued, "but from what we can learn from the facts of the case, we feel certain that they did nothing more than their duty required."

Unable to learn the man's identity, Sheriff Frazier saw to it that he got "a nice suit of clothes" and had him "buried in a quiet and genteel way, Rev. J.E. Sawders officiating."
