Don't Let A Scammer Like Madoff MAKE

OFF With **YOUR** Money! By Barbara Bennett,

Thieves are getting more sophisticated in their strategy to steal your money. Even with all the recent publicity about the many scams worldwide, investors are still at risk.

Our sense of safety allows these swindlers to commit "affinity fraud," a crime that targets entire groups of people at once.

Scammers may pose as a member of the targeted group to get their foot in the door. They may enlist the unwitting help of group leaders to win members' trust and get them excited about a supposedly "safe" investment. They rely on the expectation that their victims will be too embarrassed to report this type of fraud to the authorities. Such silence allows these crooks to repeat their frauds on additional unsuspecting people. Right here in NC, a con man tricked members of his own church out of \$1.6 million.

Just about every state in the U.S. has a Securities Division similar to the one in North Carolina that can be contacted for investment and securities information. Such information may help prevent you from becoming a victim of fraud.

CHECK BEFORE YOU WRITE A CHECK!

While all investments carry risk, the North Carolina Secretary of State Securities Division recommends the following to minimize the threat of falling victim to a scam:

- 1. Call 919-733-3924 or 1-800-688-4507 to verify that both the person selling the securities investment (brokers and dealers) or anyone charging a fee for investment advice, and the security itself are registered.
- 2. Do not invest simply because another member of your group invests.
- 3. Make sure the promises made by the promoter are in writing.
- Do not believe claims that the investment is risk-free or "guaranteed." If it sounds too good to be true, it most likely is.
- Do not be pressured for an immediate decision. No legitimate opportunity requires a snap decision.
- Remember that use of insider information is illegal, so any deal cloaked in secrecy is suspicious.
- 7. Pressure tactics, whether to induce fears, greed or a sense of confusion, are aimed at getting you to sign a check before you realize you have been duped.
- 8. Don't let anxiety about asking "too many" or "dumb" questions, stop you from performing your own due diligence. It's your money!

Proof?

We have little primary proof for many of the Fulgh*m lineages we have worked out but have ample evidence supported by U.S. Census records and other records. However, we do have some genetic proof for several of the lineages. Using the 12 marker Y-DNA test, ten Fulghums or Fulghams have been tested and made the results available (1). All ten of these individuals have identical marker profiles. Following the lineages back to the sons of Captain Anthony, we find that five of the tested individuals descended from Captain John Fulgham, the eldest son of Captain Anthony Fulgham while the other five trace back to Michaell Fulgham (2). Thus, we have genetic evidence that Captain Anthony Fulgham is the common ancestor of almost all Americans with the name, Fulghum, Fulgham, or Fulgum. One of Captain Anthony's sons, Anthony, Jr., died without issue and the youngest son, Nicholas', lineage failed and his remaining descendants died during a Yellow Fever epidemic.

Captain Anthony Fulgham presumably emigrated to the Virginia Colony from England. At the present, we have been unable to find Captain Anthony's roots in England despite much research. The English Fulghams were a cadet branch of the prestigious Foljambe family of England. While there are still Foljambes in England, the lineage failed several times since the 1600's and the current Foljambe aristocracy are not genetic Foljambes. We have not been successful in finding other persons in England with known lineages back to genetic Foljambes who are willing to undergo Y-DNA testing.

The Foljambes (The Norman version of the name was DeFoleschamp) are known to have fought with William at the Battle of Hastings and to have helped establish William's authority as the King of England. These people were of Norman descent and the old chronicles tell us that they were of Viking descent. That the old chronicles were true in this respect is shown by an individual in New Zealand who matches the American Fulgh*ms at the 12 marker Y-DNA test. Inquiring the origin of this gentleman, we found that his family descended from a group of Vikings who were ship-wrecked in the Shetland Islands (3). Thus, we must have with him a common Viking ancestor. Another person from Finland contacted us as he also matched the Y-DNA of the American Fulgh*ms⁽⁴⁾. He concluded that we most probably had with him a common ancestor from Norway, the origin of his family. There are some others that match us; however, we have had no communication with these individuals.

Using the rationale used by the Genographic project (5), we can trace the migration of our family from northern Europe from the dawn of written history to the present - a journey of at least 1,500 years.

After discussion, it was decided to award the Scholarship for 2009-10 to Timothy White of Columbia, SC.

Robert S. Fulghum discussed the progress of the proposed Library. This report included the history of the progress from the early thoughts to the present status

Robert S. Fulghum gave a report on the acquisition of materials for the Library.

Campaigns for funding the construction of the Library and for purchasing books for the Library are continuing. Please contact Peggy F. Wood regarding donations. The Library will be something very useful for not only the family but also for the Isle of Wight County, Southside Virginia and the Southern US. When the Library is complete, the Fulgh*m Family will be leaving a permanent legacy of which every one of us should be very proud.

The Annual Business Meeting

June 27, 2009

Larry Fulghum, President, of Raleigh, NC called the meeting to order.

Peggy Fulghum Wood gave the **Treasurer's Report**. There are 179 paid members for 2009. Peggy thanked those loyal members who were generous and sent more than dues to help with expenses. The Treasury as of June 16, 2009 had a balance of \$18,083.50. Expenses for 2008-9 were \$16,305.77 which included payments on the 2007, 2008, and 2009 reunions made to date.

Robert S. Fulghum gave the **Editor's Report**. He reported no problems with the newsletters. He spoke to the importance of Obituaries as genealogical documents and urged the members to send in Obituaries for inclusion in the newsletter. He also gave reports on the **Library** and **Library materials**. Essentially these were the same as the reports for 2008 except that the Benns Grant proposal has received approval by Isle of Wight County Board of Supervisors (See Foundation Newsletter, No. 4, p 3, Summer 2008). It was noted that there would be changes in the Library Planning Committee membership and the Curator of the Library Chairman in the future.
