# WILLIAM FOLJAMBE III (ca. 1463-ca.1534) THE GGG GRANDFATHER OF CAPTAIN ANTHONY FULGHAM

INTRODUCTION - Newsletter issue #84 of Summer 2016 explored the life of William Foljambe IV (ca. 1490-1548). This article shall study the life of his father, also a William. In order to differentiate the two, the father shall, for the purposes of this work, be called William III. In the early stages of preparing this study it became clear that the prime mover affecting William III's life was the multi-generational profession of his ancestors, i.e., estate management. His GGG Grandfather, Sir Godfrey Foljambe (1316-1376), had been Chief Steward of Lands for Queen Philippa (King Edward III's wife) and subsequently for John of Gaunt (1340-

1399), Duke of Lancaster. William III's ancestors subsequent to Sir Godfrey were Feoffees (Trustees), Escheators (administered land transfers to the sovereign when no legal heir existed), Feodarys (assisted the escheator in issues involving the Court of Wards), and Notaries (prepared contracts, deeds, etc.). Each of these professional activities involved our ancestors in estate management including property related topics such as conveyances, reversions, and inheritances, to name but a few. Those of William III's ancestors performing these activities were functioning under an umbrella of sovereignty held by the earls and dukes of Lancaster and, after 1399, the English Crown. As such, they were early retainers of the Duchy of Lancaster and, later, of the Crown. In the role of retainers of the Duchy of Lancaster and Crown, our ancestors associated with other Lancastrian retainers and, over time, became members of what would later be named in scholarly writings "The Lancastrian Affinity.\(^1\)" Certainly, Sir Godfrey was an early and auspicious member of the affinity. Being in the affinity meant that one had ready access to Lancastrian or Crown patronage and ready access to the affinity marriage market for one's marriageable issue. Sir Godfrey arranged the marriage of his son, Thomas (1345-1433), to Margaret Loudham (1371-1432), of the Lancastrian Loudham family, who, as co-heir of her brother Sir John Loudham (1369-1390), brought Thomas part of the vast Loudham estates, including Walton Manor in Derbyshire. Thomas Foljambe, in turn, arranged the marriage of his daughter, Isabel (1396-1417), to Lancastrian Sir Hugh Willoughby (1386-1448) setting in motion a family affinity that subsequently brought other Willoughby marriages to the Foljambe family extending to William III's direct ancestors. Also, Thomas arranged the marriage of his daughter, Margaret (1389-1462), to Lancastrian Ralph Monboucher (1383-1411), Lord of Gamston (aka Gamelston) Manor, Nottinghamshire. After Ralph's death sine prole in 1411 and Margaret's remarriage to Lancastrian John Cokefield (1380-1453) of Nuthall, Nottinghamshire in 1413, Thomas and his nephew, William "the feoffee" Foljambe (1376-1444) (William III's G Grandfather) purchased Gamston in 1418 from Monboucher's heirs for 200 marks and gifted Gamston to Margaret for her life. She lived until 1462.


#### **Family Website**

BIRTH AND EARLY ADULT LIFE – It is estimated that William Foljambe III was born about 1463 at Cossall Parish near Wollaton, Nottinghamshire. Cossall had been the home of his mother, Alice Willoughby, when she was married to her first husband, John Marmion, prior to his death ca. 1460. Alice married in ca. 1462 William "the younger" Foljambe and they remained initially in the Cossall manor while their family grew. As written above, their first-born, William, came in ca. 1463. Although no christening record has yet been found for William III, we can be reasonably sure that he was named William since the naming custom of the time was to name the first-born son after his paternal grandfather, in this case, William. The family left Cossall, Nottinghamshire by November 1464 and moved into what would become their home for three generations (70 years), Inge's Manor, Hertfordshire<sup>2</sup>.

There were at least seven midland families of major importance in William III's life and that were allied with the Foljambes during their long history with the house of Lancaster:

William III grew up during the second half of the Wars of the Roses but there is no evidence that he fought in either of the two final battles that happened after he reached 16 years of age, the 16th century minimum conscription age <sup>5</sup>. Given that neither William the younger nor William III entered the priesthood and that neither trained to be professional soldiers, it seems likely that they were content to live at Inge's Manor as country gentlemen occupied with farming interspersed with legal work similar to William the elder. By the late 1480's it was time for William III to marry. A cohort of the families involved - the Foljambes, the Willoughbys, Elizabeth Bowett, and patriarchs of families of potential marriage candidates - would have met to discuss the issues of the future marriage and ultimately negotiate a marriage settlement. The prospective wife would be from William III's social level, be of a family with Lancastrian credentials, offer an acceptable dowry and be acceptable to William III's side of the before-mentioned cohort. Because of interconnecting family interests, one family, the Thurland family of Gamston, Nottinghamshire, perhaps came to the forefront early in the search. The Thurland family had been on the rise in Nottingham since the beginning of the 15th century and, at the time of the marriage search, included an eligible daughter that met all criteria for William III's wife<sup>6</sup>. A clue to the convergence of the Foljambes of Inge's Manor and the Thurlands is inferred by following the conveyances of Houghton on Idle and Gamston manors shown below:



Although no official record has been found that proves the identity of William III's wife (presumably Alice Thurland), it remains reasonable to infer the marriage based on the following surviving circumstantial evidence: (a) Alice Thurland's mother, Jane (nee Willoughby) Thurland, was the half-niece of Richard Willoughby, Lord of Wollaton; (b) Richard Willoughby was the son of Isabel Foljambe and half-uncle of William III; (c) Alice Thurland's sister, Jane Thurland (d. 1520), in 1504 married Sir John Dunham, the son of Elizabeth Bowett; (d) Sir John Dunham, William III's brother-in-law remarried, in 1522, Benedicta Foljambe, William III's 4th cousin; (e) Sir Thomas Thurland left his daughter, Alice, 40 Pounds in his will of 1498 and she was ultimately the longest lived of her siblings ... but her only brother, Thomas, was styled "The Profligate" by antiquarians and may have squandered the family fortune. At their marriage in ca. 1489, however, William III could perhaps have anticipated a substantial dowry.

#### Literacy Fund Established in Memory of Joan Fulghum



The Rev. Peter Fulghum holds a picture of his wife, Joan, a lifelong teacher, and reading tutor, who died in December 2017. As a longtime elementary school teacher, Joan Fulghum knew the importance of reading. She taught in three states, including Maryland, where she worked in Washington and Anne Arundel counties. Now, her family is honoring her with a fund in her name to help local adults learn to read. Fulghum retired from Pangborn Elementary School in 1997. In November 2003, Joan trained to be an adult reading tutor with the Literacy Council of Washington, County, Maryland, according to LCWC Administrator Brenda Vanover. "She jumped in on that when she retired, "said Fulghum's husband, the Rev. Peter Fulghum of Smithsburg. After Joan Fulghum died in December 2017, her husband and their four children considered different ways to honor her. They started "The Joan Fulghum Memorial Fund for the Literacy Council of Washington County," which was established through the Community Foundation of Washington County. A pledge of \$30,000, to be given in \$10,000 increments over three years, was presented to the LCWC on Jan. 28, 2019. LCWC Board President Kevin Fox said the fund will support the council's three main objectives—attract and retain volunteers to tutor adults, provide up-to-date books and resources, and help students pay for GED and citizenship exams. It allows us to continue our mission in the community, "Fox said. "We're extremely grateful not only for the gift but for Joan's service. Once tutors complete the training, they are paired with an adult student and generally meet for one to two hours a week. Tutors make a commitment to work with their student until the student accomplishes the goal, such as citizenship, completing a GED and applying for jobs. "It's exciting for tutors. It's a commitment, too," Fox said. There are currently about 38 adult students working with 24 tutors. Nine students are waiting to be matched with a tutor, Fox said. Tutoring is free after students go through a 30-minute evaluation. Fox said Washington County has an adult illiteracy rate of about 9 percent. Peter Fulghum said his family is excited about the fund and his wife would have been pleased that her teaching legacy continues. "It changes lives. It really does, "he said. Tutor training is offered twice a year. Groups, such as churches, can request a separate training. The next tutor training is May 11 and May 18 at Benevola United Methodist, 19925 Benevola Church Road, Boonsboro, from 9 am to 3;30 pm. "It only takes one to two hours a week to help somebody learn to read...and change someone's life forever. If you can read, come to the training session and we'll teach you how to teach," Fox said.
