Annual meeting and reunion report

The annual meeting and reunion of the Old Broad Bay Family History Association was held Saturday, August 6, with 17 members attending. The treasurer's report showed an ending balance on June 30 of \$1,423.44. Expenditures for the fiscal year July 1, 2010 to June 30, 2011 were the donation to help restore the 1815 Waldoboro map (\$400), newsletter printing & mailing (\$229.33), rental of the hall for the 2010 reunion (\$125), the 2010 speaker's fee (\$50), and purchase of a brick inscribed with the Association name for the Waldoboro Library sidewalk (\$50).

There was a discussion about increasing public awareness for the Association. Web master Fred Snell explained what keywords he uses for our website to gather in web surfers. There was a brief discussion as to whether a change of the Association name might help. A closer exchange of information and cross-linking web sites with the Waldoboro Historical Society was discussed and will be acted upon by the respective web masters.

Our speaker, Peg Kearney, presented a talk based on her master's thesis, *An Imperfect Union: The Eighteenth Century Origins of the Two Maines.* She will be preparing a summary article for a future newsletter focusing on

the how & why General Knox was able to make the German settlers pay again for the land they thought they had purchased from General Waldo.

Jean M. B. Lawrence of the Waldoboro Historical Society also spoke about her book *Citizens Who Heard the Call to Political Service: Waldoboro, Maine 1773-2010.* Copies were available for purchase. Those who were not present and would like to buy a copy may contact the Waldoborough Historical Society; the cost is \$15.70, tax included. All proceeds go to the Waldoborough Historical Society.

Association elections results

The election of officers was held with one person (Dale Gunn) nominated from the floor to serve as director. President's Message

My thanks to all who attended the annual meeting and elected me president. I have big shoes to fill and I hope to be worthy of your trust.

The Old Broad Bay Family History Association started with the Broad Bay Roots Project of Wilford Whitaker and Gary Horlacher in late 1991 with the first newsletter (*Old Broad Bay Bund und Blatt*) published in January 1992.

In reading the old newsletters it appears Whitaker & Horlacher were in touch with about forty persons doing research on Waldoboro's German families. The summer 1992 issue (vol. 1 #5) tells of the meeting called by Richard Castner on 27 August 1992 at the Friendship Community Center *...to discuss the possibility of having a three day convention/seminar/reunion as an offshoot of the upcoming fourth annual Octoberfest celebration...built around the annual service at the Old German Church.* The summer 1993 newsletter (vol. 2 #4) is the first to be noted as the Official Publication of Old Broad Bay Family History Project and the winter 1995 (vol. 4 #1) issue is the first to be noted as the Official Publication of Old Broad Bay Family History Association.

Mr. Whitaker and Mr. Horlacher published their research as *Broad Bay Pioneers* in 1998. A second book with source documents was reported to be in the works, but never made an appearance. What happened to the raw research material is unknown and attempts by several people since 1998 to contact (or even locate) Mr. Whitaker and Mr. Horlacher have been unsuccessful.

All this is background to saying that 2012 is the 20th anniversary of the Old Broad Family History Association. Since its inception membership has fluctuated widely from a high of over 100 members to a low of about 30. There are many reasons for this, but I would like to make 2012 a special year with lapsed members returning to the fold and new members brought in to join us.

To that end, a major membership recruitment effort is being launched. If you know someone who is descended from a founding Waldoboro family (German or otherwise) please pass this newsletter on to them and tell them they can get a membership form on our website or they can contact me directly at 77 Pascal Avenue, Rockport, ME 04856. The Board of Directors is also looking in to putting the complete run of newsletters from January 1992 to Fall 2003 on a CD along with the complete article index. We hope making the newsletter more easily available to the public will bring new members to our group.

Another topic of discussion for the Board of Directors was whether our Constitution allows us to appeal to the broadest range of persons while remaining true to the original purpose of the group. According to the OBBFHA Constitution, Article II: *The purpose of the Association shall be to unite people who are descended from the founders of Old Broad Bay (now known as Waldoboro), Maine*

to:

- (1) preserve the memory of the German founders of the community
- (2) work with the town, county, and state to preserve the original records of the area
- (3) undertake research on the founding families and the community in general

Further, under Article V Membership: *Membership in the Association shall be open to anyone interested in Waldoboro genealogy and history*. The question is, are we getting our message out? How can we increase membership? I mentioned two courses of action we will be taking in the coming months. If you have any other ideas, please contact me.

He is interested in the family of Johann Georg Hubner, born 1712 in Nieder-Florstadt and died 1797 in Waldoboro. His first wife was Anna Margaretha Naumann (born 1744 & died 1753 in Nieder-Florstadt); he married his second wife, Elisabeth Frizwell, in 1757. He immigrated with his sister Agnesa and her family to America in 1753. Agnesa was born 1719 and married Caspar Claus in 1742; both died in Maine.

He is looking for the families of Johann Georg Roth (son Conrad, wife Anna Elisabeth, brother Johann Christoph), Caspar Claus (wife Agnesa, sons Johann Conrad, Johannes, Georg Philipp, and Johann Conrad II) and Johann Peter Dauernheim.

Camden, ME census 1840 lists Sophronia Kaler household with 2 males under 15-20, 1 female under 5 & 1 female 30-40.

Guardian account, Martha Feyler

The following is a transcription of an account of funds distributed for the care of the minor Martha Feyler: Lincoln County Probate Court, vol. 57, pp. 555-556.

The account of Frederic Castner, Guardian to Martha Feyler a minor child of Godfrey Feyler late of Waldoboro deceased.

A true account

Personally appeared Frederic Castner aforesaid, and made oath to the truth of the foregoing accounts and the same having been ?-----mind? is hereby allowed and accepted, after proof of notice having been given as ordered by the County, and ordered that the balance of \$540.18 due ?loan? be carried to new account.
