Does anyone have any information whether Hans Jerg Rominger, the father of Michael, David, and Philip Rominger who initially settled in Broad Bay, came to America or not. I know his wife, Elisabeta Odelin did not come to America because a church record in Germany shows that she died in Singen on 17 February 1741. Publications by OBBFHA members

A new book was published in July that should interest every student of Waldoboro history. The book is entitled, *Major Philip Ulmer, A Hero of the American Revolution*. It was written by Ms. Patricia Hubert of Connecticut, who is a descendant of the Ulmer Family. Ms. Hubert's book tells the life story of Philip Ulmer and his brother George Ulmer, highlighting their long and heroic service in the American Revolution. I am in the process of obtaining a copy of the book and I will review it for all of you in the next issue of the newsletter.

Speaking of books and writers, I would like to take a moment to highlight some of the authors we have within our membership. Ms. Jean Lawrence, a long time resident of Waldoboro and President of the Waldoboro Historical Society, recently had a story published in the *Mayflower Quarterly* about a barrel that

stands in the vestibule of the Old German Church in Waldoboro. The barrel was part of the cargo transported on the ship Mayflower. The barrel was property of George Soule and was donated to the church by his descendants from Waldoboro. Jean has also authored numerous articles and five books on Waldoboro history. Recently, she authored a short story of historical fiction entitled *Sedony's Story* which won a local fiction award and was published in *The Goose River Anthology*.

Mark Biscoe, another of our members, has authored numerous articles and several books on the history of shiplbuilding in the midcoast area of Maine. Mark has also written a two volume work entitled *Merchants of the Medomak* which explores the history of shipbuilding in Waldoboro.

Anette Ruppel Rodriguez, a German language translator and faculty member at the University of Maine has done extensive research into the German soldiers that were stationed at Fort George in Castine during the American Revolution. She has lectured and published numerous articles on the Hessians in Maine and has translated into english, a play written in 1783 by a German soldier formerly stationed in Castine. Anette has also written a piece of historical fiction entitled *Margaretha* which was published in a book of short stories entitled *A Quiet Blue Wheel*.

Ms. Helen Shaw, editor of our newsletter, and current President of the Maine Genealogical Society, is a certified genealogist who has authored a book and numerous articles for genealogical publications. Helen's book in entitled, *The Family and Descendants of George Hall and Elizabeth Knight*. Helen has also authored numerous articles for such genealogical publications as *Heritage Quest, The New England Historic Genealogical Register*, and the *National Genealogical Society News Magazine*. Helen has also been an activist working to revise the public records law and the cemetery laws in Maine.

As you can see, when you joined the OBBFHA, you joined some very talented and passionate people. I want to encourage all of you to submit to our newsletter any pieces you may have written about the history and genealogy of Waldoboro and the area of Midcoast Maine. Genealogists' Declaration of Rights — We Need Your Support!

The Genealogists' Declaration of Rights is a statement advocating open access to federal, state, and local public records. The Declaration affirms America's long history of open public records, which has been threatened the last few years over concerns about identity theft and privacy. The Declaration of Rights has been approved by the board of directors of the three sponsoring organizations of the Records Preservation and Access Committee (RPAC): The National Genealogical Society (NGS), the Federation of Genealogical Societies (FGS), and the International Association of Jewish Genealogical Societies (IAJGS). RPAC has worked with state and federal legislators as well as local public officials for more than twenty years in support of legislation and regulations that achieve a balance between access and privacy. The

Declaration of Rights is a document RPAC plans to use in response to both state and federal legislation that would restrict access to public records. The Declaration will be presented to the appropriate legislative committee chairs or Executive Branch of government together with a specific statement about RPAC's position on a proposed law or regulation.

The Declaration is available for online signature at http://bit.ly/gen-declaration. As of 4 November 2014, over 4,000 signatures have been obtained. We need 10,000 signatures by the end of 2014 before the next state and federal legislative sessions begin! We Need YOU to sign the Genealogists' Declaration of Rights!

Genealogists' Declaration of Rights: Records Preservation and Access Committee; 27 April 2014

WHEREAS, Americans have pursued the research of their family heritage since the beginning of our country; and

WHEREAS, millions of Americans derive enjoyment from genealogical exploration, consistent with the pursuit of happiness recognized by the founders of our country in our Declaration of Independence; and

WHEREAS, Americans derive substantial emotional benefit from genealogical exploration into their heritage; and

WHEREAS, many Americans derive financial benefit from the practice of professional genealogy and have performed such throughout this nation's history; and

WHEREAS, genealogists make meaningful contributions to the fields of forensic genealogy, identification of kinships, determining the facts in legal cases such as probate court, cases involving tribal and other relationships; and

WHEREAS, thousands of genealogical and historical societies, libraries, museums, and other institutions and associations have been established throughout our land to assist all Americans in the pursuit of their family heritage; and

WHEREAS, genealogy adds substantially to the ethnic, cultural, and racial richness of which our country is composed; and

WHEREAS, the American people have recognized that the right to open government and unfettered access to the records of our government are rights which find expression in the constitutions and legislation of our federal and state governments and which enrich the lives of all Americans; and

WHEREAS, genealogists have been at the forefront of efforts to protect and preserve the precious records and documents of our genealogical and historical heritage; and

WHEREAS, genealogists, no less than other Americans, are vitally concerned for personal privacy and safety from untoward acts that diminish our freedom; and

WHEREAS, most records, including vital records, have, for all of our nation's history, been substantially open to access,

NOW THEREFORE, BE IT KNOWN

That we, the undersigned genealogists, in pursuance of our individual and collective rights as Americans, do hereby

DECLARE

That genealogists possess the right to the pursuit of genealogical exploration through unfettered access to the records of our government; and

WE CALL upon our governmental representatives to recognize our rights by:

PRESERVING the freedom of the American people to access the public records of our government in a timely and orderly manner through appropriate legislation; and

REFRAINING from legislation which would prevent or render extraordinarily difficult access to the public records, principally birth, marriage, and death records collected by our state and federal governmental agencies; and

PROMOTING those principles that enhance, not diminish, our freedom of access to records; and

CELEBRATING with genealogists the valuable benefits of exploring, researching, and compiling the histories of our families, and as a result, the history of our exceptional nation.
