# Broad Bay research material on Familysearch.org

In an e-mail dated 7 February 2015 Wilford Whitaker reported that he had given all the research notes used to compile *Broad Bay Pioneers* to the Family History Library in Salt Lake City. The material filled eight boxes, each weighing about 60 pounds. The material was digitized and resulted in eleven discs containing a total of almost 20,000 pages of material.

The material has been posted to FamilySearch.org and some of it can be accessed via your home computer. Some may be accessed via a computer at a family history library or other library which has an agreement for the FHL in Salt Lake (Exp: the Camden Public Library). To access material from your computer you should first set up an account with FamilySearch.org – this is free and helps you access & download files.

Broad Bay material which can be accessed from your home computer:

- (1) Broad Bay descendants' correspondence: letters, research, documents -1990-2000: relating to the history of Broad Bay (Waldoboro), Maine: the German colony of Broad Bay settled by Samuel Waldo, gent. 1742-1753
- (2) Hyler-Heiler families : of Switzerland to Germany and voyage from Germany to Broad Bay, Maine 1742

Material which, apparently, can only be accessed via computers at a family history library:

- (1) Broad Bay, (Waldoboro, Maine): historical research documents: German parish research by Gary Horlacher
- (2) Old Broad Bay German settlers: on the West side of the Medomak River

The following is listed in the FHL catalog as digitized, but there is no link to access it:

(1) Broad Bay (Waldoboro, Maine) historical research and documents

The following are not digitized, but may be available on loan to a local family history library:

- (1) Broad Bay, (Waldoboro, Maine): historical research and documents: births and deaths
- (2) Broad Bay pioneers: 18th century German-speaking settlers of present-day Waldoboro, Maine

To access the digitized files log into FamilySearch.org, then go to

SEARCH, then go to

CATALOG, then click on

AUTHOR, and type in Whitaker, Wilford. This will bring up two choices, click on WHITAKER, WILFORD, 1934

You can then chose the file you want to access.

#### **Book review**

Major Philip M. Ulmer: A Hero of the American Revolution by Patricia Hubert, History Press, 2014.

Patricia Hubert has studied her 18th Century ancestor Philip Ulmer, who started his life in the eastern frontier German settlement of Broad Bay, now known as Waldoboro. He was born in 1751 in this poor struggling settlement which had only been settled for a few years. The author traces Ulmer's life and his service in our War for Independence to Ulmer's death in the Village of Ducktrap (today's Lincolnville) in 1816.

Philip Ulmer enlisted in the rebel forces in 1775, fought in the battle of Bunker Hill, and continued to take part in many of the engagements from Lake Champlain to Trenton, Princeton and Saratoga. After the war, Ulmer and his brother, who became a land agent for Henry Knox, became very successful merchants in the new settlement of Ducktrap. As Knox's fortunes declined at the turn of the new century, so did the Ulmer brother's spiral downward, and Philip died in poverty in 1816. His remains were buried on a point of land in Ducktrap where his marker stone remains today.

## Three new cemetery bills before the legislature

The ad hoc committee to review cemetery laws prepared three revisions of current cemetery law for the 2014-2015 legislative session. Senator Andre Cushing sponsored two bills: LD 862, "An Act to Clarify Who May Authorize Repairs in a Burying Ground," and LD 862, "An Act to Clarify the Ownership of an Access to Ancient and Family Burying Grounds." Senator Thomas Saviello sponsored LD 1071, "An Act to Increase the Penalties for Vandalizing a Cemetery."

LD 1071 had its public hearing on April 15 before the Committee on Criminal Justice and Public Safety. While committee members agreed cemetery vandalism was unacceptable, several were concerned about stigmatizing juveniles (the most frequent cemetery vandal) with a felony. Attorney groups objected to the creation of another felony, saying cemetery vandalism could be prosecuted under other laws. It was pointed out by bill supporters that law enforcement personnel are reluctant to even try to track down cemetery vandals (it's a misdemeanor, why bother!), attorneys refuse to prosecute because it is a victimless crime and only a misdemeanor, and judges refuse to require restitution, leaving towns, cemetery owners, and families with thousands of dollars in costs to repair the damage. After a call for a vote of "ought not to pass" (which passed with only 2 no votes) Representative Catherine Nadeau said she wanted to work to amend the bill. The amendments were not accepted by the committee.

Public hearings for LD 862 and LD 1328 were held on April 27 before the Committee on State and Local Government. Due to the perceived complexity of the bills both were tabled when committee members could not agree on amendments following the work sessions on May 13. Subsequently a request was made to carry LD 1328 over to the fall legislative session with a subcommittee to meet with stakeholders over the summer. LD 862 was tabled after a work session on May 20; at this time it is not known if it will be carried over to the fall session. Check the MOCA Facebook page for updates.

## **Cemetery survey results**

As a result of the arduous work done to revise LD 1662 during the 126<sup>th</sup> Legislative Session, an ad hoc group was formed to review all cemetery laws. Members of the committee were from the Maine Genealogical Society, Maine Old Cemetery Association (MOCA), Maine Cemetery Association (MCA), Maine Municipal Association (MMA), and the Maine Department of Veterans Affairs.

At the first committee meeting it was decided to survey municipalities to determine what they know about cemeteries within their boundaries, what was being spent to care for these cemeteries, and what issues were of concern for municipalities in terms of vandalism, land use, and other threats. Kate Dufour of the MMA drafted the survey and it was sent to 492 municipalities on the MMA mailing list. For most municipalities MOCA was able to provide a list of cemeteries within their boundaries based on the MOCA database. Where no such list existed the municipality was given a blank form on which to record known cemeteries.

Three hundred and thirty-two municipalities responded to the survey. A 500+ page report has been drafted and when completed will be posted on the MGS, MOCA, MCA, & MMA web sites. Over 5000 cemeteries were listed with ownership reported as 1,464 municipal, 319 association, 2,452 private, and 825 unknown. Ownership of most of the cemeteries listed as private is in fact unknown.

Several of the issues raised by responders will be answered by the bills submitted this legislative session including vandalism, repairs, ownership, and access. However, the biggest issue for municipalities is the cost of caring for cemeteries and gravestones. There are few granting agencies that fund cemetery repairs and preservation. Many people who volunteer to clean a cemetery are not trained to do so properly and some people who offer repair and cleaning services use methods that can damage older gravestones. These are issues the ad hoc committee will work on during 2015 along with revising LD 1328 and (probably) LD 862 for the fall legislative session. The issue of vandalism will also be revisited.

### Vital records rules update

The final draft of the rules for accessing vital records have been sent to the stakeholders. An Assistant Attorney General is reviewing the document. When she is done a public hearing will held. When that date is known I will post it on the MGS Facebook page and send an e-mail notice to OBBFHA members whose e-mail address I have.

A major change to the rules will be to allow genealogists with a state researcher ID card to have on-line access to the DHHS vital records database prior to ordering a copy of a vital records certificate. Persons applying for a state researcher card must belong to a genealogy society and must sign a genealogist code of conduct which includes the legal penalties for misuse of the DHHS database.
