

# 1836 Mixed-Blood Census Register

Ottawas and Chippewas of Michigan  
Treaty of March 28, 1836

By the treaty of March 28, 1836, the Ottawas and Chippewas of Michigan sold their lands in western lower Michigan north of the Grand River and the eastern half of the upper peninsula. Among the thirteen articles of this treaty, Article Six provided for a payment to mixed-blood relatives of the Ottawas and Chippewas. Article Six states:

**The said Indians being desirous of making provisions for their half-breed relatives, and the President having determined, that individual reservations shall not be granted, it is agreed, that in lieu thereof, the sum of one hundred and fifty thousand dollars shall be set apart as a fund for said half-breeds. No person shall be entitled to any part of said fund, unless he is of Indian descent and actually resident within the boundaries described in the first article of this treaty, nor shall any thing be allowed to any such person, who may have received any allowance at any previous Indian treaty. The following principles, shall regulate the distribution. A census shall be taken of all the men, women, and children, coming within this article. As the Indians hold in higher consideration, some of their half-breeds than others, and as there is much difference in their capacity to use and take care of property, and, consequently, in their power to aid their Indian connexions, which furnishes a strong ground for this claim, it is, therefore, agreed, that at the council to be held upon this subject, the commissioner shall call upon the Indian chiefs to designate, if they require it, three classes of these claimants, the first of which, shall receive one half-more than the second, and the second, double the third. Each man woman and child shall be enumerated, and an equal share, in the respective classes, shall be allowed to each. If the father is living with the family, he shall receive the shares of himself, his wife and children. If the father is dead, or separated from the family, and the mother is living with the family, she shall have her own share, and that of the children. If the father and mother are neither living with the family, or if the children are orphans, their share shall be retained till they are twenty-one years of age; provided that such portions of it as may be necessary may, under the direction of the President, be from time to time applied for their support. All other persons at the age of twenty-one years, shall receive their shares agreeably to the proper class. Out of the said fund of one hundred and fifty thousand dollars, the sum of five thousand dollars shall be reserved to be applied, under the direction of the President, to the support of such of the poor half breeds, as may require assistance, to be expended in annual instalments for the term of ten years, commencing with the second year. Such of the half-breeds, as may be judged incapable of making a proper use of the money, allowed them by the commissioner, shall receive the same in instalments, as the President may direct.**

A special commissioner, John W. Edmonds, was appointed by the Office of Indian Affairs in Washington to examine these claims and compile a census register of all persons submitting claims under this Article.

The letter of instructions to Edmonds, his report to the Commissioner of Indian Affairs, and his census register are reproduced in this document. Names in this document can be searched by using the Find Command in Adobe Acrobat Reader. The originals of the Census Register and Edmonds' report can be found in the National Archives microfilm series *M574, Special Files of the Office of Indian Affairs 1807-1904, Roll 23, Frames 584-729*. There are other documents on this roll relating to this census register which are not reproduced here. These include further reports on Edmonds' decision to accept or reject certain claims and letters of complaint by individuals whose claims were rejected.

This is the first in a series of electronic documents relating to the history of the Indians in the Great Lakes region which I am in the process of compiling. Planned future volumes include Durant's 1907 Ottawa and Chippewa census roll; a compilation of documents relating to the various Great Lakes

Indian treaty negotiations; Charles C. Royce's *Indian Land Cessions in the United States*; early Ottawa, Chippewa, and Potawatomi annuity payment rolls; documents relating to Indian allotment land fraud in Michigan; reports of the Mackinac Indian agents to the commissioner of Indian affairs; Grand River Ottawa history and others.

Comments, corrections, suggestions and donation of documents are always welcome. This document is being offered at no charge, and all documents in this file are in the public domain so feel free to pass this file along to your friends. Some future electronic publications may have a modest charge associated with them to help offset the hundreds of hours I've spent in transcribing hundreds of hand-written documents from microfilm to electronic format. Also, let me know if there is any interest in the above mentioned documents so that I can prioritize their publication.

Instructions to John W. Edmonds from the  
Commissioner of Indian Affairs  
July 8th, 1836

Sir,

A commission appointing you to investigate the half breed claims under the treaty with the Ottawa and Chippewa tribes of Indians of March 11 [28], 1836 has been transmitted to you by the Secretary of War. I now proceed, agreeably to the intimation you have received, to prescribe such instructions for the regulation of your duty as appear to be necessary.

In the 6th article of the above mentioned treaty, a copy of which is herewith enclosed, you will find a general description of the trust reposed in you. Mr. Schoolcraft the Indian Agent at Michilimackinac has been advised of your appointment and he has been requested to correspond with you and to inform you of the time when the Indians will probably be convened and when it will be necessary for you to reach Michilimackinac. An important change proposed by the Senate to the treaty renders it necessary to procure the assent of the Indians before definitive arrangements are made for its execution. Mr. Schoolcraft has summoned the Indians to meet on the 10th July for the purpose of procuring their assent, if this is withheld all further proceedings will stop. If however it is given, then the necessary arrangements will go on, and I presume the Indians will meet about the beginning of September for the purpose of adjusting their half breed claims and of receiving the payments which will be made agreeably to the treaty. Mr. Schoolcraft will communicate to you the result and also the day that may be fixed upon.

When you proceed to the execution of your duty, you will let it be known that the claims of all persons either through themselves or others will be received. After you have made a census register of the men, women & children, who come within the provisions of the 6th article, you will lay the same in open council before all the Indians and you will call upon them for their statements respecting the claims of each person named in the list. It is presumable that in most of the cases there will be little doubt or contrariety of opinion on the subject of the claims, and it may be taken for granted, that when all present assent to the claim of a person to be a half breed that such claim is well founded.

Besides the Indians however, the Agent will be present who is well acquainted with them and also many traders and other persons who have longed lived in that region. Their statements will also be received in all doubtful cases and more particularly should you have reason to believe that any person has acquired such an undue influence over the Indians, as to induce them to admit an improper claim. In this branch of your duty and indeed in every other I recommend to you to council freely with the Agent whose advice from his knowledge of the people of the country will be very useful to you. You must likewise satisfy yourself that the several claimants were resident within the country ceded at the ratification of the treaty. On this point as well as upon the other you will receive the statement of the Indians made in open council. And you may also call for any other proof you may think proper. And you will form your judgement upon the circumstances of each case as they may appear to you.

The census register will show the names, the ages, as near as may be, and the places of residence. In all those cases where after an annunciation to the Indians in open council, the same is fully admitted

by them and no doubt is thrown upon the subject by any other person, you will mark them as admitted in open council. When they are denied in open council and no sufficient proof is addressed to you, that the claims are correct, you will mark them as rejected in open council. Where doubts may exist and you proceed to an investigation you will in those cases give a short summary of the facts upon which they are admitted or rejected, and you will state upon your register admitted or rejected upon examination.

Mr. Schoolcraft has a volume, containing the previous treaties with these Indians and their kindred bands, by examining which, and availing yourself of his personal knowledge of the Indians, you will be able to ascertain who have received allowances, and are consequently excluded from a participation in the benefits of this treaty.

The general principles laid down in the 6th Article seem to be sufficient to guide you in the distribution. You will cause the whole matter to be clearly explained to the Indians and you will ascertain in the first instance whether they desire a division of the claimants into classes. If they do you will then call upon them to designate the class in which each individual whose claim is admitted shall be placed. After this is done the division will be made as required by the treaty. Provision, as you will find, is made in the treaty respecting the mode of payment of the shares of married women, children, orphans etc. These you will carry into effect. You will designate upon the register the wives and children of persons who are entitled to their shares. The sums due to orphans will not be distributed, but will be returned by the officer, in whose hands the money is placed, to the Treasury, for subsequent distribution agreeably to the treaty. You are at liberty however, with the cooperation of the Agent to authorize a small sum to be expended in the purchase of necessary articles for such of these orphans as require it. A special return will be made of these cases. You will observe that the whole sum allowed for these claims in one hundred and forty five thousand dollars, the sum of five thousand dollars being deducted from the amount of one hundred and fifty thousand dollars, to be applied to the support of the poor half breeds.

You will enquire into the condition and capacity of each of these half breeds to manage their own affairs, and if you think that the payment of the whole sum to them at this time will not be useful you are authorized to allow an instalment upon it amounting from one fifth to one tenth part at your discretion, taking into view the circumstances of the claim.

The census register will be so made, as to show your action upon each claim, from its presentation to its admission and payment, or its rejection.

You will give all necessary directions upon the register, as before explained, and will authorize, the officer in whose hands the funds may be placed to make the respective payments. Arrangements will be made for the attendance at Michilimackinac of a disbursing officer for this purpose. The receipt of the claimants upon this register will be his voucher. You will furnish him with two of them and a third you will transmit to this office.

You will be allowed Eight dollars a day for every day actually engaged in this business and Eight dollars for every twenty miles of travel going to and returning from Michilimackinac. The account to be settled upon your certificate of honor. The appropriation for the pay and travelling expenses of the Commissioner is one thousand dollars; that for the compensation and expenses of a clerk, stationery, postage, witnesses, messengers to collect Indians, and canoes for them, subsistence for two thousand

Indians for twenty days, fuel for them while on the island and other incidental expenses, attending the commission is Three thousand dollars and these amounts must not be exceeded.

It has been supposed here that but one council would be called for the examination of these claims, the payment of the annuities, the distribution of goods and other objects, and the sum of Three thousand dollars was intended to cover the expenses of it. But should separate councils be necessary, you will arrange with Mr. Schoolcraft the proper sums to allotted for each.

The Disbursing officer will be instructed to pay this sum of three thousand dollars upon your requisitions, or those of the Indian Agent, which will be attached to the several accounts duly receipted and attested. Mr. Schoolcraft will furnish you with the proper forms.

You are authorized to employ a clerk at Michilimackinac to aid you should you find it necessary, allowing a reasonable compensation therefor. This however will not exceed Two hundred dollars.

John W. Edmonds' Report to  
The Commissioner of Indian Affairs  
February 9, 1836

Sir

In obedience to my appointment and your instructions to me of the eighth July last as Commissioner under the 6<sup>th</sup> article of the Treaty with the Ottawa and Chippewa nations of Indians made at Washington on the 31<sup>st</sup> March 1836. I proceeded to the Island of Mackinac where I arrived on the 26<sup>th</sup> day of August last.

On my arrival, I found that the Indian Agent had prepared a list of those who were claimants under this Article of the treaty. Altho' that list was of great assistance to me, in the discharge of my duties, yet I found it necessary to examine each claim as it was presented, in many cases to take testimony, to examine the parties and others and personally to visit the families of many of them. The result of my examination will appear, by the Census Register, which accompanies this communication, signed by me and the principal Chiefs, who attended the Council. That Register contains the names of the applicants as will those whose claim was rejected as those where it was admitted.

The class in which each was enrolled by me—the Age of each—and their residence at the ultimate ratification of the treaty—the duration of such residence—the degree of relationship to the Indians, whether  $\frac{1}{4}$  or  $\frac{1}{2}$  blood of the Chippewas or Ottawas—my decision in each case—the amount to which each claimant was entitled according to his class, allowing to each an equal share in the respective classes—the person to whom the several amounts were under the provisions of the treaty properly payable and stating the instructions in which the amounts allowed were to be retained in consequence of the Orphanage of the claimant or his desertion by his parents while under 21 years of age—and a column of remarks, showing generally and briefly the grounds on which the claim was either admitted or rejected. Agreeable to your instructions, I prepared 3 copies of this Register, two of which (omitting only the column of Remarks) I delivered to Maj. Whiting, your disbursing agent and the other is herewith annexed.

One of the first questions which occurred for my decision, was as to the precise meaning of the words "half-breed relatives". Strictly they might properly be so construed as to include only those one of whose parents was a pure blooded Indian, or in other words only those who were half blood Indians. But I found that this acceptation of the terms would be too contracted for the sense in which the Indians, their relatives and all who were in habits of intercourse with them universally used the term. According to this usage, it included those who were akin to the Indians and who had descended in part from white ancestry. This would include all who had any—even the slightest portion of Indian blood in them, or who could trace even a distant relationship to these Indians. This was discerned to be too general an acceptation of the terms and would bestow the bounty of the Indians, upon many who had either denied or been ignorant of their relationship, until this bounty had induced them to disclose or hunt up their Indian descent and of course upon many whose relationship had not been sufficiently known or recognized to warrant the Indians in asking of them that aid which in the language of the Treaty "furnishes a strong ground for this claim". Some restriction therefore became necessary and I adopted that which the Indians would most easily understand & most readily recognize and which was most consonant to their habits and customs—I admitted only those, one of whose parents or Grand parents was of pure Indian blood.

In making this decision, I had in view that these half breeds were in no respect owners of the land ceded and of course had no claim of rights to any part of the purchase money—and that the Indians

in setting apart for them, a portion of the price of their domain, had intended it as a donation to those, whose relationship to them was so well known, that in their necessity, they could ask for and receive aid. Such was the meaning of the Indians & such my understanding of the spirit of the Treaty. It is the power of the half breeds to aid their Indian connexions which furnishes the strong ground for this or any allowance to them.

I found two kinds of half-breeds. One kind had adopted the habits, manners & customs of the white people and spoke either the French or English language, tho' many of them had learned the Indian language. The other kind had adopted the manners, habits and customs of the Savages, lived with them and as they did, were completely identified with them and were recognized fully as Indians. I understood that the provisions of the 6<sup>th</sup> Article were intended for the former kind only and that the latter kind were excluded by the spirit of this article and by the considerations that they were included in the census of the Indians and received pay as such. It was not deemed equitable, that any one should receive both as an Indian and an half-breed.

I endeavoured to confine the allowances under this article to actual residents within the boundaries described in the first article of the treaty. By doing so, I should have excluded the greater part of the relatives of the Ottawas. They reside on the south side of the Grand River and were prohibited by the laws of the U. States from living within those boundaries, yet resided so near the line, that they had for years been aiding their Indian connexions and furnishing a strong ground for their claims—against such a course the Ottawas of Grand River remonstrated. I should also have excluded several who had for years resided in the ceded territory but who had been temporarily absent or had removed just without the lines, but were so situated that they would be frequently called upon and compelled to aid their Indian connexions, as much as if they should continue to reside within the boundaries. Against such a course, the Chiefs of the Ottawas & Chippewas in the case of Wm. Mitchell and the Chiefs of the Chippewas, in the case of Mrs. McMurray remonstrated not only in open council, but by written communication to me. And the Indian Agent, who negociated the treaty, with the Indians assured me, in an official communication, that in his opinion, “my favourable action” on one of the cases, mentioned, “would not contravene the spirit of the treaty, while it would have a tendency to preserve the good understanding now existing with the bands.”

The treaty was not definite as to the times when the claimants were to be residents within the ceded district. It did not say whether such residence should be at the date of the treaty, in March at its ratification by the Senate, in May or at the final ratification by the Indians, in July. Taking all these things into consideration and feeling that the allowance under the 6<sup>th</sup> Article was a donation by the Indians, which they had the best right to control, I yielded to their requests and admitted the cases, in whose behalf they spoke and all others to whom the principles, which they had there established, would properly apply. I am well persuaded that no injury has been done by this procedure. It satisfied the Indians and enabled them to bestow their bounty upon those to whom they were most warmly attached and who had “furnished the strongest ground for this claim.”

The Register accompanying this, is not only a census of all the men women and children coming within the 6<sup>th</sup> article of the treaty as therein required, but also of all who claimed to come within it.

Classifying the Claimants I was satisfied, was not only proper in itself, but was desired by the Indians. And the reason, for the classification, mentioned in the treaty, was unquestionably intended as its basis. Those who were “held in highest consideration by the Indians”, who had “the greatest capacity to use and take care of property and consequently the most power to aid their Indian connexions” were to constitute the first Class—those less so the second Class, those least so, the third Class. I could not discover in the treaty any other basis or reason for the classification. Having this in view, as the different claimants presented themselves, I made a memorandum of the class to which, from

their appearance and the testimony, each one would seem to belong. Upon closing the list against any more claims, I found that my memoranda had placed about 25 in the first class, 100 in the 2d and 327 in the 3d. The disproportion was so great, as to induce me to doubt the accuracy of my classification and I then took great pains, by visiting the claimants personally, at their dwellings and by consulting every one, acquainted with the characters of the claimants and whose disinterestedness I had any assurance of to correct any error into which I might have fallen. The result was the classification indicated in the annexed Register. Of one thing I am satisfied; I may have placed some too high, but I have placed no one too low, unless the basis of my classification is wrong. No task could have been more invidious or unpleasant than this classification. I could not find any two persons among those who had known the claimants for years, who could agree in all instances as to the proper classification. The claimants differed just as much among themselves and I became convinced that no classification I could make could give universal satisfaction. I therefore attempted to satisfy only my own conviction of what was just and proper.

In allotting the whole sum to the respective classes I found still greater inequality. By the language of the treaty one half of this whole sum or \$72,500.00 was to be allotted to the first class. Two thirds of the residue or \$48,333.34 to the second class & the balance or \$24,166.67 to the third class. I found that many of those who were present at the execution of the treaty understood this provision otherwise. They supposed that the money was to be so allotted that while one in the third class should receive at the ratio of \$1, one in the second should receive at the rate of \$2, & one in the first should receive at the rate of \$3.00. This impression had been made on their minds by their understanding of what the treaty was to be and not by its language. Such a construction would have been most acceptable to me, but the provisions of the treaty was so clear & explicit that I had no option. The effect was that each one in the 1<sup>st</sup>. Class received \$1812.50; in the 2d. Class \$305.89 & in the 3d. \$95.14. This inequality was very great, and tho' my desire to lessen it was equally so, yet I could not do it, unless I adopted an arbitrary principle of classification in violation of what seemed to me to be the plain meaning of the treaty. And after all, I found that it was not widely different from what had prevailed in other treaties. There in the treaty made at Chicago in 1833, some of the half breeds were allowed a sum as high as \$10,000 while some received only \$100.

The column in the Census Register headed "To whom payable", includes four classes of cases: first, where the father was living with the family, the shares of his wife & children were directed to be paid to him; second, where the father was dead or separated from the family and the mother was living with the family, the shares of herself and children were directed to be paid to her; third, where the claimant was under 21 years of age & was an orphan or had been deserted by his parents or did not live with them his share was directed to be retained; and fourth, where the claimant was judged to be incapable of making a proper use of his money, only a portion of the money allowed him was directed to be paid to him. These directions were required by the provisions of the 6<sup>th</sup> article of the Treaty and your instructions. All other persons of the age of 21 years were permitted to receive their shares.

There were 44 cases of orphanage, where the money was directed to be retained. This amounts to \$6293.66. This sum together with the \$5000 set apart for indigent half breeds is, I suppose the excess under the 6<sup>th</sup> article, which is, in the supplemental article, directed to be vested in stock under the conditions mentioned in the 4<sup>th</sup> Article. Some of the shares of the orphans must, under the provisions of the treaty, be retained by government 17 years. If it is practicable, I would recommend that in all these cases, the money should be paid to Guardians properly appointed under the laws of Michigan, to be expended for their education. They will thus derive the greatest benefit from their allowances—be made by its means more valuable citizens and much will be done to reclaim them from the sired habits of the Indians to which they are now very much inclined.

I did not find any case, in which I thought it either safe or necessary to direct any portion of their allowances to be applied to their present support.

I annex hereto, copies of the communications from the Chiefs, of the Agents letter and of the speech of the Chiefs in council in reference to the admission of Wm. Mitchell & Mrs. McMurray and their children among the half breed claimants.
