Page 2:1 - FERRYMAN DROWNED - Mr. Joseph BRUNT who has for sometime past been employed by Mr. WISWALL as a ferryman at the Upper Ferry, was drowned on the 3d inst. It appeared from the evidence, that he was seen to fall from a raft Dying near the ferryboat which had just been launched, and it is supposed in attempting to get on to it, his feet slipped and he fell into the water, and, although he was said to be a good swimmer, (the reasons why attempts were not immediately made to rescue him) it was soon seen that he was struggling and two men started with a small boat, the distance of only five or six rods, but before they reached him he sunk to rise no more; and the Coroner's Jury gave a verdict of accidental drowning.

We learn Mr. B. was about 21, the oldest of several children of Mr. BRUNT, an Englishman residing in Lansingburgh; & Mr. WISWALL, with whom he had lived several months, we learn that he was an industrious, trust worthy, respectable young man and bid fair to become a useful member of society.

Page 2:4 - NASSAU MURDER - We have already announced (says the Evening Journal) the arrest of a young Irishmen by the name of Barney O'DONNELL charged with the murder of an Italian by the name of Antonio RATTO, in the Town of Nassau in June last. He was arrested in Philadelphia by an Italian named GNECCO who had rented a hand organ to the deceased and which he found in possession of the accused. O'DONNELL was brought to Nassau on a requisition from the Governor, and his examination has been going on before N.N. SEAMAN Esq., Coroner, for nearly a week. It was closed on Saturday and O'DONNELL committed to the jail of the County to wait a further examination. (A correspondent says the prisioner is young and about 19 years of age, sprightly and active. During the examination he seemed as unconcerned as any ofthe spectators. The prisioner and RATTO were proved to have been together on Monday forenoon the same day onwhich the murder was committed and the prisioner was seen in the woods in which RATTO was found dead about 2 P.M. and then again in Albany, on the evening of the same day, with the organ, at the Irish boardinghouse on South Broadway. The next testimony we have of him was in Philadelphia, where he was seized by GNECCO - There is no doubt as to GNECCO's being the owner of the organ; for although, he is an Italian, not understanding much of the English language, he gave a very
