Page 2:1 - OUTRAGEOUS ASSAULT - The Troy Times says that as two gentlemen named POTTER & GUNSALUS, residents of the Village, were riding through Cohoes, Saturday afternoon they were stopped by some Irishmen, and a white hat, which one of them wore, was taken from his head and trodden upon by the Irishmen, remarking at the same time that they supposed he was a "d_ _ d know nothing" - Some if not the entire party were arrested, and committed by Squire PHELPS for examination Monday. The assaulting party is supposed to be from Waterford.

Page 2:4 - A STRANGE AFFAIR - Mrs. Mary L. SHAW, wife of Sidney SHAW, of Columbiaville, Columbia Co., committed suicide last week by taking arsenic. She was but 16 years of age, and leaves a babe seven months old. She is said to have been a woman of rare personal beauty, and superior intelligence. No apparant cause could be assigned for the commission of the rash deed. Her husband is represented to be a temperate, industrious man.

JULY 5, 1854

Page 2:5 - DIED - In Troy on the morning of the 2d inst., of consumption, Theodore G. BUCKLIN in the 30th year of his age.

- In Milwaukee, WIS of consumption, on the 22d ult, age 31 years, Mary wife of Henry L. PALMER & daughter of Horace LOVELAND of this Village.

JULY 12, 1854

Page 2:1 - A man named Oscar CHAPMAN was killed by a powder explosion in the powder factory of Messrs LOOMIS, MASTERS & SWIFT in Schaghticoke on Saturday.

- FIRE AT COHOES & LOSS OF LIFE - The cotton mill known as the Strong Mill, in Cohoes, caught fire about 8 o'clock on Saturday morning, and the two upper stories, together with the stock, machinery &c, were totally destroyed. The fire caught from a spark which ignited some loose cotton. The loss is about \$50,000, partly covered by insurance. Shortly after the fire the south wall of the building fell in, injuring several persons, and killing a lad named John W. BAIRD, a resident of that vicinity. Cor. WITBECK held an inquest upon his body, and the jury returned a verdict in accordance with the above facts.

- Coroner WITBECK held an inquest at Cohoes, on the 7th inst. upon the body of Mary KEEFE, who committed suicide by taking corrosive sublimate. It is stated that she committed the awful deed on account of a disturbance which originated in her marriage but a day or two previous; - friends being opposed to the man to whom she was married, The jury rendered the following verdict - Mary KEEFE, formerly Mary DAVIS, came to her death by voluntarily taking a large quantity of corrosive sublimate, administered by herself on the 5th of July which produced death on the 6th of same month.
