Page 2:2 - DEATH OF HON. ABBOTT LAWRENCE - The death of the Hon. Abbott LAWRENCE occurred at Boston on Saturday morning. Mr. L. for many years occupied a most prominent position in Mass. & New England as a merchant, manufacturer, politician. Few man have succeeded better in any capacity. While as a businessman, his sagicity enabled him to rise from poverty to the position of an enormous wealth, his shrewdness and ability as a politician gave him a seat in Congress as long as he would consent to occupy it and afterwards clothed him with the responsibility & dignity of the position of Ambassador at the Court of St. James. Since the days of HANCOCK there has not occurred a more notable instance of eminent success. in the double pursuit of political distinction and wealth.
