Page 2:5 - MARRIED - At Newark, N.J. Thursday September 27th by Rev. Rutgers VAN BRUNT, Mr. Abram L. LANSING of Watervliet to Miss Sarah J., daughter of Ephraim T. TUCKER of Newark.

Page 2:5 - On the 25th ult by Rev. H.W. RANSOM, Mr. J.E. METCALF, formerly of this Village & Miss Julia A. FERRIS of Fort Edward.

OCTOBER 10, 1860

Page 2:2 - INQUEST - Coroner WITBECK held an inquest on Monday upon the body of Peter CONNORS, a man of about 60 years of age, residing in this Village who was drowned in Lock 3 - Erie Canal, Sunday night. A verdict of accidental drowning was rendered.

Page 2:5 - MARRIED - On the 2d inst by Rev. Dr. GREGORY, Mr. Warren S. BONCE to Miss Eliza ALSTON, both of this Village.

OCTOBER 17, 1860

Page 2:4 - DROWNED - The body of Nicholas KANE of Cohoes, was found on Saturday last in Lock 10, Erie Canal. KANE had been missing from home for several days. Coroner WITBECK held an inquest, the jury returning a verdict of accidental drowning.

OCTOBER 21, 1860

Page 2:5 - MARRIED - On Sunday 21st inst. by Rev. George W. HATHAWAY, Mr. John MARCELLINE of London, Canada West & Matilda BURNS of this Village.

DIED - In this Village on Sunday the 21st inst Jessie, daughter of James & Caroline S. ROY, aged 7 years.

NOVEMBER 7, 1860

Page 2:1 - INQUEST - Coroner WITBECK held an inquest on Friday morning upon the body of Margaret SNODDEN, who was found dead at her residence in Temperance Hill. A post-mortem examination was made in the presence of the jury, and a verdict rendered of "death from congestion of the lungs, super induced by intemperance."

Page 2:4 - DEATH FROM LOCK JAW - On the night of the 25th ult, a row took place at the saloon of John WALL, on the corner of Union & Water Sts. in this Village. During the melee, WALL drew a pistol; whereupon Edward CLARY, who had been a looker-on, rushed upon WALL and bore the pistol down, at which time the pistol was discharged, inflicting a slight flesh wound CLARY's hand which was thought but little of at the time. Dr. WITBECK dressed the hand that night, and CLARY attended to his business as usual until Friday, when his hand became sore, his arm inflamed and Tuesday morning he died with the lock jaw. Coroner WITBECK took his dying deposition which exonerates WALL from all blame..
