Page 2:3 - PERJURY - Mrs. Lucy WIL<sup>K</sup>INSON the woman upon whose oath Jefferson W. BENNETT was arrested for the murder of Robert MORRISON - the particulars of which case our readers are already familiar with - was arrested on Wednesday last charged with perjury. She is now undergoing an examination on the charge before Justice COLE at Albany.

Page 2:5 - John McCOUN an old and esteemed citizen of Troy, died at his residence in that City on Sunday last.

Page 2:6 - MARRIED - In Cohoes April 23d by Rev. L. POTTER, Mr. George EMERY of Albany & Miss Lizzie H., daughter of Rev. E. STOVER of the former place.

DIED - In this Village on Thursday April 25th John HASWELL in the 80th year of his age.

Page 2:2 - MURDER AT RENSSELAERVILLE - Joshua ALEY, a well-known resident and tavern keeper of Rensselaerville, in this County was arrested on Saturday charged with procuring an abortion on the person of Antoinette CONVERS which resulted in her death. The evidence taken before the Coroner's jury showed that a mixture of oil of tansey and oil of cloves was administered. The deceased was about 30 years of age, and had formerly been employed as a seamstress in the house of ALEY. The verdict of the jury was in accordance with those facts. Immediately upon rendition of the verdict, ALEY was arrested by Coroner LEDERER and conveyed to jail in Albany. ALEY has heretofore been under arrest for a charge of somewhat similar character to this. The affair has created an intense excitement at Rensselaerville.

Page 2:3 - DROWNED - Bartholomew FOLEY Lock tender at Lock No. 16 Erie Canal Cohoes, was drowned Monday night about 11 o'clock. It is supposed that he attempted to cross the Lock on the south side and fell into the Canal below. Parties in buildings near heard cries for help, but were unable to ascertain from whence they proceeded in time to effect a rescue. The water in the levels between Locks 15 & 16 was drawn off yesterday morning and the body found. Coroner WITBECK held an inquest, the jury returning a verdict of accidental drowning.

Page 2:3 - DROWNED - The body of James HENDERSON of Cohoes, who we announced as being missing from his home last week, was found in Basin A near the Strong Mill. Coroner WITBECK held an inquest and the jury returned a verdict of accidental drowning. HENDERSON leaves a wife and five children.
