Use of Steamboats in the Battle of New Orleans

of The use Steamboat became commercially feasible in 1807 when the Claremont built by Robert Futon began regular freight and passenger service between New York and Albany. company was also granted several routes in the Southeast as well. Meanwhile entrepreneurs built flat-bottomed boats with steam-driven paddlewheels to operate on the Ohio and upper Mississippi. One of these boats, the Enterprise, in response to the needs of Jackson's troops in New Orleans, loaded 67 tons of war material to take from Louisville to New Orleans. made the trip in two weeks and arrived 9 January one day after the battle at Chalmette. Badly damaged and having lost its two leading generals the British retired behind ramparts to reorganize.

Jackson ordered the boat unloaded and having heard of supply keelboats at Natchez, sent the Enterprise to tow them to New Orleans.

When the Enterprise arrived from Natchez, it was loaded and sent to take supplies to Fort St. Phillip at the mouth of the Mississippi. The fort had been under cannonade from January 9-18 but it stood. When the supplies arrived, the fort personnel were able to return fire causing the British to leave. The Enterprise returned to New Orleans where it was fitted with cotton bales and cannon and became a mobile platform to harass the British army.
