
Why on earth would I want to go to Salt Lake City for research?

Have you ever met a person who was not the least bit interested in genealogy? I can only re-member one. Of course interest levels vary. Younger people usually feel it is something they can do later in life.

How can we best showcase genealogy and encourage people to experience the joy of research-ing their families?

Some things I do:

- 1. Share short family stories (two to three minutes) from my research.
- 2. Give a CCGS business card and invite them to the library.
- 3. Do research on their family and present it to them. It shows how easily the work can be done and it generally sparks their interest.

TO THOSE WHO HAVE SUBMITTED ACCOUNTS OF THEIR EXPERIENCES IN SALT LAKE CITY

Your accounts have not vanished into a black hole – they are in our publishing queue. We value them, but we can only use them as space is available. This is true also of other submitted material. We would like, in fact, to receive more such material so that we have a selection to choose from when we have a bit (or a lot) of space to fill. And we know our readers like to hear from their fellow CCGS members

I have been looking for information on family members in Ohio. I saved a costly airline trip by using the Internet. From Cindy's List I searched for public libraries in Youngstown, OH. The library's web page directs you to genealogy research policy. Listed on their web page are the sources they will check, such as obituaries or birth announcements for specific dates (5 days from info), city directories and much more. You can ask for information by email, with a maximum of 5 questions per request.

The library charges \$5.00 per request plus 10 cents for each page copied. This was such a great find! I sent for and received 3 obituary notices from the newspaper and 3 copies of city directory pages, all for under \$6.00. It is so amazing to me that you can get so much information, all from the comfort of your own home. I know there is so much more information out there in never-never land just waiting for me to ask the right questions.
