RESEARCH USING GENEALOGY CD'S

One of the outstanding benefits of membership in our society is the access we have to a collection of over 300 genealogical CD's. CD's may be checked out at any meeting for use at home and returned at the next month's meeting.

Approximately half of the CD's run on Family Tree Maker software and 57 can be read with the LDS Family History Resource File Viewer. The collection also includes the digitated New England Historical and Genealogical Register.

Our president, **Patrick Bowers** has developed this collection from donations made by GSNB members and purchases on his part. The CD's checked out are copies of the originals which Patrick keeps in case a disk is damaged or lost. He, also, transports the collection to and from our meetings.

Tonight Patrick will give an overview of the collection, demonstrate searching several of the databases and answer any questions you may have about using the collection.

LETTER FROM CONGRESSMAN WELDON

December 3, 2007

Knowing of our shared interest in banning internet taxes, I wanted to update you on recent action in the U.S. House.

As a cosponsor of H.R. 743, The Permanent Internet Tax Freedom Act, which would permanently prohibit taxes from being levied on Internet access fees, I am very much opposed to Internet taxes. This bill would also prohibit multiple jurisdictions from imposing sales taxes on a single purchase, and would prohibit taxes from being levied on purchases that would not normally be taxed if purchased at a store. It is important that Internet access charges not become like our phone bill that is currently overburdened with additional fees and taxes.

While I believe that this tax prohibition should be permanent, there are some in Washington who disagree. The original House passed version (H.R. 3678) only extended the ban for four years; the Senate passed a seven-year ban. Fortunately we were able to persuade a majority of the House to agree to the Senate's seven-year ban. We passed it with overwhelming support on October 29, 2007. President Bush signed the bill into law on October 31, 2007. Though less than I had hoped for, I voted for the seven year extension, but will continue to advocate for a permanent ban.


STAPLES REWARDS
