# REX WALKER KILLED APR. 3 IN GERMANY

WIFE RESIDING HERE IS NOTI-FIED OF DEATH OF NATIVE CHESTER TOWNSHIP

A message from the war department this morning informed Mrs. Mary Walker, 1127 South Main street, that her husband, Tec/5 Rex R. Walker, 23, had been killed in action April 3 in Germany.

Technician Walker had been overseas since Oct. 1, 1944, with an armored division of the seventh army, serving first in Prance and then in

serving first in Prance and then in Germany. He drove a half-track in the mechanized cavalry.

Before going into service Tec./5
Walker was employed for the Pan Handle Gas Co. at Jackson, Mich. He left Dec. 8, 1942, from Grant county, as his family at the time resided at Fairmount, and was sent first to Camp Chaffee, Ark. then to camps in Tennessee and Kentucky.

The last letter received from Technician Walker was received by his wife Monday. It had been written March 28.

His parents, Mr. and Mrs. Wayne
Walker, and his wife, formerly Miss
Mary Howell, of Pairmount, moved
to Bluffton two years ago. He was

#### More Murder

#### Women and Wine, Game and Deceit, Make the Wealth Small and the Want Great

Another sickening tragedy occurred at Keystone last Sabbath evening about fifteen minutes past three o'clock in which George Shaw was shot through the head by William Walker, trustee of Chester township and postmaster at Keystone. The facts are related to us by a prominent citizen of that place, an eye-witness to the scene. On the fatal day, George Shaw, Henry Bark\_\_\_\_\_ and another gentleman whose name we did not learn, walked to the drug store and sat down on the porch. Presently Harvey Wilson came along in an intoxicated condition and began to abuse Mr. Bark . He soon changed his abuse to George Shaw, calling him all the vile names he could think of. Shaw then pitched into him and knocked Elizabeth Darr, a sister of him down. Wilson, appeared on the scene and began to help her brother by striking Shaw who got on and went off. The two pug\_\_\_\_ met shortly after and Wilson again began to call Shaw vile names. Shaw pulled off his coat and said "boys, I can't stand this." He then knocked Wilson and got on him and commenced to give him a sound beating. Wilson's sister again appeared on the scene and accosted William Walker, one of the bystanders, asking him f he was going to stand by and see her poor brother pounded like that. Walker was standing on the left of the men who were fighting. He stepped around to the right side, drew a revolver and shot Shaw through the head, the ball entering at the base of the skull and embedding itself in the brain. The wounded man expired about an hour after he was shot. Walker, who it is said was so much intoxicated he did not know what he was doing, then backed out of the crowd and left for the woods. He was approached by one

of the men when Walker told him he had better not attempt to take him if he valued his life. He remained in the woods for several hours and although the woods were surrounded and had been traversed through by a number, no one seen him, although he says they passed on all sides of him. He returned home and soon became sober enough to realize what he had done when he voluntarily surrendered to the constable. A preliminary trial was held Monday when Walker waved examination and was brought to Bluffton and placed in jail. Isaac Wilson, Harvey Wilson and Elizabeth Darr were also arrested as necessaries and were released on their procuring bail in the sum of \$500 each for their appearance. Walker's remorse on recount of his rash act seems to grow greater each hour. He is a warm hearted, generous fellow if he would leave liquor alone, and his downfall only dates back a period of about eight months when he began to drink heavily and associate with women of doubtful character although he had a wife and six children at home. Chester township is a Democratic township, yet he, a Republican, was elected by a \_\_\_\_\_\_ majority about a year ago. Walker bought grain for Warin, Studabaker & Co., he was postmaster, had a good business in his country store and had every prospect to become one of the most useful and respectful citizens of Chester township had he left the accursed liquor alone. Now we dread to think of the future in store for him and his faithful wife and innocent children and the widowed wife of Shaw and his children. We trust we may never again be compelled to chronicle so terrible and disgraceful a disaster in our county.

again. About 125 witnesses residing in Chester township will be present much to their disgust as this is their busiest time in the year.

#### William Walker The Great Murder Trial now in Progress



The trial of William Walker for the murder of George Shawe in May, 1884, has been occupying the attention of the present session of court, so far, and is likely to take up the entire term. Last Wednesday the case was called and the prisoner entered a plea of not guilty, as charged in the indictment, and claims that the act was committed under the impulse of the moment when he was not in his right mind.

Wednesday, Thursday and until half past one o'clock Friday was occupied in the selection of a jury. Besides the regular venire of twelve jurymen, a special venire of sixty jurymen were drawn. These were soon exhausted and two more of twenty-five each and one of fifty were drawn before a jury was selected. A. N. Martin then made a preliminary statement of the case to the jury and by an agreement of the attorneys on both sides of the case, court was adjourned until Monday of this week. The object of

adjournment was to allow jurors to go home and arrange for work on their farms during their absence which may be prolonged this week and next. The jury is one of more than ordinary intelligence and has been selected with great care. They are, as far as we know them, men of integrity and will do what they think is right and weigh everything deliberately and carefully before bringing in a verdict.

A.L. Sharp, one of the attorney's for the defense, has kindly furnished us the following interesting facts concerning the jury: There were 10 jurors summoned in the case from which the following jury was chosen. James Earle, Lancaster township; George W. Lehman, Jefferson; Lewis O. Cotton, Union; John T. Ware, Liberty; George Shaft, Lancaster; Josephus Caston, Jefferson; Jeremiah Soule, Union; Lewis Prilliman, Harrison; Jackson N. Cotton, Union; Cornelius Taylor, Jefferson; Levi Osborne, Union; Phillip Motz, Union. Three of the jurymen drawn were witnesses and were discharged as incompetent to sit as Twenty-five were discharged by State peremptory challenge and twenty-five by Defense peremptory. Twenty-five had formed and expressed an opinion while two had no opinion on the subject.

Nearly all day Monday was taken up in the examination of Dr. L.E. Maddox who was an eye witness of the homicide. He gave a graphic description of the fighting and showed how Walker

stepped around the crowd, took aim and fired. That Shawe raised up from the position he was in, in holding Wilson down, fell backward and soon expired. He also said he asked Walker after he was arrested, why he had committed the act and Walker replied that he did not know what he was doing and was very sorry the affair occurred but that it could not be helped now.

The defense asked the court to strike out some evidence that was given on Monday evening and the jury retired from the court room while the attorneys argued the question before Judge Bobo. The motion to strike out the evidence was overruled.

The state expected to close the examination of witnesses Wednesday noon.

No new developments are made up to the time of going to press.
