He explained the process of grave moving and presented a sample of his meticulous records for each body. With the research and records gathered by Don, the Parker Cemetery will have various types of information available to researchers. Don started the project with only a few dollars available to the Association and ended with having 70 new lots available for sale. Don included some interesting stories and allowed time for questions and discussion.

## Minutes of the November Meeting

The Blackford Wells Genealogy Society meeting was opened with Connie Brubaker, President, presiding. There were 14 members present. Minutes of the September 17, 2005, meeting were approved as printed in the Newsletter. The Treasurer's Report was given with a beginning balance on July 13 reported as \$2,042.01. ## **Another One of Those Email Hoaxes**

How many of you have seen a historical account of the 1500's making its email rounds? When I received it, I decided to do a little investigating. I was surprised, though I shouldn't have been, at how prevalent it has become. I typed in "Life in the 1500's" in a Google search and it returned several hundred hits. One of those links led me to a website which explained the truth about this recycled internet account. I am copying the parts that relate to death and burial, as that seemed to fit well with our newsletter. I do encourage you, though, to check out the rest of the facts concerning the article, as well as the page called "Buried Alive." It is all quite fascinating. Below, the sections which are indented are from the original article that is being circulated, and the rest is the revealing of the facts.

## YE OLDEN TIMES

A monthly addition to **your** genealogy society newsletter. Edited & typed by Linda V. Thomas

We continue on with excerpts from the *Greenback Times*, a political paper of 1878. Our final paper this edition will be from a Bluffton Banner from the year 1859.

#### A Statement from the Greenback Nominee for Congress in the Twelfth District.

To the people of the Twelfth Congressional District of the State of Indiana I deem it proper to make the following statement.

I moved to Wells county, Indiana, in 1838, where I have ever since resided, and where I expect to spend the few remaining years I may have to live. I shall always cherish a warm feeling for the people of Wells county for the many favors I have received at their hands in the way of patronage in my store, bank and grain warehouses. What little property I have accumulated in the last 40 years has been made in Wells county, and I say it belongs to Wells county, and shall be used in the county in the regular line of my business so long as I live, and never will I invest one cent of my means in government bonds.

When I emigrated to this county in 1838, I brought with me a small stock of goods, and, although the country was new, they met with ready sale. In a few years thereafter it became necessary for some one to build a warehouse to handle the produce of this section of country. I at once resolved to erect the needed warehouse, and in a few months it was up and ready for use. I immediately advertised that cash would be paid for all kinds of grain and produce, and that advertisement has never been recalled to the present day.

It has been about twenty years since I sold my store to George Arnold & Co. and started the Exchange Bank.

I conducted this bank about four years, or until 1862, when, in company with some other parties, I started a National Bank, and run the same nearly five years. I then closed up the National Bank, and resuscitated he Exchange Bank, in which I am still doing business in the town of Bluffton. My reasons for closing up t First National Bank of Bluffton are as follows: The law regulating National Banks rendered It impossible for any one business man to borrow of so small a bank as ours as much money as was necessary to carry on his business, and he was compelled to negotiate loans elsewhere, and then the bank had more money than it could use at home and had to seek parties outside of Wells county to lend money to. After the National Bank was closed up, the business men of Bluffton could be accommodated in the Bluffton Exchange Bank with all the money they wanted.

I spend about one-third of my time on my farms. There has never been a year since I have lived in Wells county that I have not made a full hand in the harvest field. I have done it this harvest, in the 62nd year of my age. It will take about two weeks from date to finish up my harvest, then I shall commence my canvass for Congress. I shall visit every township in every county in the 12th District, devoting all my time from the 25th of July to the October election, in order that the good people throughout the 12th Congressional District of the State of Indiana may thoroughly understand the doctrine of the National Greenback Labor party before casting their votes. The cream of the two old parties are coming over to the National party. The people are determined to make a change, and have a little legislation for themselves, so that these old political rings of both the old parties may be broken up. Pay off the bonded debt with the greenback dollar, to be made a full legal tender for all debts, both public and private, and stop the interest. Then will prosperity and plenty again return to the homes of the people of the United States.

Further, I will say that there is not one foot of real estate that I have ever

purchased at sheriff's sale but what I have always said to the parties that they could have all the time they wanted to redeem it, by paying principal, interest and taxes. I can now call to recollection only one piece of land that has not been so redeemed, and that can be redeemed at any hour.

I am in favor of reducing the pay of Congressmen to eight dollar per day for time actually employed, and the reduction f the President's salary to a sum not exceeding \$25,000 per year. I also favor a reduction of the salearies of all other officers in the same proportion, and the prompt dismissal of all superfluous clerks and officeholders from the government service.

When I was finally able to get my genealogy related email caught up a bit, I ran across the following article from Roots Web that I thought I would share with you concerning that very thing.

## **Brushing up on Latin Dates**

Often we encounter abbreviations used in contemporary documents and newspapers in reference to dates. For example, in a report of a shipwreck, an item might say "On Sunday night, the 18th inst." or "the ship left Liverpool on the 8th ult." or "the inquest will be held on the 25th prox."

These are Latin abbreviations which were commonly used. The meanings are: inst. is short for instant, which means "in the current month"; ult. is short for ultimo, which means "in the month preceding" (before

the current month); and prox. is short for proximo, which means "in the next month" (following the current month). Previously published in **RootsWeb Review**: 21 December 2005, Vol. 8, No. 51.
