It seems that some of my ancestors have decided to come out of hiding and I have been able to take 3 of my surnames back to the 1300-1400's. Families I didn't have a clue about before have appeared. Research is so much more fun when you get past that "brick wall," even if it leads to another "brick wall." It's the search that keeps us going.

I have been working on the Haiflich Family Tree for Leota Haiflich Dormire Kline and I am in the process of publishing it now. Leota will be 106 on her birthday March 9, bless her heart she has been waiting for me to get this done for almost 2 years now. I think she will be well pleased at the vast amount of information I have gathered for her to share with her family. Many families in the RockCreek and Union Townships are connected to each other through this family. A copy will be available in our Society library and I plan to send copies to the Fort Wayne and the Wells County libraries.

If you remember I made a request last month via email for contributions toward a new computer for the Society. We didn't receive enough money to purchase one yet, but I have applied to Wal-mart for a grant of \$600 to help purchase one. I also took the old computer to the repair shop and had a new hard drive and 3½" floppy put in it (the cost was \$115.) So I still have a computer to work on the data entry, but it's like putting new tires on an old car, you never know when the engine (mother board) will go out and you're still stuck with a junker. Hopefully, Wal-Mart will come through and we can have a nice dependable computer to use. Also when and if we get a new one we will have two computers available for anyone to come to the Society library to use to help do entry or to do research.

Cami and I also applied to the Wells County Foundation for grant money to help pay for printing of the first volume of the Wells County Deed Index. The Foundation has accepted our application and will vote on it March 21st. Keep your fingers crossed that we will get the full amount. Then, as soon as the data is entered, we can publish our first volume of the book. We expect the sales of each volume will provide the money needed for the publishing of the rest of the volumes in succession as we have them ready for publication. Each volume will be approximately 600 pages (that's a lot of names!).

The Iron Bridge School District (continued from the January 2007 newsletter) e Rockcreek Township School Book Story told by D. Nelson Decker

Excerpt from the Rockcreek Township School Book

There were no wells of water in those early school days in the school yards. The township trustee usually furnished one water bucket and one tin-cup for all to use. Generally the large boys that didn't like school were the ones that asked the teacher if they might go and get a bucket of water. Frank Fishbaugh was elected trustee in 1904. He had driven water wells put at all the schools, that should have been done many years ago.

Over the years until the iron bridge along with the other one room schools gave way in about 1922 to the Rockcreek Center consolidated grade and high schools. Old Iron Bridge turned out many students of note, men who have made their mark in this and other communit8es. I will just name a few. Chester Redding who served several terms as trustee of Liberty, our neighboring township. Clarence Fishbaugh who was auditor of Wells County two terms. Ernest McAfee on the County Council. Frank Brown who also served in that capacity. Frank Fishbaugh who was our Township Trustee, later elected as its trustee who was also auditor of Wells County. And of my own family, my brother, John F. Decker, was a member of the Indiana State Senate and Judge of the Wells Circuit Court for two terms; Charles, another brother, served two terms as Wells County Surveyor and later on the Bluffton City Council; Rufus and Otto, who each served on the Wells county "Advisory committee and last, but not least, my own 37 years as mentor of the youth of Wells county as a teacher in the schools, a public trust that I never intentionally betrayed.

I would like here to digress and tell of some of the history and legends handed down from the early settlers in the Iron Bridge district which occurred before my birth and entrance on the scene of action. My two grandfathers were born in Berks County, Pennsylvania in 1820; my grandmothers were born there, too. Isaac Decker bought and lived where Carl Freds lives now. John Houtz owned the farm Ralph Milligan now occupies. Other settlers in the Iron Bridge District came from North Carolina to get away from the curse of slavery.

There are two bank barns in the district, one on what used to be known as the Mary Sparks farm, and the other on what is known as the Isaac Decker Sr. farm. The bank barn idea came from Pennsylvania. The Sparks barn was built in 1867 and the Decker barn in 1868. It took three days to raise the Decker barn size 45 X 96 feet. There were 110 men there one day, but not one of these men is living now.

Isaac Decker and John Houtz were Jefferson and Jackson Democrats. During the Civil War they belonged to a secret organization known as the "Knights of the Golden Circle." The Republican party had an organization called the "Home Guards." It seems its chief purpose was to force unwilling Democrats to help fight in the war. Soon after the war began in 1861, there were some men who passed the Samuel McAfee home in the Iron Bridge District on their way to Wabash, Indiana to enlist in the army. Mr. McAfee went with them and enlisted and fought till the close of the war. His wife and children did the farming. It was told that after he got to where there was real fighting, there was a big battle, but he was not supposed to take part in it, but he helped to handle a cannon.


Some interesting trivia about us Hoosiers......

Diary of Rachel Grisell Irey

A taste of the past. How wonderfully this young mother strove to be a good example to her children and others around her. I found this a rereshing glance at a struggling mom, full of hope rather than despair.

The following was transcribed from a microfilm copy of a book by Morgan Milton Lewis & Mrs. Jessie Gray Emmons, "Genealogical & Biographical Record of Lewis & Grisell Families 1751-1763 to 1903" (1903 Morgan Milton Lewis, Battlecreek, MI, LDS Film #1320690), p.350,

"Rachel Grisell was the youngest ughter of Thomas and Elmira isell, whose family moved to Delare County, Ohio and settled on a m near Alum Creek. She was ite young when deprived of a other's care, yet, with the help of r father, brothers and sisters, she ceived an education in the district hool and taught for some time in public schools. Later on, through help of her brother William, she is enabled to enter Oberline Colge as a pupil, where she was under influence of President Fairchild, no has made Oberline what it is lay. Leaving there she took up ching again in Ohio, and later ent to Jay County, Indiana, making r home with her grandfather hite's family and teaching until her arriage...."

Some notes from her diary, now n possession of her daughter, Viola 7. Beall, may not be amiss:--

March 31, 1857. -- Hilles and I had a happy evening together. How much cheerfulness and smiles smooth the rugged pathway of life. April 1.--I have been impatient today, was irritated at the children's mischief. O, the patience and calmness a mother needs.

April 4.--How glad I was today to get sister Elmira's letter. April 5.--This evening I read a good piece about, "How to make home attractive and pleasant to children." Enter into their little plays, giving them privileges so far as right, and get interesting books for them to read when they are large enough. April 7.--O, how much I want to be a

good example to my children. This must now be the warfare of my life. Far from it, I have been. (Continued from page 5)

October 14. --Hilles and I have been to Father Irey's to gather our winter apples: They have given them to us. O, how kind they are. November 1.--I would be happy had I not said something this morning for which I am sorry. O, when will I learn to guard my speech? November 5.--Yes, I am glad to live, though there are thorns there are sweet roses too.

November 15.--We have been on a visit to Father Irey's. They were glad to see us all. O! what nice bread and butter, honey and baked apples. We had a good visit. On the way home we stopped to see cousins Emily and Martha Lewis. How good it seems to be at home. "Be it ever so humble, there is no place like home."

December 6.--I felt disappointed today; father and mother Irey did not come. It was too stormy. **December 7.**--The children and I are alone. How great is the demand for sympathy, kindness and forbearance toward them. Their active limbs are always busy, therefore they should be supplied with entertainment suitable for their active minds.

Give it play and never fear it. Active life is no defect. Never, never break its spirit, Curb it only to direct.

December 15.--It would be a relief to me if I could unbosom my thoughts on paper or if I had the gift to scatter them in oratory to the inhabitants of the earth. I long to see truth prevail, mankind purified for a higher life. Joyful thought, that we are to life forever, near to the fountain of all living truth. I can say with one of old, "O Lord, cleanse though me from secret faults." O that my life and example may be also pure.

December 25,--Christmas. Brother Benjamin and wife were here, they stayed the evening; we had a good time. We ate apples, read and talked about Women's Rights. **Jan 1, 1858.**--Mother Irey is sick, I am with her. Hilles is at home alone; I am anxious about him. **January 4.**--Hilles came after me Sunday. I did not like to leave mother.

(Continued from page 6) came very near getting chocked on a chicken bone. We were very much alarmed.

February 2.--A deep snow is on the ground, everything is carpeted with its white drapery.

January 14.--Father and mother have not come yet. Hilles had gone down.

January 15.--Hilles and mother came at noon, and O! we were so glad. I wish father would come and they would stay with us. The children are full of mischief, but as pretty as ever. What beautiful flowers they are; how could we live without them?

January 17.--Mother is still with us and we are having a pleasant time.

January 24.--How natural for people to despond at times when the brightest paths seem darkened. I want to resist such feelings. It is right to be thoughtful and sober, but no sad and gloomy, for that causes others to be unhappy. We should try to be cheerful, not only for our own happiness, but those with whom we associate.

June 13.--The clouds are dispelled, the orb of light appears, the birds sing their sweetest songs, the green trees seem to wave a gentle welcome as their foliage spreads above the dripping earth.

March 29, 1862.--Five years ago I attempted to keep a diary, but increasing care prevented after two years. I am now thirty years of age and the mother of four darling children.

.... Soon after the last date Hilles Irey enlisted in the civil war.... She managed the farm, with the help of neighbors, saving the money which he sent home and adding it to the sale of stock until Mr. Irey was mustered out at the close of the war. The next year they sold the farm and opened a store in Pennville, where they lived several years....
