## ***Ancestry.com Introduces “WorldArchives Project”***

Ancestry.com has launched a new program in the six last months called Ancestry World Archives Indexing Project.

Ancestry.com is expanding their support for genealogical and historical societies with an exciting new Society Partnership Program in connection with the Ancestry World Archives Indexing Project. POINT members who will join the project will have FREE access to content on Ancestry.com and Ancestry.it (Italian and US records). Ancestry has already discussed this project with Tom Militello and received his full support and approval. The next issue of POINT magazine will contain a note about this project.

This is a unique opportunity for POINT members to participate in a project aiming at preserving Italian records and making their indexes available for free to the larger community of people interested in tracing their Italian ancestors. 
- New opportunities for our organization to work together on local and family history projects, which becomes an excellent recruiting tool to motivate new members to join and become engaged in our organization

Italian records that will be available for the World Archives Project include civil registration records, in particular marriages and deaths, from different provinces across Italy. Ancestry is starting off with the province of Verbanio-Cusio-Ossola in the Piemonte region, and will continue with records from the provinces of Pavia, Varese, Casale Monferrato, and Siena. There will be also records from the regions of Sicilia and Calabria.
