witching which has been used for hundreds of year to locate underground water sources. Metal rods are utilized to identify areas where the earth has been disturbed. Enthusiastic members were given an opportunity to try the technique, and have since had great success in their "practice" attempts with graves that have good headstones to test their findings. This is another great tool in our search for family history!
