Lewis Brown dec'd Estate of
Final Settlement -

This day being set to hear and pass upon
the account heretofore filed by A. G. Freeman and
Mary M. Brown as the Administrators of said estate
for a final Settlement of their Adminis^{tr}trations
thereof, now comes the said Freeman and Brown
and move the court that their said account may
be passed and allowed.

And it appearing to the court, that due notice
of the time and nature of this Settlement has been
given by posting notices at the court house door
and other public places in said County for
three successive weeks; and that B. Sanford
who was heretofore appointed to act as guardian
ad litem for and protect the interest of all the
minors concerned in this proceeding and Settlement -
the court proceeds to examine said account and
to consider the proof relating thereto.

Whereupon it is shown and appears that said
Administrators have received of the assets of said estate
the sum of four hundred and eighty five dollars in
money and that they have justly expended in and
about the costs and charges necessary & incident to said
Administration and in payment of the debts of said dec-
edent the sum of one hundred and sixty one & 07/100
dollars, leaving a balance of three hundred and twenty
three & 43/100 dollars for distribution among those
entitled.

And said account appearing to be full and correct
it is considered and allowed by the court, that said
accounts be and the same are hereby, in all things passed
and allowed as above stated.

And it further appearing to the court that said
decedent - left him surviving seven children, some

- 1st Eliza Ashcroft- dec^d who left- five children, & wit-; S. H. V. H. P. Ashcroft- and S. C. Holman wife Halman and E. R. Nichols wife of Nichols all of whom are of full age and sound mind,
- 2 Lexington Crow dec^d, leaving two children wit-; Adaline McPherson wife of Perry McPherson and J. A. Crow who is now dec^d leaving five children; and whose estate is represented by Nyley Murff as Adm^r.
- 3 Rebecca Johnson dec^d who left four children wit-; J. M. Johnson R. B. Johnson, M. C. Owens wife M. Owens and Savilla Johnson.
- 4 M. C. Greenman wife of A. H. Greenman
- 5 Caroline Crow
- 6 Malissa McGinnis dec^d who left one child wit-; Jimmie Armstrong wife of J. M. Armstrong

All of whom are of full age and sound mind except the children of J. A. Crow dec^d wit- Enley, Lela, Quidey, Lemell A. and one not named, who are represented by the Adm^r wit- Nyley Murff.

And it appearing that one seventh of the said \$323⁴³ ¹⁰⁰ three hundred and twenty three ⁷⁴ ³ ¹⁰⁰ dollars would be a full share, i.e. \$46²⁰.

It is therefore adjudged and decreed by the court that the heirs of Eliza Ashcroft- dec^d wit- S. H. V. H. P. Ashcroft- and S. C. Holman & her husband Halman and E. R. Nichols and her husband Nichols have and recover the sum of \$46²⁰. Thus, S. H. Ashcroft- \$9²⁴ - V. B. Ashcroft \$9²⁴ H. P. Ashcroft \$9²⁴ S. C. Holman & her husband \$9²⁴ and E. R. Nichols and her husband \$9²⁴. And the said Administrator has having filed in this court Receipts from each of said distributees covering their full distribution shares it is therefore considered by the court that said Adm^r go hence discharged from the above five claims.

It is further ordered adjudged and decreed that the heirs of Lexington Crow- dec^d ~~Rebecca McGinnis~~ ^{Adaline} of McPherson and her husband and the Adm^r of J. A. Crow dec^d wit- Nyley Murff have and recover of said Adm^r his balance the sum of \$46²⁰. This Adm^r will

The said Adm^r Thomas Brown having filed in
 this court a receipt from each of the two last-
 distributees for the sum of Eleven \$33⁰⁰ dollars

 her husband \$11⁵³-

It is there fore adjudged that said deceases be
 credited with amt of said receipts -

It is further ordered and decreed that
 M. G. Brownam, her husband & her heirs
 receive share of said said estate
 And the said Adm^r having filed a receipt from
 said M. G. Brownam for the forty six \$20⁰⁰ dollars
 amount of her distributee - Then they are therefor
 discharged from said decease

It is further adjudged and decreed by the court
 that Caroline Brown have and recover of said Adm^r
 the sum of forty six \$20⁰⁰ dollars as her distribut-
 ion share of said estate

It is further ordered adjudged and decreed by the Court that John Armstrong and her husband of M Armstrong for her use have and recover the said Admrs the sum of forty Six \$20/100 Dollars her distributive share of said estate. And the Admrs having filed receipt from said Armstrong covering full amount of said decree they are thereupon discharged from same.

It is further ordered adjudged and decreed by the Court that Mary A Crow recover of the said Administrator the sum of forty Six \$20/100 Dollars her distributive share of said estate, and the said Admrs having filed receipts from Mary A Crow covering amt of the decree they are thereupon discharged from same.

This order is adjudged and decreed by the Court that said Admrs pay over the following amounts to the following heirs and distributees being their respective shares of said estate, and for which several writs and decrees executions may issue to wit:
