concerning the North West quarter of Section Twenty Eight Township Twenty four Range Thirty One Section 28 Twp. 24 Rge. 31 West of 1st Meridian.

Homestead Pre-emption

- 1. What is your name in full, age and Post Office address? *John Sigurdson age 40 years P.O. address Logberg neither*
- 2. Are you a British subject by birth or naturalization? If naturalized, when and where? *neither*
- 3. What is your trade, profession or calling? *Farmer*
- 4. When did you obtain entry for this homestead? *in October 1898*
- 5. When did you build your house thereon? *in October 1898*
- 6. When did you perfect your entry to your homestead by taking in your own person possession of the land and beginning continuous residence thereon and cultivation thereof? *Ever since*
- 7. What portion of each year since that date have you resided thereon? State each month. *Ever since*
- 8. When absent from your homestead where have you resided, and what has been your occupation? *never been absent*
- 9. Of whom does your family consist; when did they first commence residence upon this homestead, and for what portion of each year since that date have they resided upon it? *a wife and one child in October 1891, and have resided upon it since*
- 10. How much breaking have you done upon your homestead in each year since you obtained entry, and how many acres have you cultivated each year? *none*
- 11. How many horned cattle, horses, sheep and pigs have you had on your homestead each year since date of perfecting entry? Give number in each year? *15 Horned cattle 2 Horses 20 sheep This is the whole number of Horses at present on the farm*
- 12. What is the size of your house, and what is its present cash value? *14x16 feet \$25.00*
- 13. What extent of fencing have you made, and what is the present cash value thereof? *None Stables \$25.00*
- 14. What other buildings have you erected? What other improvements have you made, and what is the cash value of the same? *None*
- 15. Are there any indications of minerals or quarries on your homestead? If so, state nature of same, and whether it is more valuable for agricultural than any other purpose. *None*
- 16. Have you had any other homestead entry? If so, when and where, and what became of it? *No*
- 17. Have you assigned or transferred or agreed to assign or transfer your homestead or pre-emption right or any part thereof? If so, when and to whom. *No*
