Headline: *El Paso County's Oldest Document a Poll Book of Forty Years Ago*

“The recent overhauling of the basement of the county jail, in which are stored the dust-covered books and yellow-edged papers belonging to the county known as “archives” brought to light what is believed to be the oldest El Paso county document extant.

It is the poll book made out after the election held at the Cotton ranch on September 1, 1863, 40 years ago.

The Cotton ranch was at that time the central habitation of precinct No. 3, which is described in the document itself, reproduced below. Present at that election were several El Paso county citizens who are still in the county, among them J. C. Woodbury, B. Hall, A. G. Hill, Anthony Bott and A. C. Beach, while Thomas Owens, who was a candidate for county commissioner and A. Z. Sheldon who was elected surveyor and representative, are still here.

The territorial council, to the lower house of which A. Z. Sheldon was elected, met that year in Colorado City. For lack of accommodations it was necessary for it to move, however, and, the country counties being greatly opposed to Denver as the seat of the state government, it was moved to Golden. It was necessary for it to move again, however, and it finally landed in Denver. Mr. William Howbert, father of Hon. Irving Howbert of this city, was chaplain of this council.

The following is the complete contents of the poll book referred to:

El Paso County, Colorado Territory
POLL BOOK
Precinct No. 3
Election September 1, 1863

Precinct No. 3, Commencing at the junction of Cherry creek and Colorado roads, thence down the Fountain Qui Bouille to and including A. D. Sprague's ranch, together with all that section of country between the southern boundary line of El Paso County and northerly to Bijou creek not included in other precincts.

At our election held at the house of O. M. Cotton in the third district of El Paso County, in the territory of Colorado, on the first day of September, in the year of our Lord, one thousand eight hundred and sixty-three, the following named persons received the number of votes annexed to their respective names for the following described offices, towit:

For the council, John Howard received (10) ten votes, Robert Stubbs received (32) thirty-two votes.

For representative, A. Z. Sheldon received (37) thirty-seven votes. Baxter received (1) vote.

For county commissioner, O. M. Cotton received (16) sixteen votes. Thomas Owens received (16) sixteen votes. Charles E. Senger received (3) three votes.

For treasurer, L. (I.?) M. Rhoads received (34) thirty-four votes.

For assessor, J. B. Wright received (33) thirty-three votes. W. G. Harmes received (5) five votes.

For surveyor, A. Z. Sheldon received (30) thirty votes.

For clerk, G. A. Bute received (37) thirty-seven votes.

For attorney M. Green received (30) votes.

For coroner, H. Stevens received (37) thirty-seven votes.

For sheriff, R. S. Kelly received (38) thirty-eight votes.

For probate judge, E. T. Caten received (37) thirty-seven votes.

For superintendent of schools Rev. W. H. Fisher received (30) thirty votes

For justice for two years, J. C. Woodbury received (36) thirty-six votes; Sprague (1) vote.

For justice for one year Rothrick received (36) thirty-six votes.

For constable for two years, S. Lister received (36) thirty-six votes.

We the undersigned judges of election held at the house of O.M. Cotton on the first day of September, one thousand eight hundred and sixty-three, do hereby certify the above to be a true record of the votes cast for the different candidates.

Directly below this above article on the same page for the Gazette, Jan. 12, 1903, is another article: *Death of El Paso County Pioneer at Fountain*. "Word was received here yesterday of the death at Fountain of Mr. Ames, one of the oldest residents of this section of the state. While no particulars were received, it is understood that Mr. Ames had been more or less ill for some time and he was quite advanced in years. He was one of the pioneers of Colorado."

Headline: *Oldest Official Document in History of El Paso County*

Sub-heading: Pole Book of the First Election Held in this County is Unearthed from Archives of the County Treasurer - Dates Back to 1863

"While delving among the archives of El Paso county in the county jail last Thursday, Mr. Hollis Jewitt, a clerk in the employ of the county treasurer's office, dug up what is believed to be the oldest official document in the poll book of the first election in the county, and bears the date September 1, 1863, a time which antedates the founding of the city of Colorado Springs by about eight years.

According to the aged document, the election was held in the ranch house owned by A. M. Cotton, the father of Frank Cotton, who is at present one of the firm of Cotton, Terrill & Garlick. The record is written on legal cap, and covered with common brown paper, and in addition to the names of the voters it contains the oaths of office taken by the newly-elected county officers. The list of voters follows:
