Acceptable proofs include birth & death certificates, Bible records, wills and estate distribution records, census records, approved record copies from other recognized hereditary organizations, land records, and published books if they are well-documented.

The cost to register your first ancestor is \$30.00, made payable to the Genealogical Society of Henry & Clayton Counties, Inc. Additional ancestors may be registered for a cost of \$20.00 each.
