BEE CAUSE OF BAD INJURY TO MRS. INNIGER

Mrs. Rufus Inniger of north of town was severely injured Friday afternoon when the sharp points of a pair of shears pierced her left foot. Mrs. Inniger was out on the lawn, engaged in sewing, when a bee lit on her head. In her efforts (crease) ...on the scissors. The points went through her shoe, then entirely through her foot. Mrs. Inniger lost a lot of blood and suffered considerable pain. A local doctor dressed the injury.

The car driven by Mrs. Schwartz turned over and was damaged considerably. Mrs. Schwartz escaped with bruises.

The car driven by Long was only slightly damaged and he was not hurt.

DEATH TAKE MRS. CHRISTEN

Mother of E. S. Christen Dies at Decatur Tuesday

Decatur, July 16 -- Mrs. Catherine Magley-Christen, 85, lifelong resident of Adams County and mother of E. S. Christen and Ray Christen of Decatur died at her home, 636 North Second Street, Tuesday night at 6:35 o'clock of uremic poisoning. She had been ailing for the last two years, and had been seriously ill for 10 days previous to her death.

Mrs. Christen was the oldest Gold Star Mother in Adams County, and was a life-long member of the Concord Lutheran Church until it was disbanded.

Mrs. Christen was born in Adams County, three and one-half (crease)...ber 25, 1850, a daughter of Christian and Mary Shearer-Magley. She was united in marriage to John Christen, who preceded her in death in 1920.
