Funeral services for Mrs. Peter D. Schwartz Held Here

Funeral services were held Sunday afternoon at 2 o'clock at the Mennonite church for Mrs. Peter D. Schwartz, aged 43, who died at her home late Thursday. Rev. C. H. Suckau officiated at the services. The funeral sermon was preached in German. Burial was in the M.R.E. Cemetery.

Mrs. Schwartz had been ill for ten weeks, and her condition was critical for several days before her death. A post mortem, held Friday disclosed that death was caused by carcinoma. She suffered greatly during her illness. The Schwartz family lives on the former Ben Habegger farm, northeast of Berne.

Elizabeth Nussbaum Schwartz was born in Wabash township, Sept. 20, 1893, a daughter of David C. and Marian Habegger Nussbaum. Most of her life was spent in Monroe township, and on June 18, 1916, she was

married to Peter D. Schwartz. He survives and the following children, all at home: Gerhart, Chester, Leroy, Frances, Raymond, Anna Louise and Rosemary Elizabeth. The father, David C. Nussbaum, also survives, and four brothers, Sam D., Jacob, Philip and Menno Nussbaum, all of this community. The step-grandmother survives, Mrs. Catherine Habegger. The mother and one sister preceded.

### FUNERAL WEDNESDAY FOR FRED SCHULTZ

Police to Honor Patrolman Killed in Truck Crash; Pallbearers Named

Funeral services for Fred Schultz, aged 42, patrolman in the Fort Wayne Police Department, who was killed instantly Monday in a truck crash south of Decatur, will be held Wednesday at 1:30 p.m. at the residence, 1705 South Lafayette Street and at 2 p.m. at the Scottish Rite Cathedral. Dr. Paul H. Krauss, pastor of the Trinity English Lutheran Church, will officiate. Burial in Lindenwood Cemetery.

Pallbearers chosen by Captain of Police Jule J. Stumpf, are Officers Frank Conroy, Edwin McCarthy, Jack Asies, Francis Dibble, Alfred Smith and Edward McGrath. Arrangements have been made for all police officers on the second trick to attend the services in a body. Wayne Lodge No. 14, Fraternal Order of Police, will conduct services at the grave.

#### BODY TAKEN TO HOME

The body was removed to the residence at 4 p.m. today from Julian Schone's Funeral Home. Surviving are the widow, Lula; a son, Robert; a daughter, Esther; the mother, Mrs. Augusta Schultz, and a brother, Clarence, all of this city.

Officer Schultz died instantly of fractures of the skull, jaw and of an arm and leg and a crushed chest. He was a passenger in a truck driven by William C. Franke, driver for the Baum Company, of this city, when the truck crashed into a bridge and then into a tree. It is believed Franke went to sleep.

#### FRANKE EXPECTED TO LIVE

It was reported at the Adams County Memorial Hospital at Decatur today that Franke probably will recover. He suffered injuries to his chest and head and shock. The injuries are not believed to be critical. Adams County Coroner Robert Zwick had not returned a verdict today. He is investigating the fact that the truck left Fort Wayne and 8 a.m. and was wrecked about 11 a.m., an unusual amount of time having been required to cover the distance. Officer Schultz was accompanying Franke to Cincinnati on his day off.

Mr. Schultz was a member of Summit City Lodge No. 170, Free and Accepted Masons, and the Fort Wayne Consistory, Ancient Accepted Scottish Rite Masonry.
