#### NEW ADDITION AT COMMUNITY EXCHANGE HERE

##### Albert Sprunger is Having New Office, Storage Room Constructed

A new office and storage room is under construction at the Community Exchange here, managed by Albert Sprunger. The new building is being erected directly east of the present building. The new addition will be 42 feet long, and 24 feet wide, not including the new and wider driveway which will be made.

The foundation has already been put in. The building is being erected by "Jake" Schwartz and his brothers, sons of C. J. Schwartz north of the tile mill. The building will be a frame one, and is expected to be completed yet this fall.

The office will be moved into the new building, and the rest of the new addition will be used for a storage room. The driveway will be made three feet wider, and will make it easier to unload trucks.

A bin for corn cribs has been constructed on the north side of the present building. It is so equipped that the cribs will slide down to the floor, where they can be loaded.

Mr. Sprunger became manager of the Community Exchange some time ago, the firm succeeding the former Berne Milling Co.
