This is the last will and Testament

produce agent and the Ballarat Trustees  
Executors and Agency Company Limited  
Executors and Trustees of this my will  
and I declare that the said Company  
may execute any of the Trusts and  
powers herein contained by its Officers  
I devise and bequeath all my Real  
and Personal Estate unto my said  
Trustees upon the following Trusts  
that is to say as to my Real Estate  
upon Trust for my wife Margaret  
Lane during her life and upon her  
death then upon Trust to sell and  
dispose of the same and to stand possessed  
of the proceeds to arise therefrom upon  
the Trusts hereinafter contained I bequeath  
to my said wife all my household furniture  
and effects absolutely as to all the rest  
residue and remainder of my Personal  
Estate upon Trust to sell and convert into  
money so much thereof as shall not  
consist of money and I declare and direct  
that my said Trustees shall stand  
possessed of the proceeds to arise therefrom  
and of all moneys forming part of my  
Personal Estate hereinafter called Trust  
moneys upon Trust thereout in the first  
place to pay all my just debts funeral

and testamentary expenses and also all  
probate and Federal Estate Tax on  
the whole of my Estate and in the  
next place to invest the residue of the  
said Trust moneys in or upon any of  
the securities authorized by Law for the  
investment of Trust monies and to pay  
the interest and annual Income to  
arise therefrom to my said wife during  
her life and upon the death of my said  
wife then I declare and direct that my  
said Trustees shall stand possessed of  
the said Trust monies and all investments  
and accumulations thereof and also all  
monies to arise from the sale of my Real  
Estate upon the following trusts that is  
to say upon trust the said Trusts  
following legacies namely

- 1 The sum of £200 to the Reverend John  
McAuley or other the Parish Priest  
for the time being officiating at the  
Roman Catholic Church at Koroit  
for masses for the repose of my soul
- 2 The sum of £500 to the Building Fund  
for the completion of the said Church
- 3 The sum of £100 to the Convent Koroit
- 4 The sum of £200 to the Sisters of Nazareth  
Home Ballarat
- 5 To the Sisters of the Poor Northcote the  
sum of £200.
- 6 The sum of £25 to the Foundling Hospital  
Brookmeadows
- 7 The sum of £25 to the Warrnombool  
Hospital

8 The sum of £25 to the Port Fairy Hospital  
9 I direct my said Trustees to expend the  
sum of £200 for the erecting a suitable  
Monument and railing to my memory in  
the Lower Hill Cemetery

10 To my Brother John Lane of Clontarf  
County Clare Ireland £200

11 To my Sister Ellen Gorman of Cressley  
the sum of £200.

as to all the rest residue and remainders  
and remainder of my real and personal  
estate upon trust to divide the same  
between my Brother John Lane and my  
Sister Ellen Gorman equally share and  
share alike

To appoint William Ardlie as his  
successor in Business Solicitor to my  
estate

I revoke all previous wills and declare  
this to be my last will and Testament  
In witness whereof I the said Roger Lane  
the Testator have hereunto set my hand  
this 25th day of August 1923
