Your letter of May second has been received. Thank you for your offer to furnish the results of your research. The Librarian of the D. A. R. Library will be most pleased to receive your genealogy when it is completed.

Mrs. Olive Virginia Miller Jaco's National Number is 203487. Mrs. Alice Hohn Moorhead's, National Number 74630, who died in 1918, is the only descendant of Captain Duncan McVicker who has joined our Society, not listed in your letter. The dates of birth and death we have for your ancestor are slightly different from yours. The dates we have are 1748 - 1820.

The libraries at Sigourney and Cedar Rapids, Iowa, are not on the standing order for Lineage Books, but the library at Cedar Rapids has a few of the earlier volumes. The Iowa State Library at Des Moines is on the standing order list and has received through volume 160. Volume 161 is the last one published and will be sent with Volume 162 on July first. No volume of index has been published beyond the second volume which covers Lineage Book Volume 80. The only indexes are those in the backs of the books, but reprints of indexes beginning with Volume 150 are sold through the office of the Treasurer General for 25¢ each.

Original signature ("Dunken McVicker") on file.

Page 401 of Stryker's Official Register of the Officers and Men of New Jersey in the Revolutionary War, published 1872, shows this man as a Captain. This, however, is an error, and is probably due to the fact that, as a Lieutenant, he was commanding a Company.

Although both Christian name and surname appear under various spellings, the arrangement used in the personal signature has been taken for the compiled record.

Dear Registrar-General:

For a long time I have been conducting researches and I have assembled considerable materials relating to Capt. Duncan McVicker (1759-1818), Second Regiment Sussex County New Jersey Militia in the Revolutionary War, my great grandfather. I have also been tracing out his descendants, a voluminous task. In this search I have found many previously unknown kinsmen, two of whom Dr. Winters Duncan Hamaker and his son Dr. Charles Townsend Hamaker, of Pasadena, Calif., at Christmas time 1936 presented me with the Family Bible of Alexander McVicker (1773-1852), a son of Capt. Duncan McVicker (1759-1818) with whom the father spent the declining years of his life at his son's farm home near Schellsburg, Pennsylvania. This Bible contains the record of the death and the age of Capt. Duncan McVicker, evidently in the handwriting of the son Alexander McVicker (1773-1852). Alexander McVicker was an Uncle of my father whom he had never seen as I believe. This Bible contains the Family Records of the Alexander McVicker line including the entry of the death and the age of Capt. Duncan McVicker (1759-1818) in the handwriting of the son Alexander McVicker, and thereafter the record is continued in the handwriting of a son of Alexander McVicker—Duncan McVicker (1799-1879)—down to 1876, in 4 pages of writing.

Dear Madam:

For some time extending over a period of several years I have been collecting material for the genealogy of the family of Duncan McVicker who served as an officer in the Second Regiment of Sussex County New Jersey Militia, and also, as I believe, additionally thereto, during the American Revolution.

It is my intention eventually to publish the results of my research, probably in the form of sketches under subject headings by branches of the family, or otherwise, as will best serve, and to place the copies in Libraries, particularly in the National Archives of the Daughters of the American Revolution and in State Libraries. This will be done entirely at my own expense, as it is not designed as a commercial enterprise nor as any co-operative sharing of the expense even since it is only my individual plan in which I do not wish to incur any obligation but wish to do this if I can as events enable me to do so. I am moved to submit my results eventually by the fact that I have a considerable body of material collected with great pains and which I do not want to be lost to subsequent purposes of any persons to whom it may be of advantage. As stated, I would like eventually to publish this in the form of sketches in a book or booklet and to make it available to the Libraries including yours as well as to the few persons who may have been sufficiently interested as to have co-operated and who may care for it--that is, it will be available in the public Libraries to all but probably no large number of copies will be printed except to the extent to supply the limited wishes of the descendants, or any of those concerned or so desiring copies.

I have found this to be quite an undertaking, but to me quite fascinating. I have been surprised and interested in my finding of descendants and connections.

You will readily appreciate the fact that such a research is continually marked by the fragmentary character of the results since information is only obtained piecemeal at a time and from surprising sources. However, after a long research I am able to trace the families of four of the seven sons of Duncan McVicker and one of the supposed three daughters, with promising outlook for continually widening success. You, from your observation, will also appreciate the fact that there are so many points to be harmonized and corrected by getting more data that all sources of information are greatly needed.

Duncan McVicker was my great grandfather, I being descended through his son Joseph McVicker (17__ -1841) and my father Norvel Wilson McVicker (1827-1923).

In order to write my own sketches, I have been collecting copies, from all county histories which I can discover, of sketches concerning the families of any of the descendants, obituary articles, and transcripts from all the official and public records in any way possibly concerning Duncan McVicker and his family. I have a considerable amount of such material, and am in correspondence with others who have made and who are making researches, including several members of the Daughters of the American Revolution. Whenever, the material is sufficiently collected or the opportunity affords, I also write and I have written sketches of individuals, placing the results in my files and also furnishing copies to those interested. In this way, a considerable volume of the eventual work is being completed in that form as I go along, except of course for the necessity of rewriting for the final form. I have also collected transcriptions from monuments.

Among my other sources, I have the sketches which have been published in the Lineage Books of the Daughters of the American Revolution for the following names:

These are all which I think have been published in the about 130 volumes which I have examined.

I am also interested on the side of the wife of Capt. Duncan McVicker, who was by the preponderance of much evidence that I have collected Nancy McCollum (or perhaps Annie Laurie McCollum called Nancy McCollum, just as the name of Elizabeth being called Betsy or Betty, so the name of Annie being called Nancy--but I am collecting further on the name of his wife, or wives.) Nancy McCollum was evidently of the near relatives of the Ensign Daniel McCollum family, of Preston County, West Virginia. This Daniel McCollum was the son of James McCollum (1725-1800) who with four brothers came to America from Scotland, and some or all of whom of these 5 brothers lived in Northern New Jersey, where also Capt. Duncan McVicker lived until he moved with his seven sons (and probably 3 daughters) to Bedford Co., Pa. Descendants of the McCollum family are working with me on this problem, and we hope to achieve results. Also descendants of the McVicker families are also working with me. The problem is interesting to me despite that it has been baffling in this: that just as I have been ready to achieve the sources of certain information or to see certain persons reputed to have made research into the sources, and who as I believed could give me valuable information as to either the sources or the facts they secured from sources, I have been prevented from realization of the expected results. Thus, on a trip East last summer I called to see an aged lady with whom I had correspondence, but could not see her because but two or three days before she had been taken to a sanitarium and although I was told that she had looked forward to seeing me, I was unable to see her; and have been advised that she was not in condition of health for me to write to her. This lady was the sole sponsor for the name of Captain Duncan McVicker's wife as being Annie Laurie, she having gone to New Jersey to make her researches, and she having erected at her own expense the monument to him (her great great grandfather) and placed thereon after his name substantial one) and judge it to have been erected about 15-20 years ago.

On the same trip last summer, I visited Fayette County, Pa., and at Masontown therein, where my Mother was born (1849-1899). Relatives drove me to Smithfield, only a few miles away, where I hoped to see Mrs. Carrie Stewart Mathiot (Metcalf, Mrs. A.T.), and whose name was given to me last year by your Office. She is living, or was, with her son, in the town, but I could not see her. He stated that she was a nervous wreck and under his guardianship and that he did not permit persons to see her, that she had made herself such by too much interest, research, travel and work in connection with her D.A.R. researches. He said that she had gone into New Jersey and had made extensive researches into the family of Capt. McVicker and the sources and records in New Jersey. He could not give me definite information as to just where she had gone, or as to what she found, or as to any particulars, but he stated that she had made a very careful and full written report for the records of the Daughters of the American Revolution and that she had deposited her report either with the D.A.R. Chapter at Uniontown or with one at Morgantown, W.Va., or perhaps with the National D.A.R. headquarters. He said he did not know or understand the matter, that he had not taken any interest in this work, hence could give me no exact particulars. He stated that it would mentally disturb her for him to ask her any questions at all about it, that he would not wish to look at all into her trunk where she had her records as she was very particular (he volunteering this information and not having been asked to look into her trunk). He was otherwise polite enough, but very positive that she could not be approached or asked anything at all about the matter, even by himself, because of her alleged mental breakdown and condition. However, as he said he believed, his Mother had made record of her researches and had submitted her report to the Uniontown Pennsylvania or the Morgantown West Virginia Chapter. Subsequently, the report was not found in the Morgantown West Virginia Chapter, as stated to me by the Regent. Being in Uniontown Pennsylvania I saw the officers (two ladies) of the proper Chapter there. They did not know at the time whether they had the report described, but they wanted to give me for the purpose whatever they might have but wished me to obtain from this Mr. Mathiot (the son) his written consent in lieu of that of his Mother. Accordingly I sent him a form to sign or asked him to write the Regent (being the Chapter to which his Mother belonged) to the effect, but I have never since heard from him.

I have detailed these difficulties and stated my ^bject for your information in order that you may note the entirely proper purpose for which I seek records. I have not since had time to take up the matter further with the ladies at Uniontown whom I saw and who wished to help me, but I shall write them further when I have the opportunity. I do not know if the information they have is such described report of research or not. It may be only the customary historical data for the record of Mrs. Carrie Stewart Mathiot (Metcalf) as a member.

However, in view of the purpose for which I am collecting the information--historical, helpful, and for the records of the future, and for publishing and filing copies of all my findings in the form of sketches with my authorities stated, both in your Library and otherwise, I am desirous of making a request of you. I am engaged in teaching law at the University of Kentucky College of Law. I am a great grandson of Capt. Duncan McVicker. I have a sister and a niece who are members of the D.A.R. I have had correspondence with two of the names on the list on the preceding page (2). They have given me all the history they can and will continue to do so. My purpose is therefore in accordance with your purposes to obtain the history.

I would respectfully request that I may be permitted to have copies of the records of all descendants of Capt. Duncan McVicker who have been accepted into membership in the Daughters of the American Revolution since the last publication of the Lineage Books.

As before stated, I have found only about 130 of these volumes of the Lineage Books, and as I remember, the publication of these records is about fifteen years prior to the present time. Hence, there are probably several descendants of Capt. Duncan McVicker who have been accepted into the organization and perhaps several of whom would be very helpful to me in collecting the desired information. You will readily appreciate that since you will have noted that my purpose is quite a large and comprehensive one, viz., to collect information of the descendants from the settlement of the Captain in New Jersey to the present.

I have a very considerable body of information and data collected and have found much co-operation in unexpected quarters. My desire is to render all information I can collect as complete and accessible for proper purposes as possible. It represents no gain to me but the private satisfaction of my liking for the research and writing. It represents therefore in the long run more to others than it does to myself. It will be useful and preservative of the record and the history.

I wish to pay for the copying of these records, the making of transcripts, etc., hence I am not expecting to impose a burden without expense.

There may not be many, as to that I do not know. I have received references to two from your Office in the past, one of whom wrote giving me the full line of her connection, and the other being Mrs. Carrie Stewart Mathiot above referred to.

The information requested is for files of my sources and not to be individually published, manifolded or given out. It can do no injury, occasion no embarrassment as it will not be used for any purpose by me except eventually to draw from either in writing to individuals for suggested facts in tracing further, or finally as one of my sources when I come to writing. Eventually you will probably have published the matters in your Lineage Books, but as I am making my collections and using all sources obtainable for suggestions and leads, you may have some names that will prove very valuable to me in my search.

Please pardon the great length of this letter written in detail to afford complete explanation of my object and purposes.

Dear Mr. Hagans:

I have your interesting letter of July 22, and a short time before your letter of June 26 came, having seemed to have been returned to writer first for lack of the street address. As much mail as I have put through the postoffice, I should think that they would know me but it looks as though they do not.

I have an interesting fact to report. I have just received an abstract of the D.A.R. entrance record of Mrs. Carrie Stewart Mathiot which is a most significant record. In the first place, this lady did original research work in New Jersey and elsewhere to find out the facts about her lineage. She is descended from Capt. Duncan McVicker through James McVicker (1768-1852) and Permelia McNamar McVicker (1772-1847), Elizabeth McVicker (1791-1883) and Owen John (1788-1868).

She is the first and only one of all the entrants whose records I have seen who seems to have a correct record of the birth and death dates and place of burial of Capt. Duncan McVicker (1739-1818). All others seem to have followed the beaten path of the first printed record accepted, in the D. A. R. Lineage Books. This bears out the claim that she did original research work about the matter. In the next place, however, she is mentally ill it is claimed by her son, Harry B. Mathiot, Smithfield, Pa., and he allows no one to see her or to talk with her as he told me last summer. Neither did he answer a letter for me, but I have finally secured some abstract of what she has in her entrance application into the D.A.R., through another.

The significant thing, however, is that she has given the first and only dates I have found anywhere for Nancy McCollum (1748-1820). These dates may be constructed, it is true, but she has otherwise done remarkably well in getting the accurate dates for Capt. Duncan McVicker. If her dates for Nancy McCollum, 1748-1820, be credited, then Nancy outlived the Captain 2 years. If true, also, they would tend to overthrow my previous theory that the Captain had no wife in Pa., but that she had died before he came from N.J. This puts me on notice to try to have more search made in Bedford County, Pa.

I have no word from Basking Ridge, N.J., nor elsewhere except as above stated.

In re subscription list: I had secured the address of A. D. Hough through Edward Thorp King and wrote regarding the descent of Nancy McCollum. A letter of May 8, 1935 was written me by Arthur D. Hough, then of Hopwood, Pa. (now of West Leisnring, Pa., according to advice written me by Rev. H. H. Ryland, Ligonier, Pa.)

The following has nothing to do with the case in hand, but has suggested something important for our further research for Nancy McCollum--which however, we will not mention to the D.A.R.:

Dear Mrs. Gifford:

I have been looking over some of the letters and papers that you sent me and I have been getting much interested in that town of Cullybackey, County Antrim, Ireland.

At first you were under some impression that Mary ("Polly") McVicker had been born there in 1773. I see you state that an uncle, Wilson Polk McBride, gives Mary McVicker McBride as the wife of Thomas McBride and states she was born in Kalabackey, Ireland in 1773, and died May 8, 1833. He gave no reason for stating that Mary McVicker was born in Kalabackey. You add a note that the correct spelling is Cullybackey.

Now what your Uncle Wilson Polk McBride said above--that Mary ("Polly") McVicker was born at Cullybackey, Ireland, in 1773--contradicts that part of the History of Caldwell and Livingston Counties Missouri where it says: "Thomas McBride, a farmer by occupation, was married in Hampshire County in 1797 to Polly McVicker, a native of New Jersey. Her father, Duncan McVicker, also a native of Ireland, but of Scottish descent, took part in the War of the Revolution. He was a Scotch Presbyterian of the old school type."

Please note that the History record says that Mary ("Polly") McVicker was born in New Jersey, which of course is what we want. It marks the identity of Mary McVicker as a member of the family of Capt. Duncan McVicker. So far, it seems that I have found only one McVicker (and that Duncan McVicker) who did take part in the Revolution from New Jersey. Stryker's History of Officers and Men from New Jersey in the Revolution (page 401) lists the one and only McVicker as our Capt. Duncan McVicker.

But what I am interested in is Cullybackey. That statement by your uncle Wilson Polk McBride must have some basis--and I think that it may be that the mother of Mary McVicker McBride (1773-1833) was born in Cullybackey, Ireland. The statement of the fact probably got twisted that much--I think it means that the mother was born there. This gives me a great suggestion.

For a long time we have been tearing the State of New Jersey upside down to find Nancy McCollum and her origin. Another kinsmen and I have many letters out even at the present time.

So I am going to pass along the suggestion to him that a certain source has indicated to me that Capt. Duncan McVicker's wife--Nancy McCollum--was born in Cullybackey, Ireland. Now this man is a McCollum descendant and he has done research in Ireland and found another descendant. It may give him such a clue that he will eventually get some results.

But it does not pay to count on expectations of finding things in genealogy. So that is why it is best to not make mention of this research being made and planned to be made to the D.A.R--or they might say "Go ahead and we will wait on you until you get it done." And it might never result in anything.

But I am glad that this suggestion has occurred. The elusive Nancy McCollum may have come from Cullybackey, County Antrim, Ireland. It looks as though that may be the basis or the fact behind the impression that was stated in your Uncle's statement.

My files show eleven (11) names of members admitted to the D.A.R. on the record of Capt. Duncan McVicker (1739-1818) and ascribing Nancy McCollum as his wife. To the best of my knowledge and belief they have had no applications nor admissions to membership of persons ascribing either Annie Laurie or Jean McConnell. I do not know whether any have so tried with these names, but in the course of time I suppose that some one from Bedford County where they take their information from that secondary monument inscribing name of Annie Laurie may try with her name. But the name Annie Laurie is not found in the Family Bible of Alexander McVicker (1773-1832). No tradition of the name of the wife seems to have come down from that branch although the great great granddaughter reported the name Annie Laurie from her own researches in New Jersey.

When and if I am called upon to furnish a special report as to either or both Annie Laurie or Jean McConnell, my facts will consist of circumstantial evidence to advance the claim of Nancy McCollum and to explain the other two or either as the case may be.

The name of Mrs. Carrie Stewart Mathiot Metcalf was furnished to me by the National Office of the D.A.R. to aid me in thus supplementing my research. Her National Number is 180772. On June 28, 1938, while visiting my Mother's relatives in Fayette County, Pa., I called to see this lady at her home in Smithfield, Pa., where I was informed that she was mentally infirm and that no one was allowed to talk with her. I regarded her as a significant witness since she was reputed to have conducted researches in New Jersey. But we cannot secure her report except as submitted to the D.A.R. for membership. She it was who ascribed dates for Nancy McCollum as of 1748 - 1820. We have not been able to duplicate her research. We cannot learn where she found these dates. We cannot dispute them nor refute them. Things are very hard to find in New Jersey--she may have found these dates there or taken them from some other source which she accredited. We have found no trace of Nancy McCollum having been buried in the Cemetery with the Captain nor elsewhere in Bedford County. To me this is significant, but I can not go any further than to have my own personal opinion. It is possible that she came to Pennsylvania with the Captain and his children, but if she did it seems to me that she must have died some time before him and not afterward and that she must in that event have been buried in some other place and not in the Cemetery with him and certainly no trace exists that she is buried on the plot where he now rests.

I have the letters of a brother as to the report of Miss Ida R. Hamaker of Annie Laurie, but although she is living she is mentally infirm and is confined in a sanitarium as I believe in Maryland near Washington, D.C., where she had last previously resided for several years at the Hotel Annapolis. On June 18, 1935, I called to see Miss Ida Rosanna Hamaker at the Annapolis Hotel, Washington, D.C., but was told by the Clerk that she had been taken to a sanitarium about three days previously. I had planned to secure from her a report of her research affording clues. Since then I have been informed by her brother that I cannot take up the matter with her even by letter on account of her mental condition. Genealogy is a very queer search. But in her case I have quite complete statements from her brother to whom she reported her research and its results and so this evidence is available--not to prove that Annie Laurie is the name but to explain its slender origin on the effort of only one person who had to go to New Jersey to find it. So no help may be expected from either Mrs. Carrie Stewart Mathiot Metcalf or Miss Ida Rosanna Hamaker. In the former case because she accepted Nancy McCollum her report is cumulative of the other evidence--in the latter case it needs a report such as I can prepare. In the case of Jean McConnell the significant point is that of identification. I do not believe that Jean married our Capt. Duncan McVicker but another Duncan McVicker--it is evident that there were others as I think I can show (not in the Revolution). I think that the evidence is preponderantly against that being our Duncan McVicker.

Our problem in New Jersey has been to find Nancy McCollum or traces of the McCollum family to which she belonged.

The N.S.D.A.R. has references to 3 names of the supposed wife of Capt. Duncan McVicker (1739-1818), viz.:

as the wife of the Captain

1 Nancy McCollum under whose name/all members (total 12) have been accepted; this name comes direct and long claimed from family tradition of the descendants of James McVicker (1768-1852).

2 Annie Lauris whose name as the wife was ascribed upon research by Miss Ida Rosanna Hamaker (b.1861) and placed upon a monument which she erected to the Captain and she told Dr. Hamaker the name and he gave it in his sketch as Miss Lauris in Crawford County, Pa. History in 1899. It is this sketch which the N.S.D.A.R. has found and which they interpose as one of the obstacles to new applicants. I will have to do something about it, as I suppose that her research can never be retraced or proved or disproved. She is a patient in a mental sanitarium near Washington and there seems to be no prospect that she can be asked for the source of her research findings. The Doctor (her brother) says that she went to Trenton, N. J. to search. I have the Doctor's statement showing that the sole and only authority for the name Annie Lauris rests upon this report made by his sister, Ida Rosanna Hamaker. She gave no dates and nothing but the name, Annie Lauris as wife of the Captain. Her brother who got it from her only gave it in his sketch as Miss Lauris. Note that this name does not come from any family tradition of these Bedford County Pa. descendants of Captain Duncan McVicker, but it depends upon the single report of only one person, and she had to go to New Jersey to find it as there were no traces in Bedford County Pa. of the wife of the Captain.

3 Jean McConnell as the name of the wife of Duncan McVicker rests upon the incontestible authority of the Will of one, Thomas McConnell, made in Somerset County, Pa., in 1777, wherein said Thomas McConnell in said Will mentions among the other names "my daughter Jean wife of Duncan McVicker." Now the old Wills in New Jersey have been abstracted and published, and it is the record of this Will now found in the Office of the Secretary of State of New Jersey and abstract thereof also published in a Book of Abstracts of Wills and distributed to Libraries, that the N.S.D.A.R. has found and which they also interpose as an obstacle to the new applicants. I admit that the record is incontestible but I have challenged the identification of Duncan McVicker all along and have wanted to find another one.

My theory of Annie Lauris has been that this is the given name of Annie Laurie McCollum called "Nancy" for short, or that it is fanciful, or a poetic pet name for the Captain's wife perhaps applied because the real name could not be found even upon research in New Jersey and the researcher was anxious to have some name to place upon that large monument which she erected and so she chose the name Annie Laurie for the (to her and her relatives) unknown name of the wife. However, our researches have disclosed people of that period in New Jersey by the name of Lawrie or Laurie, so it is up to us to keep on picking away.

My theory of Jean McConnell has been that she married a different Duncan McVicker than the Captain who is our ancestor. We have now found this believed to be different Duncan McVicker who married Jean McConnell and will follow this up.

So now Nancy McCollum is again being rescued from a mythical character to that of the real personage who married the Captain. We have found a Daniel McCollum as a customer in a book of accounts of a store in Pluckemin, Somerset County, 1768-1775. Now it seems that you must have had some reason for your ascribing Nancy McCollum as daughter of a Daniel McCollum, and we have found one now in that region in New Jersey where it is believed that the Captain lived.

When we find these facts sufficiently we are going to file a record of them in Libraries so that they can never get away. Sincerely yours,

Dear Mrs. Gifford:

In June, 1935, I had a very singular experience upon my trip returning from attendance of a reunion of my Class at the United States Military Academy. I had done considerable research in genealogy of my parents' families, and I was particularly interested in the problem of the wife of Capt. Duncan McVicker. So among other projects at Washington, D.C., I went to see Miss Ida Rosanna Hamaker because she had researched in New Jersey and had reported the name of the wife as Annie Laurie. I wished to ask her about the records which she had searched in New Jersey. Upon inquiring for her at the Annapolis Hotel where she had made her home, the clerk told me that she had been expecting me but that she had just two or three days before been taken to a sanitarium. I had received her letter in answer to some inquiries written her some weeks before, but there was nothing in my letter to indicate that I might ever go to Washington to see her. I was referred to her cousin, an attorney in Washington who was acting as her guardian in her business affairs. I was told that she had lived too much as a recluse in her quarters and that had probably caused her mental breakdown. She was living in a private sanitarium, but could not be seen. The clerk of the Hotel Annapolis told me that it was too bad that I had not arrived several days before because he said that it would have pleased her very much to see me. As I understand, she is still in the sanitarium but cannot be interviewed or written to.

A few days later I was in Fayette County, Pennsylvania, where my Mother was born near Masontown in 1849. A cousin took me to Smithfield, a few miles from Masontown. There I inquired for Mrs. Carrie Stewart Mathiot Metcalf, to whom I had been referred by the National D.A.R. Librarian and the D.A.R. Regent for Pennsylvania because Mrs. Carrie Stewart Mathiot Metcalf had researched in New Jersey. However, she had reported the name of Capt. Duncan McVicker's wife as Nancy McCollum. But I could not get to see her. Her son, with whom she lived, said that it was necessary to keep people from seeing her because she too had suffered a nervous breakdown. She had been very active in searching genealogy. According to her son, she had a great mass of records but he may not have known what she had. He claimed that she had filed a report of her searches with the D.A.R. Chapters at Morgantown and Uniontown, but I suppose that all that she had given them was her lineage upon joining the D.A.R. At any rate, I secured by letter later on from an Officer of a Uniontown Chapter the facts that she reported as follows:

"Captain Duncan McVicker born in Glasgow Scotland in 1739
died in Schellsburg, Pa., in 1818
Nancy McCollum born in 1748 - died in 1820
No marriage date given"

Now it may be that Mrs. Metcalf does have notes of her searches in New Jersey that give more than this, but her notes are inaccessible as her son said that he would not touch them for anybody and that he would not let anybody talk to her.

Mrs. Metcalf's dates given as above bear the impress of original research for they are the only correct ones I know of given by those who joined the D.A.R. They agree with the Family Bible record of Alexander McVicker (1773-1832). I am unable, however, to retrace where she got the dates as to Nancy McCollum, for I have assumed that she died in New Jersey before the Captain went to Pennsylvania shortly after the Revolution. However, if she lived until 1820 it is very strange that no record has been turned up about her in Bedford County, Pa. The Captain spent his declining years with his son Alexander McVicker near Schellsburg, Pa., and it would seem strange that there would be no trace at all of his Mother if she lived until 1820.

Dear Mrs. Fulton:

Perhaps you will kindly remember me after a year. I was a guest at your and your father's home for dinner on June 27, 1935, and had a very enjoyable visit and conversation with your father, Mr. M. M. Hopwood, Attorney. Thereafter we called on Miss Ethel Boughner, State Registrar for Pennsylvania, D.A.R.

Upon suggestion of Miss Boughner and yourself, I wrote to Mr. H. B. Mathiot, Smithfield, Pa., requesting consent for release of information from his Mother's papers in the D.A.R. records. He did not reply.

My purpose is friendly to the policies of the D.A.R. and rather in co-operation and furtherance of their purposes and interest in getting historical conflicts in my ancestors' records harmonized, saving in convenience and in many ways for future applications for memberships.

Upon reflection I doubt if there was a report of the magnitude and extent which I had supposed from what Mr. H. B. Mathiot told me. Mr. Mathiot told me that his Mother went into the D.A.R. on 9 or 10 different lines, and if that be so evidently but a small part of her report and data would concern the descendants of Capt. Duncan McVicker (1739-1818).

I have three names given me as names of wife of Capt. Duncan McVicker:

- (1) NANCY McCO LLUM, vouched for by Morgantown West Virginia branch of McVicker descendants (many of whom joined D.A.R. giving her name as the wife), and the name of NANCY McCOLLUM has been handed down to these descendants from at least two grandsons and perhaps the son of Capt. Duncan McVicker, and they do not at all doubt it;
- (2) ANNIE LAURIE, inscribed on monument erected at Captain Duncan McVicker's grave in the Schellsburg Bedford County Pennsylvania cemetery by a great-great-granddaughter of the Captain who over thirty years ago wishing to erect the monument and to place the name of his wife thereon and not having such name not being able to secure or verify the name of such wife from the descendants of the Captain in her home community of Bedford County where he died and is buried went to New Jersey whence he came shortly after the Revolution with 7 sons to Bedford County and to make her researches in New Jersey to obtain the name of Cpat. Duncan McVicker's wife, which name she had inscribed on the monument as having been ANNIE LAURIE;
- (3) JEAN McCONNELL, shown by the New Jersey will of her father dated in 1777 to have been the wife of a Duncan McVicker at that time, but whether this Duncan McVicker is the same Duncan McVicker as the Captain Duncan McVicker (1739-1818) (my great grandfather), I do not at present know as I have no sufficient identification. But this will of Thomas McConnell refers to: "my daughter Jean McConnell, the wife of Duncan McVicker," and it was made in adjoining County in N.J.

The three names above given may all have been the wives of Capt. Duncan McVicker at different times, but I have been unable to obtain any information about any of them except their respective names, hence I am not sure of the record, doubt the identification, and greatly desire to know what if any sources of information may have been given in Mrs. Carrie Stewart Mathiot Metcalf's papers for entrance to membership or in that special report referred to by Mr. H. B. Mathiot as having been made by her and filed with the Society. I presume that she in common with others of the Monongalia County descendants of Capt. Duncan McVicker says that the name of the wife was NANCY McCollum, but does she identify who Nancy McCollum was among the McCollums? If she does not, then I have all that she has upon the subject, most likely. But if she tells who Nancy McCollum's father or parents were in New Jersey, how related to the McCollum family and what McCollum family, etc., that is what I most desire to know.

The reason I have attached such significance to her records in my quest is because that I was referred separately to her papers by D.A.R. ladies who knew the problem I am investigating about the wife of the Captain McVicker who was my great grandfather, both by the National Office of the D.A.R. and the former State Regent of D.A.R. of Pennsylvania. Then when Mr. H. B. Mathiot told of her extensive researches, I supposed that she may have traversed the same ground and much additional ground as I have about the records desired. However, she may merely have ascribed NANCY MCCOLLUM as the wife with nothing further said in her papers.

I enclose copies of my notes taken last June when I was a guest at your home and your father's on this quest.

I will enclose on a separate sheet a memorandum about my great grandfather on my Mother's side of our family, Jeremiah Hill, who also served in the Revolution.

I request that my best personal regards be conveyed to Mr. Hopwood, your father, and to Mr. and Mrs. Harold E. Hopwood.

I am very pleasantly surprised to receive your letter bringing important information.

I. Capt. Duncan McVicker

Mrs. Carrie Stewart Mathiot's record seems to be the most accurate one I have found among all D.A.R. entrants on the service of Capt. Duncan McVicker. In fact, as far as I know, she is the only one who gives the correct dates of his birth and death and place of death, that is, correct as shown by actual research. It may be that she has devoted extra careful and thorough research as claimed to me by her son, Harry B. Mathiot, Smithfield, Pa. All other entrants to the D.A.R. seem to have followed the first record accepted and published in the Lineage Books, and that is wrong in several particulars in different cases. She has avoided these errors and stated what other research reveals.

Mrs. Mathiot is the first I have noted who gives any dates for the Captain's wife, Nancy McCollum, and she assigns 1748-1820. In these last I wonder if she has checked by actual research, or has just assigned reasonable dates? These dates do seem to fit all the facts on the assumption that Nancy was the first and only wife. Not only that, but if correct, these dates overthrow other positive views which I have entertained. I have rather positively believed that Nancy did not come with the Captain from New Jersey to Bedford County, Pa., after the Revolution, when he moved there with his seven sons (and probably some daughters). This I have thus viewed because I found no evidence of any wife of his ever being in Pa., no date as to her burial in Bedford County, and on other general negative state of any data about her in Pennsylvania.

I have corresponded for several years with Dr. W. D. Hamaker, formerly member, and later secretary of the Pa. State Board of Medical Examiners (1895-1912), a great-great grandson of Capt. Duncan McVicker, and who was born and grew up at Schellsburg, Bedford County, Pa. To me, he has importance as a witness from the valued fact that until he was about 20 he practically lived with his grandfather, (another) Duncan McVicker (1799-1879) who was a grandson of the (original) Capt. Duncan McVicker (1739-1818), and who (this grandson Duncan) had practically lived with his (this original) grandfather (Capt. Duncan) for about the first 20 years of his life. The tales and traditions passed from the first grandfather directly to his grandson and from this grandson in turn directly to his own grandson. Thus, there seems to me to be an unbroken line of tradition--I am and have long been corresponding with a man who as a boy talked with and heard from his own grandfather who in turn enjoyed the same privilege with his own grandfather who was the original Captain Duncan McVicker--and so the transmission is ^{relayed} ~~is~~

to me through only two intermediaries--about the least possible number and under the most advantageous imaginable circumstances.

Dr. Hamaker has written me many letters and answered all sorts of questions for me about his grandfather's recollections about his grandfather, the Captain, but there is almost a total dearth of information as to the wife of the Captain. All I have secured can be summed up thus: Dr. Hamaker seems never to have heard of the wife of the Captain among all these traditions. His information given me is that the wife was a "Miss Laurie," and he received that not from his grandfather but from his sister who made researches in New Jersey prior to her erecting the monument on the McVicker-Hamaker cemetery plot at Schellsburg. That is, that was told Dr. Hamaker by his own sister, Miss Ida R. Hamaker. Of course, when one stops to think, this data could all have thus been naturally forgotten and thus lost.

I have heretofore assumed that the Captain's wife or wives all died in New Jersey before he came to Pennsylvania. But your letter shows Nancy McCollum reported to have outlived the Captain two years--until 1820. It now seems that it may be advisable for me to try further search in Bedford County, Pa.

If Nancy McCollum lived until 1820, she either had separated from the Captain and then stayed in New Jersey, or else she had not and so came with him. The better view is that she came with him. But she does not seem to be buried beside him. The Captain died at the home of his son, Alexander McVicker (1773-1832), near Schellsburg, Bedford County, Pa., and he is buried beside Alexander McVicker and his wife (Alexander's) Jane (Taylor) McVicker (1774-1834) in the cemetery at Schellsburg. On the large monument appears the line as to the Captain's wife: "His Wife Annie Laurie" --no dates-- and this information comes from the search of Miss Ida R. Hamaker, made in New Jersey, perhaps 30 or more years ago.

Since you are kindly interested and I can't help but make this letter somewhat long, then in order to make it more clear I will enclose the page copy of the inscriptions on the tombstones in the McVicker-Hamaker plot in the cemetery at Schellsburg. I do not want to unduly take up your time with speculations --only to say that assuming Mrs. Mathiot's dates for Nancy to be correct, I had better have some further search made for Nancy McCollum in Bedford County.

It may be that Nancy was the only wife, that (as suggested by another) that "Annie Laurie" was her given name (and so it was Annie Laurie McCollum), and that Nancy is a substituted name for Annie like Betsy is for Elizabeth.

Then as to the 3d wife (to make this clearer I enclose a page abstract about the wives or which one was the wife, etc), Jean McConnell, since I have thought that she does not fit into the picture because of my doubt that the Duncan McVicker whom she married was the same person as the Capt. Duncan McVicker who was my ancestor, this doubt may serve to eliminate her for the present. She was real and has the best record proof of any, except that to show whether it was the same Duncan McVicker. There were other McVickers in New Jersey. Duncan was a very common name among them. Duncan McVicker had a son Duncan McVicker Jr., and a grandson Duncan McVicker, the son of his son Alexander McVicker. There was another DUNCAN McVICAR even in Pa. in Cumberland County Militia in 1781 (Pa. Archives, 5th Series, Vol.6, page 188-189.)
