Frank Howard, Son of Mann and Alice Howard was born in Ellington April 13th,1908. He received his early education at Ellington High School.

Served in U.S.Army in Europe and Africa during World War 2.

He was a member of the Ellington Congregational Church.

At the time of his death he was employed by the Raine Tool Co., Jamestown

Died Friday, December 27, 1957 survived by his wife and two step-daughters and one brother and two sisters, and his Mother, Alice Howard.

Alice Howard, wife of Mann Howard, was born July 19, 1868 was a life long resident of Ellington, Educated at Ellington Schools.

Died Feb. 4th, 1958 ~~and~~ at the age of 89 years.

Was preceeded in death by her husband, Mann Howard who died August 10, 1951

Survived by one son, two daughters and one sister.

Robert Rublee, -Son of Bertrand and Minnie Rublee was born in Ellington January 25th, 1920. Attended Ellington High School and Cornell University He was a member of Theta Kappa Epsilon Fraternity.

Served as Lieutenant in Air Force during World War 2.

He held various positions with with the Junior Chamber of Commerce in Buffalo.

Served as Deacon and Elder in Lafayette Ave. Presbyterian Church in Buffalo.

At the time of his death, which occurred Feb. 25th, 1958 he was engaged in the insurance business.

He was married and leaves a wife and three children, also his Mother Mrs. Minnie Rublee survives ~~he~~ him.

Marvin LaVerne Clapp - was born in Ellington July 7th, 1879, son of Aaron W. and Mary Smith Clapp. His Father was a veteran of the Civil War.

Vern - as we all knew him - received his early education in the Ellington High School. Later he entered the Albany Law School and was graduated in 1900, and was admitted to the bar in ~~190~~ November of that year. Later he became associated with the Law Firm of Wade and Stevenson, of Jamestown.

Sometime later he withdrew from the active practice of law ~~and~~ to take charge of the Trust Department of the Bank of Jamestown, which position he held until 1945 when he associated himself with Walter H. Edson and Samuel S. Edson under the firm Name of Edson, Clapp and Edson. He retired from active law practice in 1953.

He was prominent in the First Congregational Church of Jamestown serving the ~~the~~ church in various capacities.

He was also a member of the Board of Education of the City of Jamestown for several years and took an influential part in the development of the Beard's program for the continued advancement of Jamestown's Public School system.

We also know that Vern took a very active interest in this association and did all that he could to keep it going.

He married the former Mary White of Kennedy, N.Y. June 27th, 1906 who preceeded him in death in 1952.

In October 1955 he married Mrs. Elizabeth Smith White in Ashby, Mass. who also preceeded him in death in ~~1952~~. June 1956.

Married Mabel Howard of Stockton and was a Farmer by occupation.

Died July 4th,1958, and is survived by his wife, three sons and one daughter and one sister, Bessie M. Anderson.

George S. Anderson - Sone of Aaron and Mary Shaw Anderson died July 17, 1958 at the age of 66 years. Served in World War 1 and was a Farmer by occupation.

He is survived by his wife, Evelyn Burroughs Anderson, and one brother Clair Anderson.

Carlos H. Walters - Born Dec. 4th,1892-Received his early education at Ellington High School. Later attended Ohio Northern University and graduated in 1916 in Mechanical Engineering.

Employed by American Steel and Wire Division of U.S. Steel in Cleveland for 35 years. Instructor in Evening Engineering Classes at Fenn College for 16 years.

At the time of his death which occured March 11,1958 he resided in Lakewood, Ohio. His wife and two sons survive him.

Victor Cross - Born March 22, 1888, received his early education at Ellington High School. Later attended Jamestown High School and took a Business Course.

At the age of 20 he entered the U.S. Mail Service and served as Mail Clerk for 39 years, retiring at the age of 59 years.

He died Sep't 22, 1957 at the age of 69 survived by one son, a sister Pearl Cross and one brother Elton Cross.
