

ALBERT OSBORN BARNES

Was born November 26, 1843, at Deersville, Harrison County, Ohio. Is the son of Dr. James P. Barnes and Eliza Houser Barnes, and the last survivor of a family of ten children. Attended village school till 15. Clerked in store till 16, began teaching and continued till 1870. After two years outdoor employment, resumed teaching and taught ten years in Freeport, read law and was admitted to the Bar in 1882. Moved to Cadiz in 1833, and has ever since resided here actively engaged in the practice of law. Is at present City Solicitor. Has always been an active Democrat, who have honored him with nominations for such high offices as the Judge of Probate, Common Pleas and Circuit Judge and member of Con-gress. The "Judge" has always received unusually large votes, but his party being in the minority, he has never filled the high positions for which he is so ably qualified.



HON. SAMUEL B. McGAV-RAN, M. D.

The subject of this sketch may easily be ranked among the leading physicians of the county, and is today one of its most prominent and public spirited citizens. He is the son of William H. and Elizabeth (Brown) McGavran and was born near Conotton, Harrison County, November 25. 1847. His early education was obtained in the district schools and in Hagerstown Academy. Having to rely mainly on his own resources, he taught achool five years to secure funds to defray a college course. He then entered Scio, graduated in 1869, and began the study of Medicine. In 1870 he entered Cleveland, (Ohio) Medical College, and in 1872 gradusted with the degree of Doctor of Medicine, and with such high honors as to win the valedictorian of his class. He began practice in Bowerston and continued with great success till December, 1882, when he removed to Cadiz. He enjoys a large practice as well as the confidence of the community, both as physician and citizen.



JUDGE JOHN B. WORLEY

Is a native of the county, son of Daniel and Mary (Goodwin) Worley, and was born on a farm in Athens m in 1863. Eus. Taught township, February 4, 186, cated in the district school. for a while and worked on the farm. Graduated from Franklin College and taught for one year. Then spent the summer of '88 in Kansas. Began the study of law under Judge Watter G. Shotwell and was admitted to the Bar in June, 1891. Began practice in Zanesville, but returned to Cadiz after a year, and has lived here ever since. Elected Mayor in 1896; ap-pointed referee in bankruptcy for Harrison County in 1898; resigned to accept the office of Probate Judge, to which he was elected in 1899. Served two terms and then formed a partner-ship with Hon, David A. Hollings-worth, Ex-Attorney General, and now a member of Congress.

Judge Worley stands high as law-yer and jurist. Is an ardent Repub-lican, an elder in the United Presbyterian church, and regarded as one of the high minded, progressive citizens of Harrison county.
