## Queries



When sending queries to us, please include as much information as possible for the person that you're researching. The correct names, dates and location are very important to any search. Sometimes, when possible, a five generation chart would be helpful. The fee for all mailed requests for MAGS members to conduct a research is \$10.00 for each family name researched plus the cost of copies. There is a limit of three(3) surnames. Copies are .15 cents for Xerox copies and .10 cents for microfilm copies. Copies obtained from the courthouse such as deeds, wills, etc. cost from twenty-five cents (.25) to three (\$3.00) depending upon what courthouse office provides the copy.

Certified copies of birth and death records from 1908 to present are certified copies at fifteen (\$15.00) each. No non-certified copies from Health Departments are available in Ohio.

If we can be of service to you, please remit the proper fee for research. We will bill you for the copies when the research is mailed to you.

**The Other Wife of Calvin Chapin**

Calvin Chapin born 22 October, 1780, was the son of Samuel and Sybil Joslyn Chapin according to four pedigrees at Ancestry.com. This Calvin was married to Rhoda Crofoot about 1801. Rhoda died 16 April, 1830. No other marriages are listed for Calvin in these online family trees.

Calvin Chapin appears in Gallia County, Ohio, in 1830. A Calvin, aged 50-60 is listed with a wife, 40-50 (Rhoda?); males aged 15-20 and 20-30, and a female 5-10. A marriage for Calvin to Mary Maloon (Malone) occurred 4 August, 1831, in Gallia.

My interest in Calvin Chapin stems from his marriage to a woman named Adaline Russell. Adaline Russell was the widow of Fountain Russell, whom she wed on 17 June, 1832, in Gallia County, Ohio. They had one son, Morehouse Russell. Fountain Russell died about 1833. On 12 July, 1834, Solomon Shepard was appointed guardian of Morehouse Russell. It appears that Solomon was the grandfather of Morehouse, thus the father of Adaline Shepard Russell.

The Shepards then moved to the Wyandot County, Ohio area. Adaline, as a young widow, probably left with her father. Solomon Shepard died in June, 1840, in Marion County. His estate was administered there. His widow was Lucy, and purchasers in his estate included John Shepard, C. Chapin, Widow Shepard, Clark Shepard, and Richard Malone, among others. At some point, Calvin Chapin moved to Marion and Wyandot Counties. (Calvin's son, Robert P. Chapin, was still listed in Gallia County in 1840.)

On 22 November, 1838, Calvin Chapin had married Adaline Russell in Marion County, Ohio. They are listed in 1840 Pitt Township, Crawford County, then 1850 Green Creek Township, Sandusky County, and finally, Adaline, with no husband, is listed in 1860 Pitt Township, Wyandot County, Ohio. Based on the majority of information from the census records, Calvin Chapin was born about 1780, so it seems most likely this man is the son of Samuel and Sybil.

According to online family trees, Calvin had six children by his first wife, Rhoda: Asenath, Pamela, Amarilous, Robert Park, Samuel Willard, and Mary Jane. Three children are listed with him and Adaline in the 1850 census: John, Luther, and Lucy.

In 1860, Calvin is listed in Green Creek, Sandusky County, with a woman named Cynthia Pratt, 73, born in Massachusetts. They are living next to Samuel Chapin, Calvin's son. In Wyandot County, Adaline appears with her three children. Was there a divorce? (continued on page 8)

Calvin died 28 December, 1864, in Sandusky County, and is buried in Colwell Cemetery. (Photo is available at [www.findagrave.com](http://www.findagrave.com))

Of the children of Calvin and Adaline, John, born January 1840, married and had a family. They were listed in Wyandot County in 1880 and in Cass County, Missouri in 1900. Luther, born about 1845, served in Company M, 3<sup>rd</sup> Iowa Cavalry; a mother's pension was granted on 15 May, 1863. Lucy, born 8 July, 1847, married John Brewer and raised a family in Wyandot County. Lucy Chapin Brewer died on 29 December, 1908; Calvin Chapin and "Adalaid" Sheppard were listed as her parents.

Adaline Chapin is last named in the 1900 census of Wyandot County. She was a boarder in the Milton Meutz house. Her birth was given as April 1814 in New York. Her father was born in Massachusetts, her mother in Pennsylvania. She was listed as widowed and the mother of five children, only two were living.

Adaline Shepard Russell Chapin died 24 July 1900 in Upper Sandusky, Wyandot County, Ohio.

If you have given in the past and have found more ancestors, consider sending in more cards. When two cards are found to have a common ancestor, each member submitting those cards will be notified.

Use only 3 X 5 index cards.

Only one generation to a card.
