#### 2<sup>nd</sup> OGS/FGS Teleconference in Mansfield

The Richland County Chapter in cooperation with the Ashland County, Huron County and Richland County - Shelby Chapters is hosting the third of the OGS/FGS Genealogical Teleconferences, "American Land Records" featuring Sandra Hargreaves Luebking. The teleconference can be viewed in the auditorium of the Health Sciences Building on the campus of North Central Technical College. The teleconference will be held Saturday, November 8, 1997 beginning at 1:00 p.m. and lasting until 4:00 p.m. Registration begins at 12:30. Walk in registration is available. Sandra Lucbking has been a lecturer at the Institute of Genealogy and Historical Research, Samford University. She is editor of FORUM, the quarterly magazine of the Federation of Genealogical Societies (FGS); Carolyn Kuhn Royer: A Memoir; and The Archives: A Guide to the National Archives Field Branches (with Loretta D. Szucs). The latter received a National Genealogical Society "Award for Excellence in Genealogical Methods and Sources." With Mrs. Szucs, she is revising the best-selling reference guide, The Source: A Guidebook to American Genealogy.

The Richland County Genealogical Society was organized in 1959 as The Ohio Genealogical Society. Members had been meeting for some five years. In 1964 it was reorganized as the Richland County Genealogical Society, the first county chapter of The Ohio Genealogical Society.

Meetings are normally held on the fourth Thursday of the month at 7:30 at The Ohio Genealogical Society Library, 34 Sturges Ave. There is no July meeting. The August meeting is usually a picnic on a date to be set. The November and December meetings are combined on an evening early in December.

Any member of the Richland County Genealogical Society who is a direct descendant of an individual who lived before 1840 in the area which was at that time encompassed by Richland County, may become a member of the first Families of Richland County upon the acceptance of an application with proof of such descent and the payment of a fee as set by the Board of Trustees.

The Pastfinder is published four times a year (February, May, August, and November). Members and non-members are encouraged to submit a five-generation chart and other family information, specifying their permission for the information to be published in the Pastfinder. Queries in the Pastfinder are free to both members and non-members.

The following information was taken from Val Greenwood's Researcher's Guide to American Genealogy 1978

"There are no official national records of wars before the Revolution since the United States of America did not exist. The only records which have survived are colonial and local militia records--mainly rolls and rosters. These lists are not extensive nor is the information they contain), but many of those located have been published.....

"In most cases there were no particular benefits given for service except in a few instances. For example, Gov. Dinwiddle and the Council of Virginia offered 200,000 acres of bounty land in the Ohio River Valley to Virginia troops who served in the French and Indian War."

Greenwood lists a number of bibliographies of books about the early wars.

There are many records in the National Archives and many books have been written about the Revolutionary War. Following that war, there are compiled military service records. Please consult a good research book to find if your ancestor's records are available and where. It is amazing the amount of military records that exist. State Archives contain records that are not in the National Archives, especially on the early Indian Wars and the War of 1812.

# **1820 U.S. Census of Manufacturing Establishments**

At the time of the federal enumeration of the population in 1820, a special census was taken of manufacturing establishments. Written instructions given to the U.S. Marshals made it clear that "household manufacturers" were to be excluded, "the occupation of manufacturing being, in such cases, only incidental, and not the profession properly marking the class of society to which such individual belongs." Pre-printed forms were provided, and the enumerators were encouraged to give the form to "some person principally concerned in the establishment, requesting him to give the desired information himself."

The form asked that the following questions be addressed:

Raw Materials Employed

- 1. What kind?
- 2. The quantity annually consumed?
- 3. The cost of annual consumption?
- Number of Persons Employed
  - 4. Men Employed?
  - 5. Women?
  - 6. Boys and Girls?

Machinery

- 7. Whole quantity and kind of Machinery?
- 8. Quantity of Machinery in operation?

#### Expenditures

- 9. Amount of capital invested?
- 10. Amount paid annually for wages?
- 11. Amount of Contingent Expenses?

#### Production

- 12. The nature and names of Articles Manufactured?
- 13. Market value of the Articles which are annually manufactured?
- 14. General Remarks concerning the Establishment, as to its actual and past condition, the demand for, and sale of, its Manufactures.

The answers given on those forms have been copied by Kerry Kimberly from microfilm copies available at the Ohio Genealogical Society Library, 34 Sturges Ave., Mansfield, OH.
