## The Beginning Of A County

#### continued from our last issue - original spelling retained

Tuesday Sep. 7, 1813 - The Board met pursuant to adjournment and present as yesterday. The Board proceeded to the appointment of a County Treasurer in the room of Levi Jones deceased, when John Pugh was clearly appointed, who came forward and gave bond for his faithful performance as such.

On the returns of the view and survey of a road leading from town of Mansfield to Jacob Banes Mill of which the returns make favorable report, ordered that said road be and the same is here by made a public highway and that the same be opened and kept in repair as such.

Treasure to pay Geo Coffinberry \$1.50 for viewing the road above granted. Treasure to pay the following persons the sums annexed to their names for the services likewise annexed on the road above granted.

John Wallace \$1.50 & Jacob Beam \$.70 - chain and receivers.

Hugh Cunningham \$1.50 & Joseph Meddleton \$.70 - bearers.

Michael Beam \$.70 - marking.

Wm. Riddle \$4.50 - for surveying, platting and returning.

Wm Cass and two sons \$2.10 - chain bearers and marking.

On the return of a road from the house of Wm Gass to intersect the road leading from Mansfield to Delaware at or near the 20 mile tree on which the viewers report favorable. Ordered that said road be and the same is being made a public highway and ordered to be opened and kept in repairs as such.

Treasurer pay the following named persons the sums annexed to their names respectively for stated services by them performed on the above road.

Wm Riddle \$3.00 - for Surveying, platting and returning

Russell Culver \$.70 - chain

John Brubaker \$.70 - bearers

Levi Jones \$.70 - marker

On the return of a view and survey of a road from Frederick Hurons Mill to intersect the road leading from James McClures to Amariah Watsons at or near the house of Samuel McClure on which the viewers report favorable. Ordered that said road be and the same is hereby made a public highway and that the same be opened and kept in repair as such.

Treasurer to pay the following named persons the sums annexed to their names respectively for stated services by them performed on the above road.

Wm Riddle \$3.00 - surveying, platting and returning

Treasurer pay Andrew Coffinberry \$9.75 for all his services heretofore performed as Clerk to the Commissioners and for recording all the business made ready for record at or before the present session.

The Board having examined the work by Luther Coe and Wm Roberts to the block-house in Mansfield do order that the said Luther Coe and Wm Roberts receive and order on Winn, Winship, the agent of James Hedges for the amount of the consideration by said Board agreed to ----- amounting to \$48.00 which is ordered to be ----out of ----- in which said Hedges agreed to pay for the use of public building, in the town of Mansfield.

The board do appointed Samuel Hill lister of the taxable lands in the County of Richland.

Treasure pay Geo. Coffinberry, Andrew Coffinberry \$2.75 for furnishing two books, one for the use of the Court of Common Pleas and the other for the Commissioners.

Ordered that the Board do adjourn without appointment. Melzar Tannehill, Samuel Watson

A Board of Commissioners met at Mansfield on Thursday the 9<sup>th</sup> day of September in the year of our Lord 1813. Present Melzar Tannehill, and Samuel Watson Esq. Treasure pay Geo. Crawford \$2.00 for setting as Judge of the April election 1813 and returning the poll book of same.

Treasure pay Thos. Coulter Esq. \$1.00 for setting as clerk of the election in Green Twp. on the 5<sup>th</sup> day of April 1813.

Treasure pay Thos. Coulter Esq. \$1.00 for setting as clerk of the election in Green Twp. on the 20<sup>th</sup> day of April 1813. Ordered that the Board do adjourn. Melzar Tannehill, Samuel Watson ....to be continued

#### The Death of the Mansfield's Pioneer Son

Although he was instrumental in the history of the county there is no stone to mark the gravesite of Mansfield H. Gilkinson, the first white male born in Richland County. Local ancestors of Mr. Gilkison are interested in contacting other ancestors and historians to help in the raising of funds to place a memorial stone on his grave. The following article appeared in the local paper at his death.

Death of the Pioneer Son of Mansfield Born: February 2d., 1811 Died: February 23, 1885 Aged 74 years and 21 days

On Tuesday last many of our readers were startled at the above announcement of the death, and notice of the funeral obsequies, of Mr. Mansfield H. Gilkison. The old must die, the young may, and most certainly Mr. Gilkison's life was prolonged beyond the average age of man, but it is not specially the fact of his many years that THE HERALD desires to note. It is always a melancholy pleasure to record the death of friends, and it is especially so when the demise is that of an aged citizen.

It is a fact known to most of the readers of THE HERALD that Mansfield H. Gilkison was the first white male child born within the limits of Mansfield, and that his days span all the years from the early beginning of the village down to our present growth and extent as a city.

His grandparents on his mother's side were George Coffinberry and wife, who in 1809, came to this then new country from Lancaster, Ohio, having previously moved from Virginia. His father, Jno. C. Gilkison, was of North Carolina parentage. He first moved to Kentucky, thereafter to St. Clairsville, and in 1810 to Mansfield.

On both sides he was of pioneer stock and he inherited many of the sterling qualities of these brave early settlers. Fear of man was an unknown feeling to Mansfield H. Gilkison. His father was a mason by trade, but had acquired much of a practical knowledge of the printing art, and so the son was adept both as a brick-mason and type-setter. THE HERALD, in this connection, is informed, and takes pleasure in putting on record the fact, that the father of our deceased friend was the very first to print and publish a newspaper in the county of Richland, and we would be glad to have a copy of "THE OLIVE" for that was its title, so as to re-produce it in our columns. The son, as he grew up, worked with his father, in the summer season at brick-laying, and in more inclement weather in the printing office. THE OLIVE afterwards became THE MANSFIELD GAZETTE, and passed into the control of our now venerable townsman, James Purdy, Esq., but later on Mr. Jno. C. Gilkison, with his sons, projected the RICHLAND COUNTY JEFFERSONIAN, and for years were its publishers and editors. In 1850, they retired, selling the whole plant to the firm of Day & Smith, composed of our friends M. Day, Jr. and E.W. Smith, who gave the paper a new name, THE MANSFIELD HERALD, which title, under them and their respective successors, it has since retained.

Mansfield H., when a young man, was married to Miss Dukes, a member of another pioneer family, and who preceded him to the "far off country". His children grew to manhood and womanhood, and formed alliances and established homes of their own, so that for many years since the death of the wife of his youth, the subject of our sketch was alone and lonely, and only within the year passing he was again married to her who is now his bereaved widow.

Mr. Gilkison has filled many official places in his long life requiring coolness, courage, and a determined spirit, such as marshal, constable, deputy and acting sheriff, and discharged the several duties well and acceptably by all.

He was a member of I.O.O.F. -- Mansfield Lodge, No. 19. His funeral obsequies were attended by the Order on Wednesday, and so peacefully midst the snows of winter, was this old friend, the first child of Mansfield, laid away in his final resting place, the grave -- resting place for all the weary sons of men. It is fitting that we chronicle his birth, his life, his death. One by one, they who were the pioneers, or children of the pioneers, take their departure.

On the 4th. of July, 1881, there was a gathering of our people in the park to unveil the monument. Of those there assembled was our departed friend, with many of the older citizens, the friends and associates of early days and manhood's years. Since then, of what number how many have died: John Wiler, John Y. Glessner, David Vasbinder, Samuel Snyder, Dr. Sutherland, Thos. J. Robinson, John Krause, Peter Remy, Alanson Allen, Barnabas Burns, Charles Krabill, J.A. Heldman, E. Clapp, David McCullough, Jacob Emminger, preceded him, and now Mansfield H. Gilkison joins the throng. The old men are fast passing away; the pioneers of Richland County are nearly all gone hence. We who survive should cherish their memories and imitate their virtues. - 19-Jan-1905 8:6 RUSSELL Mr. and Mrs. Harry RUSSELL are happy over the advent of an 8-pound daughter, born Thursday.
- 19-Jan-1905 12:2 LEITER Samuel B. LEITER, of Lucas, well known in Mansfield and throughout Richland county, met with an untimely death Saturday afternoon. Mr. LEITER resides along the Pennsylvania railroad about one mile west of Lucas. While upon the track about 2:20 p.m. Mr. LEITER was struck by a train and instantly killed. Mr. LEITER, according to information secured by the coroner, went out upon the railroad track at the point known as Leiter's crossing to gather up some coal which had been dropped by a passing freight train. He was on what is known as the center track, there being three railroad tracks at this point. Until recently this center track, it is stated, has been used as a siding. It is supposed that Mr. LEITER heard the second section of westbound P. F. train, No. 17, which is a fast express train, approaching but thinking he was on the siding waited until it was too late for him to escape. The engineer and fireman saw him on the track. The whistle was pulled and the continued whistling attracted the attention of people nearby and the victim was immediately picked up and carried to his home. Mr. LEITER was 58 years of age. He was well to do and leaves a wife and two grown up sons. Mr. LEITER was a member of the Richland county board of deputy state supervisors of elections, the Republican county central committee, and two Masonic organizations, Venus lodge, No. 152 and the Chapter, No. 28, of this city. Funeral Tuesday afternoon at 2 o'clock under the auspices of the Masonic fraternity, with the Rev. Murphy, of Mt. Zion church, officiating and burial in the I.O.O.F. cemetery at Lucas. [edited]
- 19-Jan-1905 12:2 HOLMES Mr. and Mrs. Walter HOLMES, 21 Flint street, are the proud parents of an 8 1/4 pound son, born Monday morning, their first anniversary.
- 19-Jan-1905 12:2 CANTLEBARY Dr. P. F. CANTLEBARY, aged 78, died Jan. 3 and his wife, Priscilla Grove CANTLEBARY, aged 75, died Jan. 8. Both were buried at Marengo. They were united in marriage Nov. 15, 1850.
- 19-Jan-1905 12:2 COLE Barnet COLE, a prominent resident of Upper Sandusky, died suddenly Saturday noon with neuralgia of the heart. Mr. COLE was 68 years of age, the father of Mrs. Emmet STERNER, of this city.
- 19-Jan-1905 12:2 GREENWALT Leo GREENWALT, aged 25, of Larue, died after a three days' illness with measles. He was so interested in a revival meeting that he drove through a storm Tuesday night after the measles had appeared. He caught a severe cold which brought on sudden death.
- 19-Jan-1905 12:3 CASSEL Mrs. Sarah CASSEL, one of the oldest residents in Crestline and vicinity, died Wednesday at the home of her daughter, Mrs. John ALTAFFER, on West Main street, Crestline at the age of 86 years. She was one (?) pioneers of that place and had (?) there for many years. She was a widow of John CASSELL, a prominent farmer who resided near Crestline and whose death occurred a number of years ago. David CASSELL, a Crestline hardware merchant, is her son and she has several children holding positions on the Pennsylvania railroad, one of them, Frank CASSELL, being baggageman at the Pennsylvania depot there.

- 26-Jan-1905 2:2 MANZER Andrew MANZER, 77, former councilman from the Fourth ward and a prominent citizen, died Monday after a linger illness.
- 26-Jan-1905 2:6 KINCAID Rachel KINCAID was born in Monroe township, Richland county, Dec. 28, 1819, and died Jan. 21, 1905, aged 86 years. She is survived by one daughter, Mrs. Minerva NAGLE, and the following grandchildren: Mrs. Charles DICKSON, Mrs. William SCHRACK, Mrs. William ACKERMAN, Mrs. John YOUNG and George NAGLE, of this city; Edward NAGLE, of Waterloo, Ia.; Mrs. Err STUCKMAN, of Heidleberg, Pa.; Mrs. Dr. T. N. PATTERSON, of New Washington, and Daniel NAGLE, of Columbus. Services at the home of Mrs. C. DICKSON at 2 p.m. Monday, conducted by the Rev. A. B. Markley.
- 26-Jan-1905 2:6 PAESSLER Helen, three-year-old daughter of Mr. and Mrs. Herman PAESSLER, of Bowman street, died Sunday evening about 10:30. Friends will remember the child's mother as formerly Miss Anna CROFT. Funeral from the house Tuesday afternoon at 1 o'clock. The Rev. S. P. Long will have charge of the services.
- 26-Jan-1905 2:6 WHALEN The death of Mrs. John WHALEN occurred Tuesday at 2:30 o'clock at her home on North Broadway. The deceased was aged 65 years and is survived by a husband and two children. The funeral will be held Thursday morning at 3:30 o'clock from the St. Mary's Catholic church, Father Leahy officiating. The interment will occur in the Catholic cemetery. Death was the result of heart disease.--Shelby Globe.
- 26-Jan-1905 2:6 SUMMERVILLE Benjamin B. SUMMERVILLE died at the home of his son, A. J. SUMMERVILLE, 317 West Third street, at 3:35 a.m., Thursday, Jan. 19, aged 83 years. The deceased was born in Beaver county, Pennsylvania, and came to Holmes county, this state, when a lad of 15. At the age of 21 he went to Hardin county, where, and in Hancock county, he lived and farmed until by reason of age and infirmities he and his wife came to this city to live with his son and only child, Mr. SUMMERVILLE, in October, 1901. Mrs. SUMMERVILLE died Dec. 18, 1902. Her aged husband, ever of strong and rugged constitution, has been failing for some years by reason of advanced age. Funeral at 2 p.m. Saturday, Jan. 21.
- 26-Jan-1905 2:6 ROBB Mrs. Catharine Elizabeth ROBB, wife of the Rev. Dr. W. A. ROBB, of Jamestown, died Jan. 16. The deceased was the mother of Mrs. Abbie FINDLEY, wife of the Rev. F. D. FINDLEY, pastor of the United Presbyterian church in this city.
- 26-Jan-1905 2:6 ARNOLD Albert Douglas ARNOLD died Wednesday morning about 5 o'clock at his home in Ausdale, aged 29 years. Mr. ARNOLD traveled for the Oliver Chilled Plow Co. and contracted malaria in the south last summer since which time his health has been failing but had only been seriously sick about ten days. Mr. ARNOLD was a member of Courtney Camp, No. 3505, Modern Woodmen of America. He leaves a wife and three children, Albert, Dorothy and Katherine.
- 26-Jan-1905 2:6 LaDOW Amos LaDOW, father of Jesse E. LaDOW the local attorney, died suddenly Tuesday afternoon. Mr. LaDOW was visiting at the home of his granddaughter, Mrs. H. J. JOHNSTON, at Haskins, in Wood county, a few miles from Toledo and less than a week ago he was seized with an attack of pneumonia. Mr. LaDOW was about 78 years of age. He was born in Plymouth and lived there all his life. The wife of the deceased died about three years ago also of an attack of pneumonia. Mr. LaDOW leaves several grown children: L. W. LaDOW and B. E. LaDOW, of Kansas City; J. E. LaDOW, of Mansfield, and Mrs. W. H. SPENCER, of Sandusky. Short services will be held at Haskins, in Wood county, before the funeral party leaves there Thursday morning. Upon arrival at Plymouth a funeral service will be held and the remains laid to rest in the Plymouth cemetery.

## Richland County Wills

Volume 4
Compiled by Nancy Hidinger

## James Armstrong, Richland Co., [pg. 118], October 7, 1859 - April 3, 1874

First, All debts, funeral expenses and cost of the erection of a tombstone monument are to be paid out of my Estate. Second, I give and devise to my beloved wife in case she survives me all her interest in my Estate real and personal. Third, after the decease of my wife the sum of one thousand dollars be paid to my grandchildren, Louisa Marlow and James Marlow children of my late daughter Sarah Marlow, deceased, provided both be of age at my wife's decease. If they are not of age, I direct my Executors put said sum of one thousand dollars at interest in good Real Estate security to be paid them when they become of age or in case of their decease that sum to be paid to my daughter, Louisa Armstrong Brown. Fourth, I direct that after the decease of my wife and that my two brothers John Armstrong and William Armstrong shall be then living that they shall each be paid the sum of fifty dollars. If either are deceased before the death of my wife, the survivor is to be paid one hundred dollars. Fifth, After the decease of my wife I direct that Eliza Stewart and Mary Graham (daughters of my beloved wife) each to receive the sum of one hundred dollars. Sixth, It is my will that after my wife shall decease that my only surviving daughter Louisa Armstrong Brown shall have all of the rest and residue of my Estate both real and personal, and that at her decease that it shall go to her children. Seventh, my Executors are to keep possession of and exercise control over my personal Estate until after the decease of my wife. Eight, I nominate and appoint my wife Elizabeth Armstrong and my friend Andrew L. Grimes as my Executrix and Executor of my last will and testament. Witnesses: Edward Sturges, Sen., John Wood.

#### Sarah A. Watson, Richland Co., [pg. 120], February 15, 1874 - April 4, 1874

I give and bequeath to my sons John and Levi, and my daughter Eliza, all of my Estate which I own and possess at my decease, provided that they pay all just claims against me and my Estate after my death and furnish and place at my grave suitable grave stones, with inscriptions to commemorate my memory. Second, I do not want my daughter Sarah A. to have any part of my Estate, for the reason that she persist in going to, and living in the Poor House, when there is no necessity for her doing so, and I do not want any part of the earnings of my life to be wasted in that way. Witnesses: Reuben Evarts, Isaac Fike

### Joseph Hildreth, Richland Co., [pg. 121], October 26, 1873 - April 11, 1874

First, it is my will that funeral expenses and just debts be paid from my Estate. Second, I bequeath to my beloved wife Mary all the household and kitchen furniture, beds and clothing to dispense of as she may think proper and sufficient of the rents profits or interest of my Estate for her comfort. Third, I bequeath to my son Thomas three hundred dollars and the amount received as charged in my book account to my heirs, also my Masonic gold jewel which he has received. Fourth, I bequeath to my daughter Jinnet Worden four hundred and thirty five dollars, one hundred of which I owe her and the thirty five being part of fifty dollars I promised her when taking care of me. It is my will that her adopted daughter Flora Alsce Gregg shall inherit from her as though she was the lawful issue of her own body. I also bequeath to Jinnet her book account as charged against her. Fifth, I bequeath to Daiy Hildreth the oldest child of my daughter Mary, one hundred dollars to be put into some savings until she arrives at lawful age. If she should die without leaving lawful issue the money shall be equally divided between my four children Nixon, Mary, Ruth and Lieucinah. Sixth, I bequeath to my son Nixon my silver watch. Seventh, my four children Nixon, Mary, Ruth and Lieucinah shall be made equal on my book accounts and that Mary Hildreth shall receive one hundred dollars less than the other four children for reasons transpiring last winter in part and that there be no interest charged on book account. Eighth, the balance of my estate after paying bequests is for the support of my wife shall be equally divided between my four children Nixon, Mary, Ruth and Lieucinah. Executor: John S. Neel. Witnesses: George W. Cole, A.E. Keyes. [John S. Neel signed Joseph's name to will at his request as Joseph was blind]

John Hilton, Mifflin Tp., Richland Co., [pg. 123], September 26, 1873 - April 17, 1874

I devise that all my credits be collected and all debts be paid, including my funeral expenses and those of my

last sickness. Second, I devise to my beloved wife Alcy Hilton all my real Estate it being ninety five accres of land, more or less, laying in the West part of the Northeast quarter of Section six in Mifflin Tp., Richland Co. together with all privileges and appurtenances for her own benefit. Third, I devise to my said wife Alcy Hilton all my horses, cattle, hogs, sheep, farming implements, wagons, carriage, household and kitchen furniture and goods and moneys, notes, duebills, bonds to have and use as she may see proper. Executrix: Alcy Hilton, wife. Witnesses: George Roberts, Charles Osbun.

#### Edward T. Hunt, Richland Co., [pg. 127], December 18, 1872 - April 27, 1874

I give to my friend Frank Standish Bradford, M.D., of New Your City, whatever medical or physiological books of my library he may select and also my Shakespeare, eight vols and all my Shakesperian literature, and the steel engraving "Shakespeare and his Friends." I give and devise to Dr. Wm C. Parks, of Williamsburg, New York, Lessings History of the Revolution, two vols, the steel engraving of Geo. Washington, (published by William Pate, 16 Burlingslip, New York) Abbotts Life of Napoleon, two vols, and the Portrait of Napoleon. I give and devise to Mathias Plum, of Newark, New Jersey, the oil painting presented to me by Frank Howland in South Adams, Mass., also the Pictorial History of England, four vols and Greeley, The Great Conflict, two vols. I give and devise to Rev. Ralph H. Bowles, of Greenbush, New York, my writing desk, my set of the Christian Review, what vol I have of the Bibliothica ---- and of Langs Commentaries. I give and devise to my sister, Mrs. J.C. Guild, Providence R.I., the steel engraving LaMadonna di san sista, and Baileys Festus; to my brother in law, Reuben A. Guild, my sett of Appletons Cyclopedia with the vols. annually published and Hamiltons History of the United States; to my Niece, Miss Jennie C. Guild, my Pictorial Bible, Miss Bremers works (four vols Bohns library) The Flowers of the Bible, one vol., and my inlaid Japan wood glove box; to my Niece, Miss Georgie Guild, Bohn's Classical Library; to my Niece Olive Guild, my specimen of Coral, Mant and D'Oyles Bible, three vols., and the small oil painting presented to me by Miss Eva Hatch of Springs, New York; to my Nephew Samuel A. Guild, my gold watch (enameled face) and to my Nephew Lawrence Guild, Sparks American Biography two setts, in both twenty five vols.; to my Brother in Law, Isaac Van Hagan of Chicago, Ill I give the History of Inventions and Industry in the U.S., one vol., Lord Byrons Poems, ten vols and the Works of the "Country Parson, four vols. To my Sister in Law, Mrs. Sarah Tomlinson, of Plainville, Conn., my chrome (not framed) and my parlor clock; to my Newphew, John Van Hagan, of Troy, N.Y. whatever vols of Bohns Scientific Library he may wish; to my Nephew, Edward L. Harris, of Plainville, Conn, the chrome of a water scene, and the Portrait of Washington (steel engraving, not framed); to my Nephew, George Harris, Abbotts History of U.S., seven vols, and to my Niece, Miss Katie Harris, the interest of my bank stock in Providence, R.I. for three years (should she be disposed to use it for her education, musical or otherwise to be controlled by her Aunt Anna M. Hunt.)

To my beloved wife, Anna M. Hunt, all my household furniture, not above given and all the rest of my private property after debts have been paid, this gift and devise includes all bank stock, bonds(2) & etc. Executors: Reuben A. Guild, Providence, RI, Isaac Van Hagan, Chicago, Illinois. Witnesses: J.L. Lambert, J. Henry Baker [Will was made while residing in Hoosick Falls, N.Y., affidavits were given by both witnesses]

#### Robert Stairs, Richland Co., [pg. 130], February 29, 1860 - April 29, 1874

It is my will that just debts and funeral expenses be fully paid. To my beloved wife Elizabeth Stairs I bequeath the farm on which we now reside in Butler Township containing about 80 acres also about 31 acres laying South and opposite the above farm, a part of Section 26 in Butler township during her natural life. She is also to receive all live stock, horses, cattle, sheep, hogs & etc now owned by me, the household and other items not particularly mentioned in this will. On the death of my said wife all the property herefore said so much thereof as may remain unexpended at her death to my five daughters as follows, to Lettice Vanhorn eight hundred dollars, to Mahala Stairs five hundred dollars and to Anna Umstead fifty dollars, and I bequeath to my four sons, David Stairs five hundred dollars, to Robert Stairs, Jr. five hundred dollars which he has received, to Mitchel Stairs five hundred dollars which he has received, to Milo Stairs forty acres of land which he has received. If any more property or money should remain at the death of my wife than the above mentioned I bequeath it to my two sons Robert Stairs, Jr. and Mitchel Stairs to be equally divided between them. I further say that my two sons Robert and Mitchel Stairs is to take possession of the five hundred dollars that I have willed to my son David Stairs at the decease of my wife, each to have an equal share of it in their hands and if David Stairs should never call on the five hundred

dollars they are to keep it as their own, but if he should or his children then they are to pay it over to him or them. Executors: Robert Stairs Jr., Mitchel Stairs, sons. Witnesses: Margaret Rice, John Rice, the only surviving witness.

James Cotter, Richland Co., [pg. 132], April 8, 1874 - April 30, 1874

I give and devise to my beloved wife Elizabeth Cotter all my Estate both personal and real until my son Charles Cotter comes to the age of twenty one, then I desire that all my property be sold both personal and real except for my household goods and furniture. I give to my wife Elizabeth Cotter all my household goods, furniture and two thousand dollars in money and the balance of my Estate I desire to be equally divided among our children Isabel Loucks, W.M. Morrow, John Cotter, Marion F. Cotter, J.C. Cotter, C.D. Cotter. Executor: J.C. Cotter, son. Witnesses: P.B. Ward, Jacob Crabbs.

To keep the integrity of the will, spellings are printed as they were written in the will book.

Arnett, setting forth that at the time of their marriage he went by the name of Charles Arnett when his real name was Ambrose Mickle Arnett, and that a the time of their marriage the defendant had a former wife living with whom he was legally intermarried. She further asks for the custody of their child and to be restored to her maiden name, that of Florence Marks. [Mansfield newspaper - Jul 15, 1882]

The county provided pensions for mother's who were not able to provide for their family upon the death of their husband or if the husband was an invalid. If your ancestor received a mother's pension you will find a wealth of information in these records. Petitions for pensions were filed January 1915. **Unless otherwise indicated a child's birth occurred in Mansfield.** Mother's Pension records are found in the Common Pleas Court Office in the Richland County Courthouse.

Oct 25, 1906 in Shelby, Paul R. b. Oct 14, 1906 In Shelby. Pension of \$6.00 per month which was discontinued Oct 16, 1915. Lucy married Charles R. Bricker, Oct 16, 1915. [pgs. 1-4]

Myrtle Hoffa, b. Sep. 2, 1877, husband James E. died May 25, 1914. Four children Vera E. b. May 5, 1903, Thelma D. b. Nov. 5, 1905, Dale E. b. Sep. 10, 1913. Pension of \$7.00 for 6 mo. which was extended with modifications until Nov. 1920. [pgs. 5-8]

#### Remains Brought Home

Bringing with them a little box not more than a foot long and eleven inches wide, E.W. McCready, A.A. Douglass and James Reed arrived in Mansfield, Tuesday night from Salamanca, N.Y. where they had gone to find the body of Robert McCready, of whose horrible death in the wreck of the Erie fast train No. 4, early Monday morning have been given in previous accounts.

Arriving at Salamanca about 3 o'clock Tuesday morning, he said "they went to the hospital but did not find Robert's body there. We were told to see a man named Edgar Reynolds and did so. He told us he saw McCready not long before the accident go into the smoking car, which was back of the mail car. He had finished his work of weighing mail at Jamestown, and was going on to Salamanca the end of his run."

"We went to the morgue and there found the remnants of six or seven bodies. We looked over the belongings of each and found Robert's watch and chain, part of his glasses, a bunch of keys and recognized the filling in a couple of teeth. No inquest had been held and we importuned the coroner to let us have the remains and he finally agreed. They were boxed up in the little box which we brought with us and have taken to the home of Warren McCready, uncle of Robert."

"We went to Jamestown and interviewed one Jacob Cleminger, of Gerry, he related his experiences in the wreck. He is a mail clerk and he told how he saw McCready with whom he was acquainted, sitting in the smoking car about two seats in front of him on the opposite side of the car. He saw him go down in the wreck. Mr. Cleminger was injured and the only thing that saved his life was that he was in a double seat which toppled over him and saved him from the flames, until he could be rescued. He saw McCready in the flames but could not get at him to help him. It certainly was a horrible thing. At Jamestown we obtained passes for ourselves and one for the remains." [Banner & Shield - Apr 22, 1903]

#### Mexican War Veterans

There were 78,718 American soldiers in our war with Mexico. Of that number Richland county contributed 247 of her sons to the army which invaded Mexico in 1846-7. In 1906 only five survived. They received a pension of \$10.00 a month from the government for their service. Those survivors were:

Jacob Oyster, who resides on a small farm a mile north of Bellville. He served in Capt. George Weaver's company, Fourth Ohio infantry, and was in nearly all the battles of the Mexican War. He also served in the Civil War. Mr. Oyster has grown old gracefully and is happy in the love and care given him by his wife and children.

Samuel Wirts, another of the veterans resides on the Mansfield-Olivesburg road just this side of Oakland church. Mr. Wirts enlisted in Capt. George Weaver's Co. D, Fourth Ohio infantry, May 22, 1847, and was mustered out of service at Cincinnati July 15, 1848. Mr. Wirts is the father of Mrs. B.F. Palmer.

John Rohme of Lucas is also a Mexican war veteran. He enlisted May 28, 1846, and was a member of Captain Ford's Co C of the Third Ohio infantry. During its service the regiment lost sixty four men. Mr. Rohme also served two enlistments in the Civil War. He was in the employ of the Pennsylvania railroad company for many years and is now on its retired list.

Samuel Frey of Shelby another Mexican war veteran, served in the Seventh U.S. Regulars. He was first under fire at Contreas, August 19 and 20, 1847, then in the battle of Churubusco, the battle of El Moline del Rey and supported the attacking party that took the lead to the City of Mexico which they entered in triumph on the morning of the 14<sup>th</sup>. Sergeant Frey has been a resident of Shelby for fifty years, twenty nine of which were passed in railroad employment at the Junction, where for seventeen years he was a bill clerk.

Another veteran is William Furgeson, who volunteered May 23, 1848, in Captain McLaughlin's Co. A Third Ohio Infantry, and was mustered out of service June 24, 1847. Mr. Furgeson was a brave soldier and passed through the hardships

incident to the campaign through which his company served. He resides with his wife in their handsome home at the corner of Wayne and Orange streets, this city. [Richland Banner & Shield - March 8, 1906]

#### 50th Anniversary Celebration

The fiftieth marriage anniversary of Mr. John Fleming and wife, of Washington Tp, was celebrated at their home on Thursday, June 9<sup>th</sup>. Mr. & Mrs. Fleming came from Cumberland county, Penn., to Ohio about the year 1834, and after a temporary residence at other points, settled into their present home in Washington Tp in the year 1838.

Both are 79 years old. Mr. Fleming owns a farm, but is a shoemaker by trade, and still plies his craft with his wonted skill. He has had scarcely a day's serious illness in his life. Mrs. Fleming has also been a person of remarkable strength and endurance, but has lately been afflicted with rheumatic troubles which compel her to keep to her arm chair much of the time.

Notwithstanding the unfavorable weather there were by actual count more than one hundred persons present. Some had come from distant points among whom were Mr. Wm Jeffries and wife, of Warsaw, Indiana; Mrs. Horace Tucker, of the same place; Mrs. Wm Taggart, of Van Wert, O; and Mr. James F. Snoddy, of Westerville, O.

A large table was spread in the house, a larger one in the yard, both were loaded with all that could tempt the palate. [Mansfield Herald - June 23, 1881]

Mrs. Elizabeth Ray, mother of Mrs. John Darling, died of cancer in the face and was buried at St. John's Cemetery, Mrs. Ray was born in County Down, Ireland, December 25, 1792. She moved to Monroe tp. at an early date and was one of the oldest pioneers of the county. She suffered many long years. [Mansfield Newspaper-May 12, 1881]
