A Memorial to be Registered pursuant  
to the Laws of the Province of Upper Canada  
Of an Indenture of Bargain and Sale  
bearing date the twentyfifth day of September in  
the year of our Lord one thousand eight hundred  
and eighteen and made at Charlottsburgh in  
the County of Glengarry in the Eastern District  
of the said Province between Allan McDonald  
of the said Township of Charlottsburgh in the  
County, District and Province aforesaid a woman  
of the one part And The Reverend Alexander  
McDonnell, the Reverend John McDonnell, Alexander  
Fraser, Donald Fraser and Angus (Roy) McDonnell  
of Charlottsburgh aforesaid and Donald McDonnell  
of the Township of Cornwall Esquire and Captain  
John McDonnell of the Township of Lancaster  
Trustees for and in behalf of the Roman Catholic  
Congregation of Saint Raphaels in the said  
County of Glengarry of the other part Whereby  
after reciting that it is the intention of the said  
Congregation to erect build and set up a Church  
at Saint Raphaels aforesaid and that it is the  
desire of the said Allan McDonald to afford every  
assistance in his power to accomplish or facilitate  
so laudable an object, he the said Allan McDonnell  
as well to further and encourage the Building  
of the said Church as for the consideration of  
twenty pounds of Lawful money of Upper Canada  
to him in hand paid by the said Trustees, the  
receipt whereof is acknowledged hath granted  
bargained, sold, aliened, transferred, conveyed and  
confirmed unto the said Reverend Alexander  
McDonnell, Reverend John McDonnell, Alexander  
Fraser, Donald Fraser Angus (Roy) McDonnell  
and Donald McDonnell being such Trustees as aforesaid  
and to their Successors as Trustees of the said  
Congregation for ever all that parcel or tract  
of land situate lying and being in the Township  
of Charlottsburgh in the County of Glengarry in the Province of Upper Canada

District aforesaid being composed of a part of Lot number eight in the seventh concession of the said Township of Charlottenburgh and being better and bounded or otherwise known and described as follows that is to say Commencing on the south side of the Kings Highway at the distance of one hundred and sixty five feet from the limit between Lots numbers seven and eight in the said seventh concession Then South twenty four degrees east three hundred and fifty feet; then in a direct line parallel to the Kings Highway one hundred and sixty five feet to the said Limit, Then along the said Limit to the Kings Highway and from thence along the Kings Highway westerly one hundred and sixty five feet to the place of beginning together with all Houses, out Houses woods and waters thereon erected lying and being and all and singular the hereditaments and appertinances thereunto belonging or in any wise appertaining and the reversion and reversionary remainder and remainders rents issues and profits thereof And all the estate right title interest claim property and demand whatsoever either at Law or in Equity of him the said Allan McDonald of in to or out of the same and every part or parcel thereof To have and to hold the said parcel or tract of Land and premises freed and discharged from all Incumbrances whatsoever unto the said Reverend Alexander McDonald, Reverend John McDonald Alexander Fraser, Donald Fraser Angus (Roy) McDonald and Donald McDonald as Trustees as aforesaid and to their Successors as Trustees of the said Congregation to the sole and proper use benefit and behoof of the said Congregation for ever - Which said Indenture contains also two several Covenants for peaceable and quiet possession by the said Congregation and for such further conveyance or assurance thereof to the said Trustees for the use

of the said Congregation as by them or  
their Successors or their Counsel shall be  
reasonably devised or advised, and required  
and is witnessed as to the Execution thereof  
by Donald McDonald — and Alexander Mc  
Donnell 93 Smith & Alexander McDonald of Charlottsburgh aforesaid,  
Gentlemen and is hereby required to be registered  
by Me Allan McDonald the Grantor  
therein mentioned. —
