He described the man to me of whom he bought it, but I knew no such person. The name of "W. Joist" was written on five pieces. He said he had bought rags and bones of him before, but not any lead. He told me he had made the man write his name on it, and added that he lived between Dorking and Guildford. I told him to let the lead remain till I had seen Mr. Bisshopp. He said that he expected to see him again before the week was out. I have not made enquiries respecting any man between Dorking and Guildford. I went the next morning to Mr. Bisshopp's house, and saw Mr. Cecil Bisshopp cut off some lead from the roll which was lying there. I afterwards went with Mr. Cecil tell Riegate, and we took the strip so cut off with us, and on comparing it with that at Mr. Wickham's, they corresponded. I have cautioned the prisoner as to what he did huy.

I said he ought to be more careful, after my baving cautioned him before about buying metal, which I bad done last November. He gave me a description of the man of whom he hought it. He said, he told his wife that should any constable come to make any inquiries about the lead, she was to deliver it to them immediately. There is a blacksmith at Crawley named Sayers, who had drawn, the prisoner said, his attention to the lead lying outside before, but he little thought then he should get into trouble about it. Sayers' shop is about the length of the Court from Bisshopp's. I know Crawley well, and there is no other shop of that kind there.
