

- Stanley c. 1670–1674.** Stephen; s. of Sir Thomas S. Knt.; b. in co. Tipperary; adm. fellow commoner at Trinity College Dublin 5 June 1674 aged 16; M.P. for co. Waterford 1717. *Alumni Dublinenses.*
- Stanley c. 1560–1566.** Thomas; K.S.; contributor to verses addressed to Queen Elizabeth in 1560 and probably under the name of Standleye to those of 1563. *Etoniana* i. 148; ii. 35, 36, 37; *Audit Book* 1559–60.
- Stannier 1670–1675.** Francis; s. of John Stanier of Uppington co. Salop and Rachel; b. at Uppington 14 June 1657 and bapt. at Ercall 2 July; K.S. 1670; matric. from Christ Church Oxford 12 Nov. 1675 aged 18; B.A. 1679; M.A. 1682. A Francis Stanier was buried at St. Paul's Covent Garden 27 Nov. 1698. "F. Stanye[r]" is cut on a pillar of Lower School. *Eton Collegers*; *Foster.*
- Stanton 1578 (1)–1580 (2).** Commensal at the 3rd table. Perhaps Brian matric. sizar from St. John's College Cambridge Mich. 1580; B.A. 1583/4. *Eton Commensals.*
- Stanton 1613 (1)–1615.** Edmund; 3rd s. of Sir Francis S. of Birchmore in Woburn co. Bedford and Elizabeth dau. of Edmund Staunton; b. 20 Oct. 1600; commensal at the 3rd table for two terms, then doubtless K.S.; matric. from Wadham College Oxford 9 June 1615; scholar of Corpus Christi College 4 Oct. 1615; fellow 1616/17; B.A. 1619/20; M.A. 1623; B.D. and D.D. 1634; incorporated at Cambridge 1624; adm. at Gray's Inn 8 Aug. 1620; rector of Bushey co. Herts 19 Apr. 1627–31; vicar of Kingston co. Surrey 1631; member of the Westminster Assembly 1642; president of Corpus Christi College Oxford 1648–60; ejected in 1660; preached at Rickmansworth, Chalfont St. Giles, St. Albans and other places in Herts till silenced in 1662; mar. 1st — dau. of — Scudamore of Watford co. Herts; 2ndly Mary dau. of Richard Balthrop; d. at Bovington co. - Staunton 1639–1645.** Edward; s. of Edward S. of Woburn co. Bedford and Susan dau. of — Roan; b. at Woburn and bapt. there 5 Nov. 1625; K.S.; adm. scholar of King's College Cambridge 1645 aged 19; matric. 1645; B.A. 1648/9; M.A. 1652; fellow of King's 1648–52; rector of Kingston co. Cambridge 1652–74; mar. Elizabeth dau. of —; d. 23 July 1673; will Consistory Court Ely 1674. *Harwood*; *Venn.*
- Staunton 1682–1687.** William; s. of the last and Elizabeth; b. at Kingston; K.S. 1682 aged 10; adm. sizar at Trinity College Cambridge 26 July 1687; migrated as scholar to Trinity Hall; matric. 1687; B.A. 1692/3; M.A. 1696; probably ordained priest (Peterborough) 10 June 1693; master of Moulton Free School co. Lincoln 1709; mar. Elizabeth —; d. 3 Apr. 1711; bur. 5 Apr. at Moulton Church; M.I.; admon. Linc. Consist. Court 9 Apr. 1711. *Eton Collegers*; *Venn*; *Nichols Lit. Hist.* vi. 73; *ex inf. G. S. Dixon Esq. The Hall Holton-le-Moor Lincoln.*
- Stapers mar. 1590 (4)–1591 (3).** Commensal at the 3rd table.
- Stapers ma. 1591 (2).** Commensal at the 3rd table.
- Stapers mi. 1591 (2)–1592 (1).** Commensal at the 3rd table. These three may be sons or more probably grandsons of Richard S. of the Clothworkers Co., alderman of London 1594, a Turkey and East India merchant. One of them is probably Richard adm. pensioner at Peterhouse Cambridge 1595/6; probably adm. at Gray's Inn 10 May 1600. *Eton Commensals*; *Venn*; *Harl. - Staples 1686–1695.** Edmund; probably s. of Alexander S. of Hanwell co. Middlesex; b. at Maidenhead co. Berks; K.S. 1686 aged 10; adm. scholar of King's College Cambridge 28 Feb. 1694/5; matric. 1695; B.A. 1698/9; M.A. 1702; fellow 1698–1709; ordained deacon (Ely) 24 Sep. 1704, priest 9 Mar. 1706/7; chaplain to Admiral Sir George Rooke; rector of Shottesbrooke co. Berks 1708–22; of Ickenham co. Middlesex 1714–22; d. 1722 aged 48. "E. Staples" is cut on two pillars in Lower School. *Eton Collegers*; *Harwood*; *Venn*; *MS. note of Provost Austen Leigh of King's.*
