*The Chapter met for the third meeting of 2012 at Tom's Pizza and Steak House in Paris on Sept. 8 at 11:00 a.m. Chaplain Janice Webb gave the devotional followed by our patriotic ritual.

*Mary Ann Claxton gave the National Defense message - a warning that we cannot assume that everything we read is fact. When Presiden't Obama signed an executive order titled "National Defense Resources Preparedness," presidential detractors said it set the President up with complete control over the economy. In reality, however, it basically duplicated executive orders signed by Presidents since the Korean War. So the order which appeared, on the surface, to be a "coup" is actually what would be expected of the President in the event of a national emergency.

*This was followed by reading of the minutes of the last meeting by Secretary Berdie Maie Foy and the Treasurer's report by Treasurer Beverly Wood, both of which were accepted by the membership as correct.

*The first item of new business was passing of a motion that the Chapter pay the \$5.00 fee for pictures sent in to the Colonial Courier.

official and the government was
based on English law which in turn



was based on Roman law. So our TN government - which was patterned after the VA form - also goes back to Roman law.

STATE SUMMER BOARD MEETING

*Summer Board business included details about the State
Regent's Project which is to fund at least 3 scholarships - one
each year of her term in the TN grand division in which the state
meeting is held for that year. Applications for the scholarships
are available from chapter regents.

*Also included in business was approval of the audit committee's report, and awards to Capt. Thomas Jameson and Middle Plantation Chapters for donations to the State Regent's Project. Regent Harmon announced a contest to name the new state newsletter (one word title suggested). To enter, submit your suggestion for the name of the state newsletter to Regent Harmon or State Historian Lynda Williams by the end of February, 2013; winning name will be announced at the State Assembly in March,

*Another State Regent's project announced by Regent Harmon is collecting ancestor stories for compilation into a state book which would be available for members to have for a small donation. Please send stories to Corresponding Secretary Mary Ann Claxton. We are requesting that members send a copy of the story (or stories) that they sent to the National Historian's Project over the last 3 years as well as any other stories they have on their ancestors - these new stories do not have to be on colonial ancestors but may be other family stories as well. [Note: Mary Ann already has the Col. Gideon Macon Chapter stories that were turned in for the National Historian's Project; Chapter members need only send new stories.] Deadline for submission for stories for the first volume is December 31, 2012 so that the books can be ready by State Assembly in March. A second and, hopefully, a third volume would be created with stories sent in after this year.

Joint effort of Col. Gideon Macon Chapter TN State Society Daughters of the American Colonists and Capt. Charles Barham Chapter Colonial


