Elizabeth Vermilya, (UNKNOWN) born 1740-1744 possibly in New York as her will noted she wished her wearing apparel and the monies received from selling her goods and stock be sent to her heirs (brother and sister's children, not named) in New York. She died June 11, 1809 at Philadelphia, Pennsylvania, buried first in Range C South, No. 5 of the Second Presbyterian burial ground later removed to Mount Vernon Cemetery when the churchyard was vacated in 1867. She is located on the 1800 Federal Census, Philadelphia, Pennsylvania as head of household with a male of the same age range and young people not identified however it is suggested she is unmarried in following records. Older, unmarried woman ("spinster"), possibly from New York, who had lived in Philadelphia since 1789 or earlier. Died of "suffative catarrh" (apparently this can have several underlying causes, including congestive heart failure, severe bronchitis, etc.). Age estimated at 65 to 69 years, birth year between 1740 and 1744, also estimated.

Note: Surname spelled Vermilia on church documents and death certificate, but Vermilya in estate papers.

Had created a nuncupative will (oral will given on the death bed to two or more witnesses, who then write down the testator's instructions) asking that all of her estate be sold except her wearing apparel, which she wanted shipped to her heirs in New York. Also wanted the cash resulting from liquidating her estate to be dividing evenly between her brother's and sister's children (none specifically named). Judging from the appraisal, most of her possessions were old and worth little, but she had more than \$500 in stock that she instructed to be sold. Estate administered by her attorney.


