Dear 1812ers,

A Happy New Year to all of you! I look forward to seeing our state society grow and complete many worthwhile projects in 2007.

With the help of Charlotte Kennedy, I am trying something new with the state newsletter. It's time for the annual reports!

The annual reporting period is from January 1, 2006 to December 31, 2006.

Chapter Presidents are to send a written report to the State President by February 1, 2007.

Chapter Chairmen of National Committees are also to send reports to the State Chairman by February 1, 2007. (State Chairmen are listed at the end of this newsletter.)

State Chairmen are to send their reports to the Chairman National by March 1, 2007. At the 2006 State Council, we decided to change our annual meeting time from the month of August to a date in late spring or early summer. As the hospitality committee considered possible meeting dates, there were conflicting meetings with other societies throughout May and part of June. Finally, June 9th appeared to be the best time to set the date. I called in September to reserve the meeting room at the Bar 14 Restaurant for June 9th but in December they phoned me that we could not have that date. After a panic attack, I began searching the Ellensburg/Cle Elum area for other meeting rooms. I discovered that many of the prices for meeting rooms were too high for our small group or that the group was too small to qualify to meet in some of the restaurant's banquet rooms. Eastbound on I-90 – Just 90 minutes from Seattle. Take Exit 84 (Cle Elum and South Cle Elum). Watch for the turn-off to South Cle Elum on your right. Continue ahead, under I-90 overpass and over the Yakima River.

Westbound on I-90 - Take Exit 84 (South Cle Elum) and turn right on Oakes Street. Go to First Street West, turn left. Watch for the turn-off to South Cle Elum, on your left. This will take you under the I-90 overpass and over the Yakima River.

Continuing from either direction – Turn right on Madison Street. Go two blocks, turn left on Sixth. The IRON HORSE INN is down about four blocks on your right, at 526 Marie Avenue.

(The main restroom is on the second floor but anyone who cannot climb the stairs can use the family bathroom on the main floor.)

Send your \$5 registration fee to the State Treasurer by May 31st. The State Treasurer is June Smith, 213 Apple Street, Bremerton, WA 98310-2078. Please call her before the meeting if you know that extra members or guests will be coming. Last minute guests should plan to pay the registration fee at the time of the meeting.
